

re: Affiliation.

The motivation behind this circular is the realisation that a number of our branches and/or centres have acquired the minimum number of members required to constitute a branch, but have not yet applied for affiliation. As soon as a centre has twenty-five (25) members registered with the Branch, the onus rests on it to apply immediately for affiliation to the National Office. This is a formality which has been over-looked by a number of our branches - for no records of applications exist at the Head Office.

I hasten to call upon branches to apply forthwith for affiliation and to submit their membership strength as well. In order to facilitate the latter I shall enclose herewith the membership assessment forms which have to be filled in and submitted on or before the 10th of July, 1974. May I just say that it would be administratively convenient to submit the forms in their entirety and not the detached stubs as stipulated on the forms. This type of submission facilitates filing at the Head Office. I further appeal to the Branch vice-Chairmen and the Organisers to take upon themselves as an obligation in rounding up all the members.

Some branches were given the forms in March at the First National Council meeting but have not yet submitted them. In such cases membership forms shall not be included until we hear from the Branch concerned of new members. The importance of these membership assessment forms can never be over-emphasised in view of our target of a million membership within three years-and this seems to be our second year. This presupposes that Branches are intensifying their drive to recruit more members into the Movement. Another illusory phenomenon is the apparent complacency and stagnation - in as far as the membership drive is concerned-in Branches attaining branch status. We wish to stress this here and now that it is not the end-point but should be viewed as an incentive for amassing more members. In six to eight...

In six to eight weeks' time, the National Offices shall be sending out progressive reports of branches with regards to the membership drive since the last Congress. This will enable you to assess your commitment in the struggle whether it has been taken involvement or not. It should not be interpreted as though our Struggle is concerned with numbers for the magnitude of our Struggle can never be measured in terms of numbers but in involvement and commitment. May you be informed that the Minutes of the 1st National Annual Congress are ready but I wish to say that these shall only be sent to those branches that have received receipt of this circular. Our stumbling block with regards to communication between us and Branches has been the lack of acknowledgement by the branches. I shall be sending them out before the end of the month.

Forward Comrades, let us realize our aims and objectives of making the world a worthwhile place to live in.

BLACK PEOPLE'S CONVENTION, NATIONAL EXECUTIVE MEETING HELD IN DURBAN ON THE 20TH SEPTEMBER, 1972.

MINUTES

The meeting opened at 10.30 a.m.

Present. R.V. Mayetula, M.M. Shezil, E. Zola, N. Dlamini, S. Cooper.

1. Minutes of the previous meeting were read, passed and accepted.
2. Matters Arising from Minutes.

(a) Banking Account

The Secretary reported that bank officials wanted at least two people for the opening of the account. The Secretary and Vice-President were requested to attend to the matter as soon as possible. It was agreed that between the 8th - 10th October, 1972 when the P.R.O. is in Johannesburg, the matter should be attended to.

(b) Registration of B.P.C.

It was reported that this matter was not yet attended to. It was agreed that the question of registration should be looked into at the same time with the Banking Account i.e. when the P.R.O. is in Johannesburg.'

Offices (Dr. Chetty's)

The Secretary reported that the said offices are still under construction. They are situated in Lenasia. The Committee's findings were that the offices would not be suitable. They would not be easily accessible as they would be out of town. The Secretary further reported that he had a discussion with Dr. Chetty regarding his promise donation. Dr. Chetty gave R23.00. He said that further donations should be discussed and some agreement reached before he can continue. The Committee suggested and agreed that:

- (i) The possibility of getting four Offices (Board room and three (3) offices) at Pharmacy House from Christian Institute should be investigated. These offices would be accepted by B.P.C. on condition that a monthly rental is paid. The B.P.C. would not accept donation (rent free) from the C.I.
- (ii) The Secretary was requested to meet the C.I. about the said offices. And, it was agreed that Dr. Chetty should be approached by the Committee regarding his office costs (as per Maritzburg Financial and Legal Commission report).

(d) Black Press

It was reported that the South African Students Organisation SASO would be holding the Black Press Conference in Johannesburg from 9th - 10th October, 1972. It was recommended that members of the Executive in Johannesburg should attend. The P.R.O. reported that he would be going up for the Conference.

(e) Mr. Moerane re: Conference Money for B.P.C.

The Secretary reported that he investigated the matter with the donors. His findings were that the donors had given R500.00 to Mr. Moerane for the N.O.C. conference at Donaldson in December ,1971. He reported that Mr. Moerane said that all the money was spent on the preparations and running of the Conference. There was no balance. It was agreed that the matter should be discontinued.

(f) Daystar Publications

The Secretary was instructed to ignore the matter as nobody knew who these people are.

3. REPORTS

(a) President

The President reported that he was invited by SASO Executive Office (Black Theology Project Branch) to attend the Conference at Maphumulo. The theme of the Conference was "Relevant Theology for Africans". SASO had sent their director of Theology and Mr. Sagues. They were rejected and refused entrance into the Conference. They called upon B.P.C. President who testified who they were. They were then accepted. When Dr. Manase Buthelezi left the Conference in protest, Mr. Steve Biko and four (4) others wanted to leave in support of Dr. M. Buthelezi. The Conference recommended that when discussing Black Theology, Whites should leave. The B.P.C. President delivered a paper on "Independent Churches" at this Conference.

Further, the President reported that Mr. D. Tenqua (from Transkei) and Rev. Ramothata (from 4748 Zone 4 Diepkloof) were prepared to start B.P.C. branches at their respective places.

The President finally reported that he received a letter from his wife reporting that some people in Sonosene are worried that they did not hear anything from B.P.C. and the Conference. He still recommended that Mr. Walaza should still be visited as he was on our side.

(b) Vice-President.

The Vice-president reported that:

- (i) A branch was established in Tzimba. The branch was to elect a Committee on 1/10/72
- (ii) He did Susto for a week. He was helped by some Students. He hoped to launch a branch there soon.
- (iii) In Pretoria he was helped by "PRESO" people to launch a branch.
- (iv) He sent 10 copies of the Constitution to Springs.
- (v) Kroonstad people asked for Constitutions.

- (vi) He helped has a helpful contact in Cradock.
- (vii) People in King William's Town and Port Elizabeth were conscientised. He found them tripped by fear because of past political experiences. Mr. Steve Biko was to make a follow up.
- (viii) Umtata and Kokstad were not yet done.
- (ix) In Zululand two priests Rev. Diamini of the Anglican Church and Rev Mjoli (r.c) were prepared to offer their pulpits for the B.P.C. message. They had promised to invite one of the B.P.C. officials. It was recommended that the President should do the job.
- (x) He couldn't proceed to Mahlabatheni; he had some people to do the job.
- (xi) The fund-raising letter was sent out.
- (xii) On Conference preparation he reported that he received a reply from Hammanskraal. The letter was read. It was recommended that a letter plus R30.00 registration fee should be sent.
- B.B.** It was reported that the Hammanskraal officials requested that Press Statements issued by the B.P.C. regarding the Conference at their place should first be shown to them. They must be sent a copy.
- (xiii) Mr. Langa was asked to help with organisation of branches at KwaMashu and Umiasiz.

The Committee recommended that the least of people who volunteered to found branches should be given to the Organiser (Mr. Shezi). The Organiser should write a comprehensive letter to these people and send them the constitution.

3. Secretary

N.B. The Secretary recommended that Executive Committee members should not be refunded travelling expenses. It was agreed that 50% of pending claims should be repaid. It was also agreed that it be put on record that the Secretary said that he would not ask for refund of his travelling expenses to Durban on 30/9/72. The P.R.O. requested that he be paid part of his original claim. These were the expenses towards the printing of the B.P.C. membership cards and receipts books. He sacrificed his personal expenses to the cause of the B.P.C. Other members followed suite. It was agreed that no travelling expenses will be paid to the executive members until such times when the B.P.C. has enough funds.

4. ORGANISATION

Reported that he was still organising. He had not yet succeeded in forming branches.

5. PUBLIC RELATIONS OFFICER

The P.R.O. reported on the role of the B.P.C. in the Chatsworth Township bus strike. The Report stated that:

- (a) Bus Service to Chatsworth was (officially) to stop as from 1st October, 1972.
- (b) People in Chatsworth organized a mass protest ~~meeting~~ meeting. About 10,000 people had gathered on Sunday 22nd September, 1972.
- (c) The B.P.C. had consulted with local organiser of the protest to allow one of our men to speak at the mass meeting - reason being that the B.P.C. had cancelled its meeting called for the Sunday on the same project. This request was refused.
- (d) B.P.C. issued and distributed 10,000 leaflets in the township and at the meeting.
- (e) The crowd refused to allow the meeting to continue before "stooges" were removed from the platform. The crowd refused Mr. A. Grobbelaar and Miss Bolton to speak. They demanded that they be sent away or else the meeting would be closed down. Only ~~one~~ man spoke. The protest was a success. Further protest meetings were to be planned.

On review of the situation it was recommended that where possible supporting mass meeting should be organised in Johannesburg (Imosa) and other places. This could be discussed with the Labour Youth Organisation. The importance of this protest was that about 3,000 workers would lose their employment if the bus service to Chatsworth is withdrawn. The people of Chatsworth would also have to bear extra costs on train fares.

The committee agreed that the P.R.O. seek legal advice on "POST" article that openly blamed the B.P.C. for disrupting the Chatsworth protest meeting. Damages would be sought against Post Newspapers. The Committee approved of further meetings in Chatsworth. It was stressed that pamphlets issued should bear the footnote: "Issued by B.P.C. local branch".

On Minutes of Pietermaritzburg Conference:

The Committee recommend that this should be studied and the Commissions recommendations should be implemented. The meeting closed at 2.45 p.m. Next Meeting: 28th/10/72 Venue: Naphamulo Seminar. Time: 10.00 a.m. N.B. The meeting recommended that invitations to the Conference at Kromskraal should be sent out as soon as possible. Invitations should be send out to branches asking them to send delegates. Agenda for the Conference to be prepared at next E.C.M.

BLACK PEOPLES' CONVENTION

MINUTES OF EXECUTIVE MEETING HELD IN THE SASO OFFICE ON SATURDAY 5th AUGUST, 1972.

The Meeting opened at 12.45 p.m.

In the Chair Rev. Mayathula.

Mr. S. Cooper.

Mr. M. Shezi.

Mr. H. Mengwekhulu -- Observer.

Apologies:

A written apology was received from Mr. D. Koka (Secretary-General) who could not attend the meeting because of a "family tragedy".

No apology was received from Mr. Blamini and it was assumed that he was probably not aware of the meeting.

Quorum:

It was noted that the quorum is not mentioned in the Constitution and the meeting was, therefore, declared quorate.

Mr. Shezi was officially asked to take the minutes in the absence of the Secretary-General.

Why the meeting was not held on the 29th July, 1972.

The Chairman explained that there was an AICA Conference he had to attend as the leader of the Youth League on the said date. He told Mr. Shezi about his plight after seeing Mr. Koka who said that the BPC meeting could be postponed. Mr. Shezi was against the postponement. Rev. Mayathula and Mr. Shezi decided to meet with or without Mr. Koka on the evening of Thursday the 27th July, 1972 and finalise this. However Shezi and Koka never turned up. Mr. Shezi's explanation was that Mr. Koka phoned on the morning of the Thursday in question saying that Mr. Mayathula was decidedly attending the AICA conference and this was seen by Mr. Shezi as the cancellation of the appointment with Rev. Mayathula.

Letter from Mr. Koka:

The letter was read from the chair and comments were invited. The apology for this meeting was rejected and Mr. Koka was unanimously censured for his absence and for his conduct of cancelling the meeting which was scheduled for the 29th July, 1972.

Agenda:

The agenda was drawn up and agreed on as follows:

1. Minutes and matters arising.
2. Implementation of resolutions.
3. Branches.
4. Finances.
5. Office.
6. General.

Minutes and matters arising:

The meeting felt that the minutes were wanting in many respects. The mover and seconder of motions were to be included; the voting power (where applicable) was also to be reflected. There was also a comment on the typed motions; that they were not like the original. It was also the feeling of the meeting that the accepted reports should have been part of the minutes. It was on these grounds that the minutes were turned totally inadequate and rejected. It was said that more comprehensive minutes should be prepared and reports which were missing were also to be located and included in the minutes. Of the missing reports the report on Urban and Rural Politics was noted as one.

2./.....Branches.

Branches:

Mass rallies were said not to be our priority or necessarily a must. We still need to establish the core of the BPC through branches which in terms of the constitution should have a minimum of 25 persons each. Mass rallies could then come after the National Convention in December, and these can be effected through the Presidential tour.

Concerning the mass rally to be held on the 13th August, 1972 as proposed by Mr. Koka was to continue but only if it was to be well advertised and should be cancelled if the time factor militates against it. Mr. Sheri was asked to attend and assist Mr. Koka if the said rally materializes.

Finances:

Under this stationery was discussed and it was agreed that receipt books were needed. The PRO was to get in touch with the printers. The need for documents for formal way of accepting money were also to be looked into. The PRO was also to secure a rubber stamp and he (Mr. Cooper) also reported that the letter head design was on the way.

The tele graphic address was to be applied for and the following suggestions were accepted:

1. Convention
2. Blackan *B.I.R.K. even*
3. Solidarity.

Membership form/card:

The membership forms were discussed and amendments were proposed and made. Mr. A. Mokoape came in at 1.20 p.m. per invitation of the meeting to discuss the proposed amendments:

Introduce: 2 "I shall always believe in the equality of all men." (Delete Original)

Delete "3" completely.

Reconstruction "8": "I shall take pride in Black creativity."

Reconstruction of "10": "Finally I shall undertake to shoulder my task of making the world a worthwhile place to live in."

Emblem of the BPC:

The BPC emblem was discussed and was left to the PRO to look into. This emblem is to be included in the membership form/card.

Funds discussed:

Fund raising was seen as very important and it was agreed that Mr. Sheri acting as National Organiser as per agreement with Mr. Bramini, should prepare ~~for the next meeting~~ for the next meeting. He was also asked to look into preparing papers for projects. The problem of paying the office staff was also discussed. It was, however, difficult to assess how much we have as the financial statement was not tabled and this was to be requested from the Secretary-General in the next meeting.

Office:

It was agreed that we may continue sharing the office with "Allied Workers". It, was, however, agreed that we should first get all particulars about the said office before it was sanctioned. A question was asked about the office (at Dr. Chetty's) which was hinted at the last meeting, but no one could answer this as the Secretary-General was not in.

General:

Pamphleteering as a means of publicity was accepted and the PRO was to write the pamphlets.

The PRO is also to look into the buying of shares in certain business concerns. He is also to continue investigations on the formation of a paper (newspaper) and give progress report to the next meeting.

Creation of slogans for the publicity of BPC was to fall under pamphleteering.

Conference Centre:

We cannot have a mass rally on 16th December, 1972.
The application for the amphitheatre are therefore, to be cancelled
and the Executive is to agree on a venue for the Conference of December, 16th.

Mr. Shni was given the duty of finding a venue for the 16th - 18th Dec., 1972.
Suggestions were made and St. Ansgars P.O. Box 81, Roodepoort was agreed on.

National Tour:

This was to begin with Presidential Tour after the constitutional elections of the Executive in December.

Two or three members of the Executive were also to members of major centres. The duty of working out the itinerary was left on the hands of the PRO (Mr. Cooper) and this was to be presented at the next meeting.

There being nothing more to discuss the meeting was declared closed at 2.30 p.m.

Next meeting to be held on the 26/8/72 in the SASO office in Jhb.
