PROPOSED URBAN BANTU COUNCIL.

### (a) Establishment.

On the 25th October 1964 (Minutes page 2410) the Council resolved that the Minister of Bantu Administration and Development be requested to agree in principle to the establishment by the Council of one Urban Bantu Council for all the Bantu Townships and Hostels under the jurisdiction of the Council.

On the 14th April 1965 the Minister approved in principle the establishment of such a Bantu Council provided the voters' roll was compiled on an ethnic basis.

At a meeting of the Non-European Affairs Committee with the Joint Bantu Advisory Boards on the 24th November 1965, the Boards expressed the view that the Bantu Council should be established on a geographical and not an ethnic basis, as Advisory Board representation had been on this basis for many years.

Discussions on several occasions between officials of the Council and the Department of Bantu Administration and Development sought to resolve disagreement on the question of geographical or ethnic representation and in August 1966 the Minister decided that the Urban Bantu Council for Johannesburg should be established on a national unit basis, i.e. ethnic. This aspect has been discussed informally with senior members of the Joint Boards and the indications are that Boards may now accept the national unit idea. The draft regulations, which will, if adopted and promulgated, establish the principle of national units will, of course, be referred to all Boards formally for consideration in terms of the Bantu (Urban Areas) Consolidation Act, 1945. These are based on a model prepared by the Department of Bantu Administration and Development and deal with the election and re-election of members of the Urban Bantu Council and ancillary matters. Copies of these will be tabled as it has not been possible to prepare them in time because of the difficulties involved in recasting the model regulations to fit the Johannesburg circumstances.

There are ten Advisory Boards under the Council's jurisdiction. one at Eastern Bantu Township and the other nine in Soweto.

For administrative purposes Soweto is divided into superintendencies of between 2/3,000 residential sites. If this overall division can be maintained, commensurate with ethnic grouping, (shown on the plan laid on the table) it could represent the Bantu Council ward boundaries, depending on the geographical layout

of the area. This would enable Bantu Council representatives to understand more clearly their administrative divisions and would afford a close link between the Council's administration and the people. In addition to the "Family Representation", the hostels should also have representation on the Bantu Council.

Section 3 of the Urban Bantu Council, Act, 1961 provides that an Urban Bantu Council shall consist of so many elected and selected Bantu, in all not being less than 6, as the urban local authority may determine; provided that the number of selected members shall not exceed the number of elected members.

In terms of the Government's model regulations there could be one selected member for each of the eight national units referred to in Section 2 c the Promotion of Bantu Self-Government Act, 1959, viz:

- (a) The North-Sotho unit;
- (b) the South-Sotho unit:
- (c) the Swazi unit;

- (d) the Tsonga
  (e) the Tswana unit;
  Venda unit; (f) the Venda unit;(g) the Xhosa unit;
- (h) the Zulu unit.

The draft regulations provide the machinery for the appointment of selected members which is similar to an electoral college of chief's representatives. The Manager, Non-European Affairs Department, is normally consulted before Johannesburg's urban representatives are appointed and the Bantu Affairs Commissioner has intimated verbally that this policy will continue.

### (b) Ward Boundaries.

The Council's Bantu residential areas, including hostels, are shown on the plan laid on the table and are divided into 10 wards -9 in Soweto and 1 for Eastern Bantu Township and the urban hostels. This division, with national unit voters' rolls for each ward, complies with the Minister's directive. With a proportionate representation based on one Councillor for approximately 2,000 voters, the total elected members would be 41. On the basis of the number of the various national unit voters the selected members would be 17, constituting a total Council of 58. The existing Advisory Boards consist of 40 elected and 20 nominated members, a total of 60 members.

The schedule attached to this report, marked Annexure 'A', gives details of the proposed wards; the number of persons (heads of families or hostel residents) of each national unit entitled to vote in each ward the total number of persons of each national unit in the whole area, and the number of elected and selected members for each national unit. From this it will be observed that for the minority groups in certain areas Councillors vill have to represent people in their ethnic group who live in more than one ward.

To obviate the duplication of votes as well as to facilitate voting, it is proposed to divide some wards into polling districts with persons registered in each district having to vote at polling stations established at the offices of the Superintendents concerned A Returning Officer will have to be appointed for the whole of Soweto, Easter Bantu Township and the urban hostels,

### (c) Powers. Duties and Functions.

Section 4(1) of the Urban Bantu Councils Act, 1961 provides that a Bantu Council shall exercise the powers and perform the functions and duties of existing Advisory Boards which are as follows:

"..... consider and report upon -

- (i) any reculation which the urban local authority proposes to make ....
- (ii) any matter referred to it by the urban local authority or ... by the Minister.
- (iii) any matter specially affecting the interest of Bantu in the urban area, upon which the Board
   ... may consider it useful or desirable to report.

may also recommend .... the making or adoption of any regulation which it considers necessary or desirable in the interest of the Bantu in the urban area.

The appropriation of monies from the Bantu Revenue Account shall not take place otherwise in accordance with estimates of expenditure ..., provided that before such estimates are passed .... they shall ..., be referred to its Bantu Advisory Board or Boards "

Section 4 (2) of the Act provides that an Urban Bantu Council shall also:-

- "(a) in respect of the area for which it has been established, exercise such powers and perform such functions and duties of an urban local authority in respect of one or more of the following matters in connection with Bantu as the urban local authority may after consultation with the Administrator assign to such Council, with the concurrence of and subject to such conditions as may be determined by the Minister:-
  - (i) the layout of the area;
  - (ii) the accommodation of Bantu not living under conditions of family life;
  - (iii) the removal of persons unlawfully resident in the area;
  - (iv) the unlawful occupation of land and buildings;
    - (v) the management and control of the area (including the determination of the order of priority to be observed in the allocation of residential facilities) and the maintenance of good order therein;
  - (vi) the erection and use of dwellings, buildings and other structures, and the removal or destruction of unauthorized or abandoned buildings or structures;
  - (vii) the allotment of sites for church or school purposes;
  - (viii) the prohibition, regulation or restriction of the keeping of animals, and the grazing on any commonage of stock belonging to persons living in the area;
    - (ix) the prohibition or the regulation of entry into or sojurn in the area;
    - (x) the provision of sanitary, health and medical services;
    - (xi) the moral and social welfare of persons living in the area."

### NON-EUROPEAN AFFAIRS DEPARTMENT.

It is proposed that, initially, the Bantu Council exercise only the powers, duties and functions presently assigned to the Advisory Boards and that further functions be conferred on the Urban Bantu Council, later in terms of Section 4(b) of the Urban Bantu Councils Act, when it can be determined in the light of experience what functions can be carried out conveniently and effectively.

### (d) <u>Allowance</u>,

Regulation 28(1) of the proposed regulations provides for payment of allowances, as determined by the local authority, to members of the Bantu Council. The following monthly allowances should be paid;

### (e) <u>Secretariat</u>.

A secretariat will be necessary, provision for which will be included in the 1967/68 Estimates. A report on the establishment will be submitted in due course.

### (f) Financial Implications.

Total annual expenditure, apart from capital redemption and interest charges on the Urban Bantu Council Chamber now being built at the Jabulani Civic Centre at a cost of R194,000, should not exceed R35,000; but there could be initial further expenditure on furniture and Councillor's gowns amounting to R6,500-00.

However, the present annual expenditure of R11,000 in respect of Advisory Boards will fall away.

Senior officials of the Department of Bantu Administration and Development have signified their support of these proposals.

### IT IS RECOMMENDED:

(a) That an Urban Bantu Council be established for Johannesburg on the basis outlined in this section of the report. MANAGEMENT COMMITTEE. (4.7.67) NON-EUROPEAN AFFAIRS COMMITTEE. (29.6.67)

(b) That the draft regulations to be tabled be adopted and be referred to all the Bantu Advisory Boards for consideration in terms of Section 21(3) of the Bantu (Urban Areas) Consolidation Act, 1945, as amended, and the Boards be asked to submit their reports on the regulations within 30 days.

(c) That the Manager report on the staff positions required for the Urban Bantu Council to operate efficiently and be authorized to make all other arrangements for the first election, establishment and operation of the Urban Bantu Council.

(In terms of Section 38(3) of the Bantu (Urban Areas) Consolidation Act, 1945, as amended, notice must be given of the Committee's intention to move at the next ordinary or a subsequent meeting of the Council, the adoption of recommendation (b)).

REGULATIONS RELATING TO THE ESTABLISHMENT AND CONSTITUTION OF THE URBAN BANTU COUNCIL OF JOHANNESBURG.

In these regulations, unless the context otherwise indicates, any expression to which a meaning has been assigned in the Bantu (Urban Areas)
 Consolidation Act, 1945 (hereinafter referred to as the principal Act), or the Urban Bantu Councils Act, 1961, bears the meaning so assigned thereto, and -

 "Bantu Affairs Commissioner" means the Bantu Affairs
 Commissioner for the district of Johannesburg.

(ii) "Bantu Council" means the urban Bantu Council established for the urban Bantu residential areas in terms of section <u>two</u> of the Urban Bantu Councils Act, 1961.

(iii) "Manager" means the officer appointed and licensed in terms of sub-section (1) of section <u>twenty-two</u> of the principal Act for the management of the urban local authority's department of Bantu administration and shall include a Deputy and an Assistant to such officer. - 2

(iv) "national units" means the following units referred to in sub-section (1) of section <u>two</u> of the Promotion of Bantu Self-Government Act, 1959 which are:

- (a) the North-Sotho unit;
  (b) the South-Sotho unit;
  (c) the Swazi unit;
  (d) the Tsonga unit;
  (e) the Tswana unit;
- (f) the Venda unit;
- (g) the Xhosa unit; and
- (h) the Zulu unit.

"Registered occupier" means (v) any person to whom a certificate of title, or a residential or a hostel permit has been issued in accordance with the regulations promulgated for the management and control of the urban Bantu residential areas, and who has attained the age of eighteen years, and any person who occupies, with the permission of the Superintendent, any approved dwelling on any church or school or institutional site.

- (vi) "Returning Officer" means the person appointed as such by the urban local authority with the approval of the Minister, or of a State official delegated thereto by the Minister, if the Minister wishes to exercise such control over the said appointment.
- (vii) "Secretary of the Bantu Council" means the Bantu official appointed by the urban local authority in consultation with the Bantu Council for the purpose of undertaking secretarial and clerical duties of the Bantu Council and shall include any person acting in that capacity during the absence of the Secretary.
- (viii) "Superintendent" means any officer, including the authorized assistants of such officer, who may from time to time be appointed by the urban local authority to supervise or control any portion of the urban Bantu residential areas.

:- (ix) ...

- (ix) "urban area" means the urban area of Johannesburg.
  - (x) "urban Bantu residential areas" means the urban Bantu residential areas under the jurisdiction of the urban local authority.
- (xi) "urban local authority" means the City Council of Johannesburg: Provided that the said City Council may delegate any of its functions, duties or powers under these regulations to its Management Committee.
- (xii) "Voter" means a person who is qualified and enrolled in terms of these regulations to vote for elected members of the Bantu Council.

### ESTABLISHMENT AND CONSTITUTION OF BANTU COUNCIL.

2. There shall be and is established for the Bantu belonging to the national units resident in the urban Bantu residential areas an urban Bantu council to be known as the Urban Bantu Council of Johannesburg, hereinafter referred to as the "Bantu Council" and constituted as hereinafter provided.

### MEMBERS OF BANTU COUNCIL.

The Bantu Council shall consist of:

- (i) forty-one elected members
   representing national units
   and apportioned as follows
   for each national unit:
  - (a) four elected by the voters of the North-Sotho national unit;
  - (b) six elected by the voters of the South-Sotho national unit;
  - (c) two elected by the voters of the Swazi national unit;
  - (d) three elected by the voters of the Tsonga national unit;
  - (e) five elected by the voters of the Tswana national unit;
  - (f) two elected by the voters of the Venda national unit;
  - (g) four elected by the voters of the Xhosa national unit;

(h) fifteen elected by the voters of the Zulu national unit;

(ii) seventeen selected members selected from urban representatives whose names appear on the list referred to in regulation 19, and consisting of-

- (a) two representing the North-Sotho national unit;
- (b) two representing the South-Sotho national unit;
- (c) one representing theSwazi national unit;
- (d) one representing the Tsonga national unit;
- (e) two representing the Tswana national unit;
- (f) one representing the Venda national unit;
- (g) two representing the Xhosa
  national unit;
- (h) six representing theZulu national unit.

### WARDS AND POLLING DISTRICTS.

4. (1)

The urban local authority shall -

(a) divide the urban Bantu residential areas into wards and shall assign a number to each ward and may divide any ward into two or more polling districts, assigning a number to each polling district;

(b) determine what ward's or wards' voters of a particular national unit each elected member shall represent: Provided always that more than one elected member, and elected members representing the same or different national units, may be allocated to the same ward.

(2) When acting in terms of sub-regulation (1), the urban local authority may regard the urban Bantu residential areas as one area and need not take the boundaries of any individual area into account in fixing ward boundaries and may further take relevant administrative factors into account including existing administrative

and may effect a division into wards which vary substantially in area and/or in number of voters, and has regard to -

- (i) affording reasonable and practical representation on the Bantu Council to each national unit; and
- (ii) representation and voting related to area of residence and existing administrative divisions; and
- (iii) facilitating voting and rendering an election practicable.

(3) No voter shall be entitled to vote at a polling station other than at the polling station for the ward in which he is registered as a voter, and where a ward has been divided into polling districts, no voter shall be entitled to vote at a polling station other than at the polling station for the polling district in which he is resident.according to the voters' list compiled in terms of regulation 24.

(4) The urban local authority may -

(i) increase or decrease the number of wards;

(ii) alter the boundaries of existing wards: Provided that such alteration shall take effect only at the next ensuing general election.

### DISQUALIFICATION OF ELECTED MEMBERS.

5. No person shall be eligible for election to the Bantu Council who -

(a) is not lawfully resident in the urbanBantu residential areas;

- (b) being a voter is in arr ar with any charge, fees or other dues payable by him to the urban local authority or Bantu Council on the day when nominations close;
- (c) has, within the period of five years immediately preceding the date of his nomination for election, been convicted of any offence in respect of which he has been sentenced to imprisonment without the option of a fine for a period of more than one month, or with the option of a fine for a period of more than six months;

is subject to an order of court declaring him to be of unsound mind or mentally disordered or defective under the Mental Disorders Act, 1916;

(e) holds an office or place of profit
 under or in the gift of the urban local
 authority as an employee;

is prohibited in terms of sub-section
(3) of section two of the Riotous
Assemblies Act, 1956 from attending
gatherings, and whose name appears
under particulars of notices published
in the Gazette in terms of paragraph
(b) of sub-section (3) bis of section

### NOMINATION FOR ELECTION.

6. The Returning Officer shall not later than three months from the date of promulgation of these regulations and thereafter not later than the first day of August of each year in which a general election is to be held, call, in both official languages in a newspaper which generally circulates in the urban area and by means of notices displayed at each Superintendent's office, for the nomination of candidates for the election of members of the Bantu Council for the period laid down by

- 7. (1) The notice referred to in regulation 6 shall specify the place at which and the date and time before which nomination shall be received by the Returning Officer. Such date shall not be earlier than fourteen twenty-one days after, and not later than XXX days after, the date of issue of the notice calling for nominations.
  - (2) Nominations of candidates for election as members of the Bantu Council shall be submitted in writing to the Returning Officer in the form prescribed in Annexure A, which shall be supplied by the Superintendent, and shall be supported by the signatures of not

less than ten persons who are members of the national unit and registered as voters in the ward or wards for which the nomination is made and who are not in arrear to the urban local authority in respect of rent or other charges on the date referred to in sub-regulation (1).

No person in respect of whom a nomination form has been submitted to the Returning Officer in terms of sub-regulation (2) shall be deemed to be duly nominated unless he qualifies to stand for election in terms of these regulations and has deposited with the Returning Officer the sum of R10-00 on or before the date and time referred to in sub-regulation (1).

Should any candidate receive less than one fifth of the number of votes cast for a single opponent or less than one fifth of the number of votes cast for his successful opponent who received the lowest number of votes, he shall forfeit the sum deposited in terms of sub-regulation (3) and the money thus deposited shall be paid to the Bantu Revenue Account; otherwise it shall be returned to the candidate after the result of the poll is known.

The Returning Officer shall as soon as practicable, and not later than fourteen after the date for the receipt of nominations, affix on the notice board at the office of the Superintendent a notice containing a list of the candidates duly nominated in terms of these regulations and shall also declare those candidates who have been returned unopposed to be elected members for their respective national units and wards.

(6) If the number of valid nominations received for a vacancy or a combination of vacancies is less than the number of vacancies the Returning Officer shall immediately after the closing date of the nominations call again for nominations for such vacancies in the manner prescribed in regulation 6 and shall in due course hold a by-election to fill the vacancies.

# PROVISION OF EQUIPMENT AND APPOINTMENT OF OFFICERS.

8. For all elections the Returning Officer shall arrange for compartments, ballot boxes, ballot papers, instruments for marking ballot papers with the official mark and shall appoint such polling officers and assistants and do such other acts and make such arrangements to facilitate the taking of the poll as may be deemed advisable for effectually

conducting the election. The equipment shall be supplied by and all expenditure in this connection shall be to the account of the urban local authority.

### DECLARATION OF SECRECY.

9. The Returning Officer and polling officers and their assistants shall make, before the opening of the poll, a declaration of secrecy under oath, in the case of the Returning Officer before a justice of the peace or commissioner of oaths, and in the case of a polling officer and his assistants before the Returning Officer.

### POLLING DAY.

10. The notice issued under sub-regulation (5) of regulation 7 shall also stipulate the places at which, the date, other than a Sunday, Good Friday, Ascension Day, Christmas Day or the day of the Covenant on which, and the hours during which the polling shall be held. The hours of polling shall be not less than 8 hours between the hours of 8 a.m. and 6 p.m. and shall be fixed by the Returning Officer with due regard to the convenience of the majority of the voters.

11. The voting at all elections held under the provisions of these regulations shall be by secret ballot and shall take place as follows:

The polling officer or his assistants at the polling station in respect of each ward or wards, or polling district, if a ward is divided into polling districts shall ascertain that the person claiming a right to vote is a voter enrolled upon the voters' list for the national unit for that ward or wards or polling district and having ascentained that such person is so enrolled and that his name and identity number appear on such list, shall enter his identity number on the identity card issued to him in terms of the Population Registration Act, 1950 upon the counterfoil in the ballot paper book and shall then tear out the ballot paper

corresponding to such counterfoil and having stamped the same with a secret mark determined by the Returning Officer shall hand it to the voter.

He shall then fold the ballot paper so that the secret stamp may be visible and having held up the ballot paper so that the polling officer or his assistant can recognise the mark shall drop the ballot paper in the ballot box placed in front of the polling officer or his assistant.

# SPOILT BALLOT PAPERS AND RECORD OF BALLOT PAFERS.

12. (1) If a voter inadvertently spoils a ballot paper he may return it to the polling officer or his assistant who if he is satisfied of such inadvertence shall give him another ballot paper and retain the spoilt ballot paper which he shall immediately cancel and endorse with the words "returned under regulation 12" and the fact of such cancellation shall be noted upon the counterfoil.

(2) Such spoilt ballot paper shall be retained by the polling officer who shall as soon as the poll is closed compile a record. of the number of ballot papers issued, the number of spoil ballot papers and the number of ballot papers found in the ballot boxes at the close of the poll.

### RECORDING OF VOTES.

13. The polling officer on the application of any voter shall in the presence of such voter mark the vote of such voter on the ballot paper issued to him in a manner directed by such voter and place the ballot paper in the ballot box in the presence of the voter.

### IDENTIFICATION OF VOTERS.

14. No voter who, on the day of polling, does not produce his reference book or identity card at the polling station to identify himself, shall be permitted to vote.

### POLLING STATION.

15. (1) No person other than the Returning Officer, polling officers and their assistants, candidates and one scrutineer appointed by every candidate and approved by the Returning Officer and the persons recording their votes shall be admitted into the polling station.

(2) The Returning Officer or a polling officer may require any person including a candidate or scrutineer, to leave the polling station and any person who fails to leave the polling station when so required, shall be guilty of an offence, and the Returning Officer or a polling officer may cause such person to be removed forthwith from the polling station.

### RESULT OF ELECTION.

16 (1) As soon after the closing of the poll as practicable and after the record in terms of sub-regulation (2) of regulation 12 has been compiled, the polling officer and his assistants shall count the votes recorded for each candidate and the Returning Officer shall declare the candidates equal in number to the number of vacancies to be filled in the particular ward or wards who have received the greatest number of votes for their respective.ward or wards to be duly elected as members representing the particular national unit for the ward or wards concerned.

17. In the event of the number of votes being found to be equal for two or more candidates all of whom cannot be declared elected, the Returning Officer shall be lot determine the successful candidate or candidates.

### GENERAL ELECTIONS.

18. The first general election of members for a Eantu Council shall take place on a date within three months after the promulgation of these regulations and the members so elected shall hold office, unless a members' seat is vacated earlier, until the 30th day of September of the third calendar year after the calendar year during which the first election was held.

### REGISTER AND LIST OF URBAN REPRESENTATIVES.

19. As soon as the Bantu Commissioner records the information mentioned in regulation 4 of the regulations published under Government Notice No. 231 of 1962 and furnishes such information to the urban local authority and advises the urban local authority whether the Minister has approved of the candidature for selection as a member of the Bantu Council of every urban representative mentioned therein, the urban local authority shall decide whether it approves of the candidature for selection as a member of the Bantu Council of every urban representative concerned and if not, what urban representatives it rejects as candidates. (1) Only persons who were born in the Republic of Bouth Africa or in South West Africa, and who are registered occupiers within the Urban Bantu residential areas and whose names appear on the voters list in terms of regulation 24 shall be qualified to vote at any election of elected members of the Bantu Council.

(2) If it is proved to the satisfaction of the Manager at any time that such voter is subject to any of the disqualifications mentioned in paragraphs (f), (g), (h) and (i) of regulation 5 such voters name shall be removed from the voters' list forthwith.

#### VOTERS' LIST.

(1) Within one month from the date of publication of these regulations the Manager shall compile and maintain a list of persons who are qualified in terms of regulation 23 to vote at any election referred to in that regulation.

(2) In such list shall be reflected the identity number and name and address of the voter and the national unit of which he is a member, as well as the number of any ward in which he is a resident. Where a ward has been divided into polling districts, the number of the polling district in which the voter is resident shall also be shown.

(3) For the purpose of any general election to be held, in terms of these regulations, only those voters who are registered occupiers up to and including the last working day of June of the year in which the election is to be held shall be entitled to vote in that election. Provided that in the case of a first general election only voters who are registered occupiers at the date of publication of these regulations shall be entitled to vote at such election.

(4) For the purpose of any by-election -to be held in terms of these regulations the names of only those voters who are registered occupiers up to and including the day on which a vacancy for an elected member occurs, shall be entitled to vote in that by-election.

(5) Any voters' list compiled in terms of these regulations shall be available for inspection by the public at least one calendar 'month before the general election or by-election is due to take place.

## CHAIRMAN AND DEPUTY CHAIRMAN.

(1) A special meeting of the Bantu Council shall be held within fourteen days after the first general election held in terms of these regulations and annually thereafter during the first fourteen days of the month of October and at every such meeting the members present shall elect one of their number to be Chairman and one member to be deputy chairman who shall forthwith enter upon their offices and continue therein up to the date of the first special meeting held in October of the ensuing year.

(2) In the event of the offices of chairman or deputy chairman being vacated, otherwise than by the expiry of the period for which the incumbent was elected, a successor shall be elected by the members from amongst themselves at the ordinary monthly meeting after the vacancy has occurred.

(3) If both the chairman or deputy chairman for any reason fail to attend a meeting, the members present shall appoint anyone of their number to act as Chairman at that meeting.

## TERM OF OFFICE OF ELECTED MEMBERS.

26. Subject to the provisions of regulations 18, 22 and 27 every elected member of the Bantu Council shall hold office for a period of three years and shall be eligible for re-election.

# CONDITIONS OF SERVICE OF MEMBERS.

27.

(1) No member of the Bantu Council shall in any way be concerned or interested in any bargain contract or arrangement whatsoever, with the exception of the hiring of sites, premises or buildings to which he is a party, made by or with the Bantu Council or urban local authority.

(2) No member shall exact or accept any promises, fee, bribe or reward whatsoever by virtue of his office other than his proper allowances paid to him by the urban local authority.

(3) Any member contravening subregulations (1) or (2) of this regulation
shall be guilty of an offence and he shall

any office under these regulations.

#### ADDITIONAL DUTIES OF SELECTED MEMBERS.

28. A selected member shall, on behalf of the national unit he represents serve the interest of that unit within the urban Bantu residential areas and within the urban area and shall keep the members of the national unit represented by him informed and also advise them regarding matters affecting the general interest of the members of the national unit residing in the urban Bantu residential area and the urban area.

#### PAYMENT OF MEMBERS.

29. (1) Members of the Bantu Council may be paid such allowances as may be determined by the urban local authority.

> (2) The allowances shall be computed on a monthly basis and shall be payable monthly: Provided that a member shall subject to this sub-regulation and sub-regulation (3) forfeit 10% (ten per centum) of such allowance in respect of each meeting of the Bantu Council or of a committee thereof which he does not attend during the month for which the allowance is payable, but shall not forfeit any portion of his allowance if his absence from any meeting is due to any cause which the Manager after consultation with the Bantu Council considers to be reasonable.

(3) The Bantu Council may grant a member not more than thirty days leave of absence from office during any year for which the full allowance payable to such member in terms of sub-regulation (1) shall be payable despite his absence. No allowance shall be payable in respect of leave of absence in excess of the said thirty days.

# CONVENING OF MEETINGS.

30. The Bantu Council shall hold at least one meeting per month on a day and at a time to be decided upon by the Bantu Council in consultation with the Manager.

#### SPECIAL MEETINGS.

31. (1) The Manager upon being satisfied of the necessity of so doing, may call a special meeting of the Bantu Council by giving the members at least 24 hours notice.

> (2) No business shall be transacted at any such meeting except such as the meeting may have been specially convened to consider.

#### NOTICE OF MEETINGS.

32. Save as provided in regulation 31, notice of the time and place of every meeting of the Bantu Council shall be served by the Secretary of the Bantu Council on every member and on the Manager. Such notice shall embody the agenda for that particular meeting, and notice to a member shall be effected either personally or by post at least seventy-two hours before such meeting, and notice to the Manager shall be effected either personally or by leaving the notice at his offices at least 72 hours before such meeting. Lack of proper service of notice of a meeting shall not invalidate any decision taken at any meeting.

#### QUORUM.

33. Any number of members exceeding one half of the total number of elected members and one half of the total number of selected members shall form a quorum of the Bantu Council.

#### CASTING VOTE OF CHAIRMAN.

34. In the event of an equality of votes the chairman shall have a casting vote.

#### COMMITTEES OF THE BANTU COUNCIL.

35. The Bantu Council shall appoint from its membership, so that each member serves on at least one Committee, the following Committees which shall consider and, if necessary make recommendations to the Bantu Council on the matters within their terms of reference as contained in Annexure B:

- (a) Amenities Committee;
- (b) General Purposes and Housing Committee;
- (c) Trading and Transport Committees;
- (d) Educational and Health Committee.

### PENALTIES.

36. Any person convicted of a contravention of regulation 11, 14 or 27 shall be liable to the penalties prescribed in section <u>forty-four</u> of the principal Act.
