Our soldiers who answered the call of King and Country have returned to find the oppression of pass laws being made more oppressive.

The Minister of Native Affairs has decreed "that every Native must carry some sort of paper" That is White South Africa thank you for the voluntary service rendered by the African in defence of South African democracy and civilization.
