

Dear Friend

In January 1987 this organisation was visited by two inspectors acting under the authority of the Director of Fund Raising. They requested details about our funding. All information they requested was provided which included our bank account numbers, our latest audited financial statements, and names of all Board members. We were promised a copy of the report emenating from this investigation. In March 1987 I was visited by a Lieutenant in the Commercial Branch of the South African Police who said he was investigating a charge against this organisation for violating the Fund Raising Act. An affidavit was requested of me. On the request of our Attorney the Director of Fund Raising made available to us a copy of the report prepared by his Inspectors. The Report is a brief document which gives a few details of the inspection and ends with the statement that according to entries from the Cash Book and the Current Account Credit it is Prima Facie clear that the Unit contravened Section 2 of the Fund Raising Act (Act 107 of 1978).

We are not clear what the designs and intentions of the authorities are at this stage but it is apparent that certain organisations are being subjected to scrutiny and harrassment. It would be helpful to obtain and collate information of organisations across the country which have been or are being subjected to investigations.

The Community Research Unit would appreciate your co-operation in completing the enclosed questionnaire which is intended to give a more fuller picture of which organisations are being investigated. The results of this survey will be made available to all participants.

Your co-operation will be appreciated.
