Minutes of the Cape Town ECC General Body, 9 June 1987

Present: Conscriptio Advice Service. Quakers. Black Sash. Koeberg Alert and Board of Social Responsibility.

1) Correspondence:

Letter from ex-ECC member, Rogan.

2) National Committee Report:

a) Campaign: Discussed aims of campaign. One of them was to intervene around the elections. but some regions felt that we confused our constituency. However the campaign did increase our profile. New ways of working were introduced in some regions. Regions felt that NC was the incorrect forum for planning the campaign. which was reflected by our slogan. National co-ordination was problematic and this needs to be reassessed.

b) Finances: Charges are being investigated against ECC under the Fundraising Act.

c) Repression and Smears: Suggested that we go for an interdict preventing Aida Parker from distributing her newsletter. A complaint has been laid with the Media Council regarding her latest newsletter. We could take 'Veterans for Victory' to court but felt it was not worth it.

Other Smears: Cape Town: stickers 'ECC PEACE OFF!'. Durban: ANC pamphlets left in the office. Lots of graffiti around the country.

d) National Co-ordination: Exchange of information between regions should be stepped up. NC is playing a more important role than it should. Felt that it should only make decisions in times of crisis and that a national forum is required. The general body discussed possible representatives and made strong recommendations.

3) Ivan:

Ivan Toms has a call-up for a camp and is going to object to it. While ECC does not form support groups around all objectors, because of Ivans past role in ECC, the executive and NC felt that ECC should take up a campaign around Ivan. Possible reservations about forming a support group would be a crackdown on ECC effecting the campaign. The general body agreed to set up a support group for Ivan.

4) Campaign:

The last couple of campaign events were assessed at the last campaign meeting. The multi-media was felt to be very successful. Paula's speech at the rally was good. The film festival was also successful. A workshop was planned to assess the campaign more fully. There were some problems expressed about the campaign, the lack of focus and nuclear slogan. It was felt that the events strung together in the campaign did not necessarily constitute a campaign. The group felt that the symposium should be postponed. Recruitment needs to be emphasized. It was felt that the co-ordination of the campaign went well.

WHAT IS ALLOWED UNDER THE ACT ?

1. To get money from membership
2. Contributions in terms of a legal obligation i.e. a contract (This must confer the right to claim consideration)
3. It is unclear whether a single successful approach to a donor contravenes the Act, but most legal opinions believe it does not.

4. E C C FUND-RAISING STRATEGY:-

Fund-raising is everyone in the Organisations responsibility, and not simply that of the Treasurer. This kind of awareness needs to be developed amongst our activists.

Also, fund-raising shouldn't be seen simply as a means to raise money, but rather as part of our political work in ECC. A good guideline for weighing up possible events is to assess a. Fund-raising potential
b. E C C profile
c. Effort involved, relative to amount raised.

SUGGESTIONS FOR FUND-RAISING

On going work

Media Sales

As far as possible any media produced should be sold for at least R1 above cost.

Numbers should be carefully worked out (rather be conservative in estimates, and then reprint)

Where possible centralise production to cut costs and effort.

Membership

Membership fees should be consistently asked for. A good idea is to ask members to sign a stop order (See attached form).

FAIRS

To date E C C Fairs haven't been seen as a fund-raising event, but rather as a publicity event. We should try also to use these to raise funds (e.g. School Fairs that raise *R50,000)

CULTURAL EVENTS

These are fun, good for E C C profile and raising money.

CONCERTS

These can be excellent fund raising events, but timing should be worked out to ensure their success.

SPECIFIC SUGGESTIONS FOR TOWN BRANCHES

Lobbying of key individuals (see attached letter from C/T).

FORMAL DINNERS

These are aimed at V.I.P's and associates.

SEMINARS 3/.....

1. Present:- Cape Town - U.C.T., Johannesburg - WITS, Durban - Pub Campus.

2. Reports were given by each of the Regions. Generally, Treasurers experienced the same problems - Lack of funds, fund-raising and awareness of the issue.

3. FUND-RAISING ACT OF 1978.

AIM The aim of the current fund-raising Act is to control the fund-raising abilities of Organisations.

THE ACT

1. Prohibits The collection of contributions from the Public in the Republic.

2. Prohibits The raising of funds abroad. "Any contribution solicited, accepted or obtained from any person or Organisation being outside the Republic, shall be deemed to have been collected from the public in the Republic+.

Unless Authority to raise such funds have been given to the Organisation by the Director of Fund-raising.

EXEMPTIONS:-

1. State Institutions, Local Authorities & Hospitals.
2. Collections by Religious Bodies.
3. Collections by Education Institutions & University Councils
4. Collections by a Political Party.
- AND 5. Collections of funds from an Organisations Membership.

If an Organisation wishes to collect funds from the public, they must apply for a fund-raising number. To do this, the following must be submitted to the Director of Fund-raising.

- a. Constitution of the Organisation
- b. Audited financial statements.
- c. Name and objectives of the Organisation
- d. Membership powers and priveleges
- e. Area/s in which contributions will be collected, and for what
- f. Procedure of amending the constitution.

This procedure basically ensures that any Organisation the Government disagrees with is unlikely to receive a number.

OFFENCES UNDER THE ACT

1. To collect contributions without authorisation
2. To use contributions for unauthorised purposes
3. Failure to keep proper records

PENALTY

1. Maximum sentence of either a fine of R1500-00, or imprisonment for a period not exceeding 3 years, or both.
2. The Act also provides for the Criminal liability of any person who participates in the management or control of an

Organisation 2/.....

POWERS OF THE REGISTRAR

- a. To enter premises without notice or warrant
- b. Powers to examine or remove any books or article
- c. Powers to request explanation re finances
- d. Powers to examine past and present office bearers.

c. PENALTIES

For receiving foreign funds, failing to comply with restrictions, using money for incorrect purposes or evading the law..... 10 years or R20,000-00 or twice the amount received.

For failing to furnish proof of origins and use of funds R1000-00 or 1 year or both.

The End Conscription Campaign was launched in 1983 as a response to:

- 1) the compulsory conscription of young white men into the defence force,
- 2) opposition to the increasingly political role played by the S.A.D.F., and
- 3) the inadequate alternatives provided for conscientious objectors by the Defence Amendment Act of that year.

From initially small beginnings we grew rapidly into a national structure with ten regional and five campus branches. The pertinence of the issue to so many South Africans was illustrated by the numbers participating in our City Hall rallies, supporting Ivan Joms' Fast in St. George's Cathedral or in our "Working for a Just Peace" community projects.

This year we have set ourselves the target of mobilizing as wide a range of support for a system of alternative national service, open to all South Africans, and being of direct service to the community. Our intention is to develop a realistic and well studied proposal that can be presented in the form of a draft bill to parliament in 1989. In this way we hope to open the way for conscripts with moral or religious objections to the S.A.D.F. to serve South Africa in a more constructive manner.

These plans will require financial support for their implementation. The new regulations regarding fund raising are likely to affect the organizations from whom we get most of our funds, notably the South African Council of Churches and the South African Catholic Bishops Council, making it necessary for us to look for local donors for support. We therefore ask that you could consider making a financial contribution to the E.C.C.'s projects for this year. We have included a campaign outline and a budget of the various phases.

In spite of being targeted by the emergency regulations, and being the target of the S.A.D.F.'s "dirty tricks" campaign, we have proved our ability to carry the issue of conscription forward. Through our contact with conscripts we feel that the campaign for Alternative National Service is one of our most significant campaigns, appealing to a far broader range of South Africans, and carrying us into an era of achievable political goals. We ask you to support us in this endeavour and we request a meeting with yourself, at your earliest convenience, to discuss these matters further.

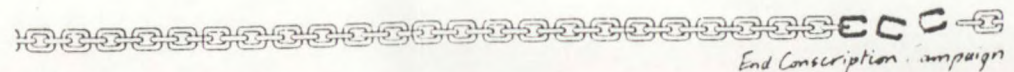
