14. BANKING ACCOUNT

- (a) The funds of the Club shall be banked at a bank convenient to the Treasurer.
- (b) All funds of the Club shall be handled by the Treasurer. The banking (current and savings) account shall be opened in the name of the Club. The Treasurer must sign plus the President or the Secretary.

15. AMENDMENTS TO THE CONSTITUTION

The constitution shall be amended to or altered provided such amendments or alterations are received in writing by the Secretary not less than 21 days prior to the holding of the A.G.M. or a S.G.M. of the Club.

Voting on such matters shall be carried by not less than two third majority.

16. DUTIES OF OFFICIALS

(a) Chairman and Vic-Chairman

- (i) The Chairman shall preside at all meetings.
- (ii) In the absence of the Chairman the Vice-Chairman shall preside.
- (iii) In the absence of the Vice-President and President a member of the council shall be appointed to preside.
- (iv) The Chairman has a casting as well as a deliberate vote.

(b) SECRETARY AND ASSISTANT SECRETARY

- (i) The Secretary shall be responsible for all incoming and outgoing correspondence of the Club.
- (ii) The Secretary shall be responsible to keep an accurate record of all minutes of meetings of the Club.
- (iii) The Secretary shall be responsible for sending notices of all meetings.
- (iv) The Assistant Secretary shall assist the Secretary in all his duties.
- (v) The Secretary shall Present Annual Report at each A.G.M.

(c) TREASURER

- (i) The Treasurer shall keep an accurate record of all the finance of the Club.
- (ii) The Treasurer shall be responsible for all expenditure and income.
- (iii) The Treasurer shall assist the elected auditor at all times.
- (iv) The books of the accounts must be presented on request from the President, Executive, Council or Auditors.

17. DUTIES OF PLAYERS

- (a) To attend all meetings of the Club.
- (b) To participate in all activities of the Club.
- (c) To act in a manner so as not to bring the Club into disrepute.

18. DOUBLE STANDARDS:

- (a) No persons or association of persons, whether as player, administrator, spectator or in any other capacity, who participates in or is associated with any persons or code of sport which practices, perpetuates, fosters, condones or furthers the aims of any form of Double Standards permitting discrimination in sport, shall be eligible for or entitled to retain membership of this Association Club.
- (b) No member of the Club shall in any way condone, encourage, foster or advocate racialism or discrimination in any form and no individual associated with SACOS (and subsequently with this Club) or its members shall in any way condone, encourage, foster or advocate racialism or discrimination in any way whatsoever, and for the purposes of this clause, the participation in, association with or support of all forms of government bodies designed to entrench and/or promote the separateness of people, viz. bodies such as the "Coloured Persons Representative Council, local affairs committees, Management Committees and the like" or any successors thereto, shall be deemed to condone or encourage or foster or advocate racialism and discrimination. .
