My dear,

This is to confirm that I received your tel. & telephone message, I immediately arranged for our friends accompanied by our attourney to meet her. But not there were also the "boys" however, they did not question her, him just followed her to her house and remained watching the place for some time. This afternoon we met. Her heart is not too good and it is worrying me, we will have to spare her. The women in her area are not leaving her alone, this morning early they convened a mass-meeting, but being exhausted from yesterday, she sent in a written speech. I appealed to her to look after herself so she will be well enough for Saturday and other meetings that we organised for her. It is such a relief for me that she is back home! Her illness was a great worry to us.

Now, we must get into action. Can Lil, be taken off from work and become an organiser for our Federation? I submit this proposal, I suggested it to the few of us this afternoon and they were all glad. Let us not waste time and get on with organising our women and build our Federation. We will have to raise money ie her salary and organising expenses. Am certain that she would prove an excellent worker. Please discuss it with her and others & let us have your decision, as we are meeting next week to work out a programme of work, and to get a fuller report to the full Committee.

The other suggestion which I made in a previous letter to you is that both Lil & Dora should write a book on their experiences in their own languages in their own style. Tis they must get down to do it right now. Dora undertook to start doing it. By the way, this weeks New Age has a lot on us - Lilis letter to me and her report is good work! Next week they will have from Dora, I suggest we should keep on having interviews from them alternatively every week, so that they are constantly before our women readers. And we will issue an appeal to our women to read, sell the New Age.

Are we getting the machine from you this week-end? please let us have it as soon as possible and also I see this Internationa Exhibition held by the S.A. Federation of Women - where was it held & when?

Dora told us that the W.I.D.F. H.O. has not received our reports we sent to the Geneva Conference ie on Peasant Women and position of our Children. This is strange, I myself sent over 4 copies. However, you have my only one copy and I still appeal to you to bring it out in a duplicated waxx pamhplet and we will beable to sell it. This material is essential to our comrades in their work.

I enclose a letter to Lil. I sent off a note yesterday to H. to assure you that she has arrived.

You have been elected "at. ec. at Conference and the job is a big one and will require all your attention, time & energy to build the Federation on a national basis and bring **ixxx** other centres up to the Tvl. region level. The question is who is to take on the job of the Tvl. region sec. you mention M. G. she is European and has just joined us recently, surely we should beable to find an Indian or African woman comrade who w ill have the respect and will with <u>assistance</u> beable to carry out the tasks.

My dear, in our country, we have to strain every nerve of ours to train non-European leaders, rather slow and paistaking at first, but in the long term policy will yield better results, therefore my dear I would like you to discuss these points and let me have your views & decisions. Your undated letter received this evening. I cannot describe the pleasure your letter gave me. Received copies of documents. Please let me have one more set as I handed this set over to our committee. Now my dear, words fail me! I feel so indebted to you for the wonderful work you are doing. You have put the Federation on the map.

<u>Re P.E.</u>: Gladys will go up in January. We must try and get Lilian there too at the same time, so it will be in preparation for the Conference. Having inspired P.E., P.E. will assist in bringing women up in East London, Kingwilliamstown, Alice etc, i.e. suggest P.E. establishes a Nat. Conference preparatory committee and undertakes to make the conference known to these women. The same pattern should be followed for the Transvaal Region, Durban and Cape Western.

Re National Conference - Peoples sufferings. We must start on our National Conference now and link it up with every campaign we have, and campaigns there are plenty with all the wrongs the Government does to our people. These mass removals of women, the breaking up of homes - this cruelty they are committing to women and children must be exposed. The 27th October has proved that. Our Federation. born with the burning desire to organise our women against racial and national oppression and discrimination is there to organise and lead the oppressed women to freedom. This Pretoria march must be made known all over S.A. and therefore your idea for a booklet on how it was done, etc will be a useful instrument in the work. The fact that the women have raised 1800 and that you have a deficit only of £12.10.0. is a proof that the movement has become a part of the people and shows what they are capable of. I am convinced that the 27th affair will make many organisations who in the past ignored our letter, to reconsider their attitude. Therefore we must soon come out with a statement on our National Conference. Perhaps we should not now press for affiliation. Let them all send delegates to the Conference and cast the constitution etc. we must be flexible. we have nothing to be afraid of - the women gathered will, I am sure, arrive at correct decisions.

On the question (a) where the Conf. should be, I feel it should be in Johannesburg, again the 27th affair proves that you deserve the honour and are capable of organising it. (b) when? April, Easter weekend proved a suitable date. Please discuss these points and let us have your views so that a circular can go out to our very few contacts. Am looking forward to seeing you. Please make an effort to come here in Feb. It is good weather, winds are down and am sure you need the holiday. will arrange accommodation for you. It has been read and re read, quoted in speeches of which there have been many, as we are right in the middle of the tenth anniversary celebrations here. At the press conference which we held on December 2nd here, we gave a very full report of your letter and all that it contained.

For the moment this is a personal letter, but you will of **MOM** course be hearing officially. On the cash. I have written to the friends in London to make sure that they have received the money from the air line. In a previous letter they had indicated that there was only about 70 to come from the air line, but I cannot believe that this is the total ammount which is due. So I have written again asking them to check. I am sorry for all the delay, but as you can imagine we are not anxious to pay out twice, and we cannot let the air line get away with any thing which it would seem they are trying to do. I shall be going home at the end of the month for my holiday so I hope to be able to clear things up while I am there. If everything proves to be 0.K. then I will make arrangements immediately to see that the money gets to you.

We have had a very nice letter from D. Her banning must have been a great blow to you, but not entirely unexpected. We wrote her congratulatingher on her statement when the banning notices were served. From L or G we have heard nothing. We appreciate that they must be very busy, but a line from them ocassionaly would be very much appreciated here.

I was sorry to hear that you are not receiving the magazine. While I am home I will check on a number of things, and one of them will be to see that some copies are posted to you from there Maybe you will not get it, but anyway we can try.

Please excuse this very short note. Am just leaving for Paris to take part in the tenth anniversary celebrations there.

I told John I would approach Lilian on this question this afternoon, and see what she has to say, then let him know on Thursday.

I don't know what you think of this, but if you have any **ftffed** rooted objections to meeting Virginia and Co, perhaps you had better ring me before this afternoon.

There is a lot I would like to say to you on the question, but no good for a letter!
