
Dear Mr. Paton:

For a variety of reasons I have not been able to get back to you sooner.

We would definitely like to proceed with your recording. Technically, we would like to have a fifteen inch per second tape, single track. As regards our financial terms, we would like to advance you \$100 to cover the recording expense which you estimate at \$42, with the remainder applied to your advance. What remains of your \$300 advance will be forwarded to you upon arrival and acceptance of the tape here. As to the contents, I will leave that up to you, with the understanding that you will include portions of your novels, as well as your poems. Perhaps you could group your selections around a general theme.

We will send you the check as soon as you have let us know that you approve of this suggestion.
