Dear Dr. Xuma,

Seeing that very little time is available for conversations on matters of importance, I have taken this opportunity and methods of giving you information regarding some of the plans and problems of the Institute.

GRANDS FROM THE NATIVE AFFAIRS DEPARTMENT: - As a result of our negotiation with the Secretary for Native Affairs we have been granted the following funds for improvements of the Institute. 1. Water Supply.....£210

2. Lighting System..... 560

3. Sanitary..... 422

Improvements in the water and lighting systems are already on the way. The sanitary improvements were completed earlier in the year. Application have been made for the payment of the grant for this purpose. The improvements in the water system consists of 2 windmill pumps, 3/1000 gallon water tanks, pipes and fitting for conduct of water to buildings and gardens, and a small resevoir for irrigation.

The improvements in the lighting system will be that of getting 2 additional lighting plants on the campus, to furnigh lights for the hostels and eventually to the Practising School. These improvements should be completed withing a few weeks.

PURCHASE OF 50 MORGANS OF LAND. These matter has developed into a real problem. We have succeeded in gheting the promose of a loan of £4000 with 15 years within which to pay. But there has arisen a serious difficulty in getting the payment of the loan. We must produce the Transfer Deed of the Seven Morgans recently purchased from the Evaton Hearth Committee. There is a delay in the due to the fact that there is a restrictive clause regarding the ownership of this land by Natives. We have had to make a plea to Court for the Cancellation on this clause. The attorneys have given the assurance that this will be done. But the question of time enters. According to the attorneys this will take another six weeks at least.

This would not be so terrible were it not for the fact that the owner of the land, Mr. Harmann is impatient and wants to sell without further delay. I have written to him explaining the position and requesting him to give us a little more time.

On the other hand the Lawyers have suggested that if we can raise the money in some other way, we can proceed to get the deed of sale signed. But that is just where the problem comes in.

From the standpoint of the church this cannot be done. There is not sufficient money in all of the treasures combined to meet this amount. Moreover, by have not been able to arouse interest in the conferences of the 15th Episcopal District in this project even though I have been presenting it over and over again.

The suggestion has come that perhaps we might be able to get some aid from the Bantu Welfare Trust Fund. I shall be very glad to get your advice and support on this issue if you think there is a possibility.

Even if the subject of the land is settled without the aid of the Bantu Welfare Trust's support, for the purpose of the building of the High School we shall still need some help. This question of accommodation for High School is also a growing problem.
