### The Just Peace Memorial Project

In order to make a lasting statement of protest, solidarity and hope, the End Conscription Campaign has initiated the Just Peace Memorial Project (JPMP) in the Western Cape. It is hoped that we will be joined by a representative grouping of religious denominations in supporting the Project.

### Description

The JPMP will consist of a central memorial in Cape Town. In addition four plaques will be placed at important sites around the Western Cape.

The memorial itself will consist of a bronze sculpture fixed on a stone plinth. The sculpture will be made by a leading young South African artist, Gavin Younge. Attached is an initial diagram of the sculpture, the artist's iconography and <u>curriculum vitae</u>. On the plinth will be fixed a plaque with the following wording:

"This memorial is dedicated to those who have suffered in the persuit of justice and peace in South Africa.

"We also remember those South Africans conscripted to take up arms against their will.

"Towards a Just Peace.

"This memorial is the centre of the Just Peace Memorial Project. Other plaques can be found at ...etc."

The four other plaques will be located at the following places, and tentatively contain the following wording:

1) At Stellenbosch:

"Hierdie gedenkplaat word opgedra aan alle dienspligtiges wat sonder keuse in die SAW dien. Voorentoe na 'n regverdige vrede."

(Translation) "This plaque is dedidicated to all conscripts who serve without choice in the SADF. Towards a Just Peace."

2) At Rondebosch Congregational Church:

"This plaque is dedicated to the families and friends of those suffering under the system of conscription. Towards a Just Peace."

3) A+ the University of Cape Town:

"This plaque is dedicated to those suffering as a result of SADF actions in Southern African countries. Towards a Just Peace."

4) In a Cape Town township:

"This plaque is dedicated to those suffering as a result of SADF actions in the townships. Towards a Just Peace."

4) In a Cape Town township:

"This plaque is dedicated to those suffering as a result of SADF actions in the townships. Towards a Just Peace."

At present, sites are being investigated for the memorial and the plaques. As indicated above, the Rondebosch Congregational Church is to be the site of one of the plaques.

### Why a Just Peace Memorial Project?

The memorial and plaques will be a permanent and thus lasting expression of protest and hope. This is particularly important when we see that we are entering a period of greater restrictions in which much protest will be denied by the authorities. In this light the project will be a constant reminder to the public and those in power of its message.

It is intended that the various elements of the project be placed in public places. Literally thousands will see it every week and hopefully be positively affected by its message.

Public awareness of injustice and the stuggle for peace in Southern Afica will be raised by the project.

It will promote non-racialism by linking the suffering of blacks and whites.

Our proposed date for an unveiling of the sculpture would be in the first week of October. It is intended that the four plaques be unveiled in the period leading up to that date.

We have identified a number of sites around Cape Town, and are in the process of approaching the bodies responsible. We are hereby also asking your organisation whether you have a suitable site for us to locate the memorial itself. In approaching your department, we had the following sites in mind:

- Somswhere on the Sea Point Promenade;

- The Gardens;

- The grass werge at the intersection of Long, Kloof and Orange Streets.
