IN S.A.

For many years now South Africa has been the dumping ground for American "remainders". That is to say, current copies of their magazines which are unsold in America are collected and sent to South Africa where they are sold at a price cheaper than the normal retail price.

Apart from the economic aspect, in that this type of dumping creates unfair competition for S.A. publishers, these "remainders" are in the majority of cases, what can crudely be given no other name than "trash magazines".

The N.P.U. has been concerned about this unsatisfactory state of affairs for some time and feels that the time has come to approach the Government on the subject. The literature reaches the hands of Non-European adults, adolescents and children and there has been a fair amount of press criticism in recent months about the ill-effects which it has.

My Executive Council have instructed me to arrange a conference with the appropriate Minister to discuss the possibilities of introducing stricter control on this dumping and have suggested that you may care to nominate a representative to join the deputation with a view to speaking from the African point of view.

My dear Friend, MENTAL ILLNESS and ITS MENACE TO THE NATION

If it is as senior office-bearer or National Convenor or National Adviser or Branch President that you read this letter, grant me the favour that you read it primarily as a woman. It is in that capacity, with its qualities of compassion and concern, that I address you.

During the whole course of its existence, our Council has interested itself in the subject of mental health and has viewed with increasing disquiet both the terrible development of disturbing features in our community life and the growing inadequacy of our treatment and curative services.

We are confronted today with a shocking rise in the divorce rate, with a sharp increase in the number of alcoholics of both sexes, with almost daily reports of cruelty to children, with accounts of crime perpetrated by manifestly disturbed personalities, with knowledge of increasing numbers of cases of mental break-down, with our own intimate and often tragic experiences.

We know that the problem of promoting mental health is thoroughgoing, that it concerns our National Convenors for Child Welfare, for Education, for Social and Moral Welfare as much as our National Convenor for Public Health.

We know that many of our colleague organisations - the National Council for Marriage Guidance and Family Welfare, Social Services of South Africa, the National Council for Child Welfare, Adult Education Councils, and many others including the National Council of Mental Health itself - are deeply concerned not only with the rising number of disturbed personalities but with the lack of facilities for preventing individual break-downs.

We know too that the Minister for Health, the Honourable Mr J.F. Naude, is aware of this acid element now corroding the life of our community and, as Dr McPherson stated in her last circular, that he is attempting to devise means to combat it.

For many years, our Council has done what it could. It has passed resolutions and made representations; but the situation has progressively deteriorated until now, the worsening mental health of the nation has become a matter of immediate and urgent concern.

Your Board of Officers, entrusted with the implementation of our Council's policy, has sat baffled before the problem of giving effect to the many resolutions which it is its duty to express - resolutions on penal reform, on juvenile delinquency, on alcoholism, on many kindred subjects, and on mental health itself. In conclave with the National Convenors for Social and Moral Welfare, Public Health, Child Welfare, and Education, it has evolved a plan for which I now seek all the assistance and cobperation which it is possible for you to give.

It is proposed that we, as your servants, organise a National Conference on behalf of the National Council of Women to discuss those aspects of the matter in which immediate and practical action may be taken. Indeed the Bloemfontein Branch Council has already kindly agreed to undertake the arrangements at the New Red Cross Hall in Bloemfontein from the 3rd to the 6th October.

The delegates would consist of as many representatives as each Branch Council could afford to send (and if a Council could not afford to send even one, Headquarters would find the money to pay the fare), representatives of nationally-organised societies, of our sister Councils in Africa, and of Government and Provincial authorities.

For such a conference to prove effective (circumstances impel its being held at this early date), it is essential that the delegates be well prepared.

I ask you now to devote your best attention and efforts, and that of your committees and your Council to the consideration of the following:

We know that the sense of social disgrace which we have allowed to develop in relation to mental illness has serious effects; for instance, people in urgent need of treatment are not given it until their condition has become acute; and secondly, lack of mental balance causes much friction and unhappiness in homes, sometimes with drastic effects.

Mental ill-health can manifest itself in many forms - in mental retardation, behaviour problems in children, alcoholism, epilepsy, lack of independence, family breakdown and the grosser forms requiring certification and admission to mental hospitals or institutions for the mentally-defective - and to deal with these conditions, we must first eliminate wrong ideas about mental illness.

To begin this task, we need factual information and particularly on the following points:

a) is there a mental hospital in your area? if so, what are its problems? is there over-crowding? if so, to what extent? are patients accommodated in gaols because of lack of accommodation in hospitals? are any of the local girls employed as nurses? if so, what are their problems? what is the extent of the shortage of nurses?

b) is these a Mental Health Society in your area? if so, what are the special problems in your area to which it is giving attention? is there close cooperation

between you and the Society?

c) how many people in your area are known to be affected by the ever-growing problem of alcoholism? if there a clinic or anyone from whom help and advice can be had?

d) what is being done for the mentally defective children of all races? is there any form of advice, teaching or training available in your area? are there any epileptic children? if so, do you know that there is only one school in the whole of South Africa where such children, if educable, can be trained to accept their disability and to become active, useful members of the community?

These are only a few of the lines of enquiry designed to plan a programme 1) to break down prejudice; 2) to provide more adequate accommodation and facilities for those in need of help; and 3) to give us a sense of individual and communal responsibility toward the increasing numbers in our community less fortunate than ourselves.

This should be one of the great causes of the National Council of Women, fully consonant with its aims and purposes and with the nature of its members. Details of the conference will soon be sent by circular; but I ask you now to marshal all your resources in its cause and name.

## PERMITS FOR AFRICAN WOMEN

In African woman is entitled to an exemption certificate:

- (1) If she has worked continuously for one employer for **ten years** or more, and she has not during that time been convicted of any crime for which she has received a sentence of more than seven days' imprisonment without the option of a fine, or more than a month's imprisonment with the option of a fine.
- (2) If she has lawfully lived continuously in the area for at least fifteen years and has not been convicted of a crime and sentenced in the same way as (1) above.
- (3) If she was born here, and permanently lives here.
- (4) If she is the wife, or the unmarried daughter, of a man who falls into categories (1), (2) or (3) above, and ordinarily lives with that man.

If an African woman comes under one of these headings, she should go to the Municipal Registration Office at 27 Rutger Street, off Sir Lowry Road, taking with her proper proof of her qualifications to receive an exemption certificate.

Such proof can consist of documents such as birth certificates, in the case of those born here, or whose husbands are born here; marriage certificates, husband's pass receipts or voter's card; doctor's certificates, or proof of attendance at clinics; references or testimonials from employers; and sworn affidavits from reputable persons such as ministers of religion, etc.

The onus or duty to prove that a woman falls under one of the headings above rests upon the woman herself. If she applies for an exemption certificate, she must show proof that she is entitled to it. But even if she is entitled to an exemption certificate, she will not be given one unless she asks for it; in other words, unless an African woman applies for an exemption certificate, the Municipal authorities are not obliged to give it to her.

So if an African woman thinks she is entitled to an exemption certificate, she herself must apply for it, and it will only be given her if she can prove that she falls into one of the categories above.
