This is further to our request of the 10th January for funding of our test case on the continued conscription of white men. SALDEF's approval of our initial request is greatly appreciated by the End Conscription Campaign.

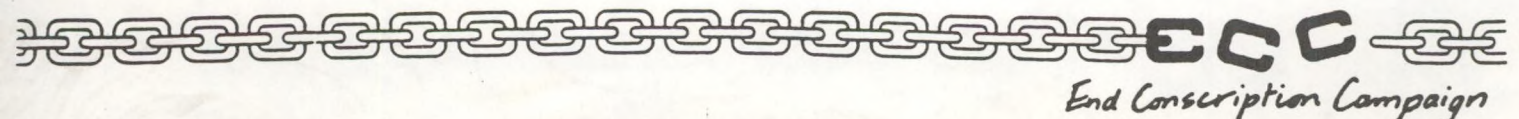
We would however like to request that SALDEF provide further assistance to us by providing funding for an additional advocate to represent ECC, and our co-applicant Richard Rule, in court.

This court application has the potential to bring an end to the entire system of conscription. Whites only conscription is one of the great anomalies of the present period of South African politics. Ending this system of conscription would be an important step forward and would facilitate the creation of a defence force which is representative of South Africans and which will be accountable to a democratically elected government.

We would therefore like to request that you approve this request for funding for an additional advocate. Having discussed this matter with an attorney who is involved with the matter, Mandy Taylor, I understand that the presence of a second attorney will make a considerable difference to our chances of succeeding in this case.
