1. OPENING

The meeting was opened at 14h30 by the Chairperson, Mr G Zabala.

3. MINUTES

Minutes of 30 July 1987 were adopted as read.

4. NATIONAL CONSULTATIONS

The decision of the meeting on 30 July 1987 was reviewed. The participating groups decided instead to plan for a national consultative meeting during January 1988 and Mr G Zabala will ask the SACC to fund such a meeting.

The meeting should aim to maximise participation by self-help, educational, cultural, health and other groups which are out of the ambit of the Church.

Mr G Zabala indicated that during September and October 1987 he intended to get in touch with regional representatives and co-ordinators of discussions.

5. SUB-COMMITTEE REPORT

Mr I Mkhabela outlined Wilgespruit Fellowship Centre's response to Mr Dangor's concerns. Relevant documents were tabled and he also stated that he hoped that the disputed points have been clarified and the issue amicably resolved.

The meeting endorsed and resolved to commend Revd Dale White for the manner in which he has communicated the feelings and position of the group with regard to issues raised by Mr Achmat Dangor in the letter of 30 July 1987.

The Sub-Committee appealed for action on the recommendations of 10 June 1987.

The group recommended to the convenor, Mr Zabala, to ask Mr Dangor to provide the copy of the alleged Citizen article. A date on which it appeared in the Citizen could serve the same purpose.

6. UPDATE INFORMATION

The meeting noted that there were government outbursts and renewed threats following the Dakar Conference. Embassies have also been issued with stern warnings. Also noted was the Reserve Bank's intervention in the NUM dispute.

7. NEXT MEETING

The meeting decided to ask the Sub-Committee to request the Kagiso Trust to host the next meeting at its premises at 2nd Floor, Darragh House, 13 Wanderers Street, Johannesburg, on Thursday, 1 October 1987 at 2.30 p.m. It was proposed that the meeting will serve to bring the discussion groups and Kagiso Trust representatives together. Various funding matters could be clarified and discussed with the assistance of the Kagiso representatives.
