Dear Prof. Hoemnle,

We are very much disturbed by Circular No.3 of 1942, Native Education, dated January 20th, 1942, (re: Quarterly returns to be submitted direct to Pretoria by Native head teachers) for the following reasons:-

- 1. This appears to break their own regulation of 1907 (page 3 of the Handbook) which reads: "It shall be the duty of the Superintendent to see that such records are kept and such returns submitted as may be required by the Department from time to time", and their instruction (page 29) "Teachers.... desiring to communicate with the Department must do so through the Superintendent".
- 2. This has not been discussed at the Advisory Board and the opinions of Superintendents sought on this difficulty.
- 3. Apparently, it has been sent out behind Superintendents' backs to all head teachers while the usual course is to ask the Superintendents to send such circulars to the head teachers.
- 4. It gives far too much power to the Department as to the "correct" payment of salary cheques. If we apply for head teachers' allowances, they can turn round and say Head teachers were late in sending their quarterly returns, or they were not in order when they were sent. Actually, with July 1941 and January 1942 cheques, meither Father Raynes nor myself had the head teacher's allowance paid to our head teachers although our returns were posted in time on both occasions and each of us sent all in one envelope.

If this is so under existing regulations, what of the future? Unless every head teacher registers his quarterly returns, he has no proof that they he posted them. Again, unless the Superintendent countersigns the return, the head teacher has no proof they are correct (paragraph 5 of this circular).

- 5. What if the quarterly returns are lost, wrongly filed, etc., by the Department! During last quarter T.E.D. lost certain Superintendents' receipts and in other respects showed absolute confusion (e.g. Rents were applied for on one sheet of paper, but only 90% were paid. On applying for the other 10% a second time, they replied that apparently they had never been applied for! etc, etc.
  - 6. Obviously, T.E.D. is terribly overworked, but they do not

realise that some Native head teachers and Superintendents are likewise. (T.E.D. made the same complaint about the late arrival of quarterly returns on 3rd November 1936, Circular No.3; so there is nothing new in this as No.3 of 1942 implies).

No doubt it is very inconvenient not getting all quarterly returns in at the correct time; but only when a Superintendent fails successively in this respect should the Department then step in with this method, or else presume the school no longer exists (page 26 of Handbook).

7. What European Teachers Association would allow their head teachers to lose their allowances, if there were mistakes on their quarterly returns? Or, if they were over 10 days late? (Circular No.3 of 1936 read "within 14 days of the close".

What can we do under the circumstances? There is the Advisory Board, but this will probably meet too late for any action.

Is there anything which could be done at once? Would the European teachers Association take it up for the Native head teachers?

The whole circular is obviously aimed against the Superintendents who are not satisfied with what T.E.D. pays and want the Native teachers to get what is due to them according to the scale and living allowance etc. But T.E.D. replies the teachers must be satisfied with what we pay them!

There is the further question of what action a Superintendent should take if T.E.D. persist in refusing to pay cost of living allowance due to the Native teachers, and issue out incorrect statements from Pretoria. As they are servants of the Crown, the ordinary procedure cannot be followed.

Dear Professor Hoernle,

In further reference to my letter of a few days ago about Circular No.3 of 1942, I wonder if you would be so kind as to move some such motion as the following at the Advisory Board on March the 19th:-

"That in the opinion of this Board, it is undesirable to make disciplinary regulations which only affect African principals and are not in force in European government schools of this Province".

In support of this there are the following facts:-

- 1. African principals are to lose their April head teachers' allowances if their quarterly returns are not at Head Office by April the 12th.
- 2. It is admitted by Dr. Eiselen that owing to the War he has an insufficient and incompetent staff at Head Office. It is a natural deduction that if they are blamed for their negligence by Dr. Eiselen, they try to shift the blame on to Superintendents not doing their duty. But Superintendents would bring forward much evidence that Head Office have mislaid various documents. It looks to me as if this is colour legislation as in July and January last not one of the African teachers received their Head teacher's allowance, but on both these occasions Mr. Darling received his! But allowance, but on both these occasions Mr. Darling
- 3. Naturally some principals out of some 950 schools are slow, but this is only similar to the 960 odd European Government schools; e.g. memorandum on the school boards to be found in the report of the T.E.D. for the year ending 1935, page 164, under "Information furnished to Head Office" "Principals are frequently careless and slack in making their returns" "Work would be considerably reduced if Principals were to carry out regulations strictly". But no one has, as far as I know, adopted the method which T.E.D. now proposes as regards African principals. I hope T.E.D. will get it hot and strong from the Advisory Board.

#### re: Alexandra Schools.

Many thanks for your favour of the 19th Instant.

In reply I wish to thank your Health Committee for being prepared to assist us. For the information of your Committee I am enclosing herewith a statement showing the number of subsidised schools in Alexandra Township together with the approximate enrolment, the number of classrooms required and the number of classrooms actually available.

From this your Committee will notice, that there are approximately 7,750 children of school-going age at present accommodated in mission churches, Halls, and other unsuitable rooms and only 59 proper classrooms.

1. Approximately 2000 children of school-going age are not attending any school at present,

2. Five private schools with an approximate enrolment of 750 pupils are receiving no Government support through lack of accommodation,

3. The eleven registered schools have at their disposal only 59 proper classrooms, leaving a shortage of 42 for these supported schools, and that

4. In all 97 additional classrooms are required this year.

These figures are furnished for your information only and to substantiate any representations, which your Committee may wish to make to Native Affairs.

My present application for£ £20,000 is only on behalf of the three amalgamated schools of which I am superintendent For these I require three separate school buildings of approximately 14, 13 and 8 classrooms respectively, together with a fourth building of at least three large rooms for Domestic Science and Boys' Industrial work. If your Committee wishes to increase the sum of money mentioned above, you may do so.

I do not think it advisable at the present juncture to call a meeting of all bodies and organisations running schools in the Township, because i. This my application is not being made on their behalf,

ii. Some of them may even feel inclined to oppose/

oppose such a request, and

iii. I have not as yet discussed such matters

with all their responsible authorities.

iv. In my programme is included a meeting of all concerned (including your Health Committee) at a later and more opportune occasion.

With regard to suitable sites it may be stated that I have inspected a large open piece of ground in front of the Wynberg(?) Police Station, and found this very suitable for school purposes. This is the site, I presume, you mentioned in connection with your predecessor.

The open public space in the Township does not appear to be too suitable, unless the whole of it is eventually set aside exclusively for school purposes.

May I however suggest, that the matter of suitable sites be left in abeyance for later consideration, but that your Health Committee in the meantime apply direct to the Native Affairs Department for a substantial grant (from £20,000 to £30,000) for three public school buildings and one manual work centre as detailed above?

Thanking you personally as also all members of your Health Committee for your interest in and willingness to support us.

(a) The Department placed an order for 750 dual desks with a firm in Potchefstroom of same type and quality you saw at W.N.T. School.

The first lot of 350 desks cost £1.12.6. each, the second lot of 400 desks cost £2. 0.0. each. Those you saw cost £2.0.0. each.

The desks ordered by Dr. Taylor now costs, I am told, £3.12.6. each, if obtainable at Duncan Baynes in Johannesburg.

(b) The last 400 desks were distributed as follows:-

Dear Prof. Hoernle,

Thank you for your long and interesting letter about Circular No.3 of the Education Department and I await a supplementary circular on this subject.

I am quite certain that you did your best and nobody else could have done it better. Personally, I distrust very much methods employed in the O.F.S. where I have been informed that Superintendents are very different from those working in the Transvaal, and I myself am very doubtful about Transvaal superintendents being away for Christmas Day during the December-January holiday, unless they are sick.

Again, as so often in South Africa the personal note comes in and how is one to tell how long Dr.E. is going to centinue to be Chief Inspector and will his successor think as he does? Again, why do so many Superintendents read harsh things into the Departmental circulars?

Here is one answer: Just a fortnight ago
Mr. de Jager visited an Anglican (farm) school at Fortuna. He
found there two teachers and 80 children all housed in one classroom 32' x 15'. Without any reference to the Superintendent, but
acting on Departmental regulations, he turned out one teacher and
thirty children including Std.IV whose names, he said, were not
to appear in the government attendance register, and told them
to hunt for a classroom elsewhere to accommodate these children
and their teacher.

As this is right away on the farms that was, of course, impossible at a moment's notice. The next day he visited the School again to make certain his instructions had been carried out, and stopped just one minute only.

I have in consequence protested to him, but as I have had no reply to this letter, I have reported the matter to Dr. Eiselen. How can Superintendents fail to say that the Officers of the Department are harsh in the interpretation of Departmental regulations?

Technically, Mr. de Jager is quite correct

according to regulations, although the Department have granted me leniency in the farms.

Also, Mr. de Jager has threatened the Head Teacher of our School in Germiston Location that he will do the same there with three teachers and the children they teach because they have not got separate classrooms.

Yet this same person Mr. de Jager is supposed to have started the Joint Council at Lydenburg.

When the dissolution of the Marabastad Location ,Pretoria, was resolved on by the Munisipality and the new Location at Atteridgeville in contemplation, the representatives of the various churches controlling schools was summoned.

It was agreed that, amongst other things, that the schools should not be denominational. That committees should be elected, that Superintenden s be nominated by the epartment.

As the first school building approached completion, a hastily summoned meeting of the Committee decided the order in which the schools should be removed. Dutch reformed first, Anglican second, A.M.E. third.

This left the Methodist Schools, with 850 scholars and I7 teachers well in the rear. We were concerned about the future of the teachers, most of them had served the interests of the school faithfully & well through a long series of years. We were however assured that there was no need for apprehension, that there would be 4,000 children, eight schools, so that principals and teachers would be absorbed. With this statement we were satisfied -at the time.

The next move was that the Dutch Reformed staff was bodily transparent -ed to Atteridgeville's first school & the balance of the teaching staff of ten was recruited from outside teachers.

This action gave rise to great dissatisfaction. A meeting was called by the Chairman of the Schools committee, representing the churches, the Teachers' Association, and the Advisory Board of Marabastad Location &c. I was voted to the Chair. The decision of the meeting was that the Department should be asked to go back on its action and not establish what, rightly or wrongly, was regarded as a denominational school. I may say that I advised moderation, said that everyone would be satisfied when the eight schools materialised. However the vote went as I have indicated.

Now things have developed as noone foresaw. The people are not going to Atteridgeville as was expected. They have moved in numbers to Lady Selborne, Eersterust, astwood. The Schools at Selborne are flooded. The Methodist School has risen from 450 to 600 and I understand that Anglican and R.C.S hools are even more numerous. We have had 8 teachers from the separtment and have paid one from fees. Now we are told we cannot refuse children removed from the Town School. I am hoping to get three or four of the town teachers moved at once and am prepared to put up extra class rooms as soon as possible.

The position is (as I understand it ) there will not be 4000 children at Atteridggville for years. The Council will soon have completed

the High School Building and the second elementary school. I am not sure if it is committed to the erection of a third elementary school. But beyond that ,I am informed that the Council will not go .Amd if it were in a position to find the capital ,the Department is not in a position to guarantee the rent per centage.

With regard to the personel of the second school, I think the Dept has departed from its intention of moving the Anglican school en bloc and placing it under the Superintendence of Canon Woodfield. A circular has been issued to teachers asking them to apply for posts in this school .I advised my I7teachers all of them to apply. To day is the closing day for applications.

Meanwhile the I7 teachers think that I have sold the pass for them and at first did not hesitate to say so. I realise that at the meeting to which I refer on the first page , they were right and I was wrong. But I relied on assurances which never should have been given.

The position is admittedly difficult. The teachers expectations are not reasonable. They think that they should have been transplanted as a Staff, which is not reasonable. Though if the staff could more or less be kept together it would be a gaim in many respects & I have said that if that could be accomplished, anyone can take the Managerskip of the School . That is to me a matter of indifference.

The "citizens" or opposing 11 group, as represented by Moeti, although admitting 11 the qualities of Mgubuli as a teacher, object to his dictatorial methods in this location, and now appear 11 to have found a lever for his removal."

I beg to inform you that the following Circular letter from the Secretary of the Transvaal Education Department (Native Branch), Pretoria, has been sent to all Superintendents of Native Schools as well as to the Principals of these schools in the Transvaal:-

### (Circular Minute No. 6 of 1942, dated 4th March, 1942).

- " I am directed to inform you that the Department
- " is not prepared to allow any teacher to take
- " part in an election for a seat on a Municipal " Advisory Council.
- " Teachers will not be deprived of the right
- " to serve on Advisory Councils provided they " have been nominated as members of such a Board by the Municipality itself ".

As the contents of this circular letter will hit the member-ship of Native Advisory Boards in the Transvaal hard, more especially in the smaller dorps, where it is almost the Native teacher who has any intelligence of local matters, is it not possible to have the contents of this circular delayed for some time.

The majority of the delegates that attend the Annual Sessions of the Location Advisory Boards' Congress, South Africa, are teachers.

I have written on similar lines to Prof. Hoernle, as he represents the Transvaal African Teachers Association in the Advisory Board in Native Education in the Province.

With further reference to your letter of the 25th Ultimo, I have to inform you that African Teachers in Secondary, High and Training Schools are eligible to participate in the Good Service Allowance Scheme in addition to Teachers in Primary Schools. Owing to a misunderstanding, the Transvael Education Department was under the impression that African Teachers in Primary schools only were eligible, but arrangements have now been made to include all African Teachers in the four Provinces in the scheme. In view of the foregoing, the question of the adoption of the Orange Free State Scales of salaries, therefore, falls away.

With regard to the third paragraph of your letter,
I must point out that while this Department makes funds
available to the Provincial administrations towards the
financing of Native Education, the Provincial Administrations have been entrusted with the administration
of Native Education and while I am very sympathetic
towards the general needs of Native Education, I am
afraid that no good purpose would be served by my
