MEMORANDUM of AGREEMENT made and entered into at

Mafeking this ^{5th} ~~August~~ ^{September} 1901 between GEORGE

NATHANAEL HENRY WHALES of Mafeking of the one part

and SILAS MOLEMA of Mafeking of the other part.

WHEREAS the said G.N.H.WHALES has edited

and published 12 numbers of certain Newspaper in the

Sechuana language called "KORANTA EA BECOANA":

AND WHEREAS the said SILAS MOLEMA has

agreed to purchase the copyright of the said paper

on the terms and conditions hereinafter mentioned:

NOW IT IS HEREBY AGREED AND DECLARED:

1. That the said G.N.H.WHALES in consideration of the

sum of £25: (the receipt of which he hereby acknowl-

edges) agrees to sell all his right, title and in-

terest in and to the said paper "KORANTA EA BECOANA"

to the said SILAS MOLEMA who shall edit and be res-

ponsible for the same as from the next succeeding

number to be published, to wit: No.13.

2. That the said G.N.H.WHALES agrees to print in

the present sized type (pica - 6 lines to inch) the

said paper at the following rates: viz: for 500 cop-

ies on one side demi folio (that is to say: 17 1/2 X 11 1/2

inches

inches) at £3 : 3 : 0. Should a large size be required the amount charged shall be in the same proportion.

For extra printing on the back of the paper the rate shall be 10/- per column of a width of 13 ems (= 2 1/2

inches). For extra copies the rate shall be 5/- per 100.

3. In case of advertisements the said G.N.H.WHALES shall receive 20% commission on all payments.

4. The said G.N.H.WHALES agrees not to publish any other paper in the Sechuana language without the consent of the said S.MOLEMA before the year 1903.

5. Either of the parties hereto shall have the right to terminate this agreement for the printing of the said paper by giving three months notice in writing to that effect.

6. The said S.MOLEMA agrees to indemnify the said G.N.H.WHALES in respect of any action for damages in respect of any matter printed in the said paper.
