Dear David Shandler,

I've just found that a publication there has charged the ECC not only with having links with WRI but that WRI is a front or has some special relationship with the World Peace Council based in Helsinki.

This would be amusing if it were not tragic. Let me answer as carefully as I can.

First, ECC itself has no links to WRI beyond our feeling very deeply concerned with what is happening there, worried about things such as the arrest of Philip Wilkenson, etc. ECC is not an affiliate of WRI and I doubt if it would choose to be one, since WRI is a pacifist organization, opposed to all use of violence as a social instrument under any circumstances, while ECC focuses solely on the issue of conscription.

There is no point pretending, however, that your people have not been in contact with us, because they have and such contacts seem to me entirely proper.

Second, on the issue of WRI's own politics, we have been accused of many things because pacifism is hard for some to understand. During World War II we were accused of being pro-Nazi because our men would not serve in the military struggle against the Axis powers. At the same time, within Germany our members were accused of being pro-British, and sent to concentration camps, executed, or forced to flee. And within the Soviet Union we were not then - and are not allowed now - to organize sections.

We have consistently, since our founding in 1923, opposed all totalitarian political forms, and all organized violence - included the violent imposition of racism upon the people of South Africa. We have defended political prisoners in the Soviet Union through decades, and do today. We have been very clear on such issues as the invasion of Czechoslovakia - we sent teams into Poland, Romania, Czechoslovakia, and into Red Square to protest the occupation. (I myself was in Prague by a lucky accident at the time of

of the invasion and was able to bear witness to the popular support the existing government had, and the nearly universal opposition I saw to the Soviet invasion).

One of our sections, the War Resisters League, sent a team to Moscow in 1978 to urge the Soviets take swifter action for disarmament - they demonstrated in Red Square (I was in the group) and that demonstration was ammost instantly broken up by police.

The irony is that if some - clearly at least one publication in South Africa - view us as Communists, or Communist dupes, or dupes of a Communist front, others, and this includes the Soviet Peace Committee, view us as far too rigid in our disagreements with Moscow.

Key people from the WRI have been to Helsinki. I was there most recently this past October for meetings involving both the official peace committees from the Soviet Bloc and the independent groups in the Western countries. We have met with the Soviet Peace Committee, and with the World Peace Council, just as we would freely meet with government authorities in South Africa to discuss our concerns.

The World Peace Council has never made any secret of its general political line, which I feel close to the position of Moscow. It was, in fact, set up to advance that political line as widely as possible. Our disagreements with the World Peace Council are known to everyone who follows the politics of the peace movement. But we defend, fully and deeply, the right of the WPC to exist, and the value of full, free exchange of views. Beyond that, however, we don't feel it is the job of WRI to discuss or define the politics of the World Peace Council. They maintain an office and a staff in Helsinki and questions can be put to them quite directly.

Our own record is exceptionally clear. No secret police files are needed - our publications are on the record, as are our actions. If we are accused of opposing ... the U.S. government in Nicaragua, that is correct. If we are accussed of supporting the Solidarity movement in Poland, that is correct. If we are accused of opposing the Israeli occupation of the West Bank, that is correct. If we are accused of opposing the use of terrorism by the PLO - or any other group, including the ANC that is correct. If we are accused of opposing the Soviet occupation of Afghanistan, that is also correct.

But to accuse us of being a front for the World Peace Council is a charge I think they would resent as deeply as I find it amusing. Our funds are very few but raised without aid from any government, either overt or covert. Our political position represents no nation - only our membership, which had its last Triennial this January, in India, as a tribute to Mahatma Gandhi, who left his mark on us, as he did on South Africa.
