FORMAT FOR SWARAJ SPORTING 50th ANNIVERSARY TOURNAMENT 1995

UNDER 7 TO UNDER 15 DIVISIONS.

**8 TEAMS DIVIDED INTO 2 DIVISIONS, PLAYING A LEAGUE FORMAT.
 THE WINNER OF EACH DIVISION GOES INTO THE FINAL.**

DURATION OF GAMES.

UNDER 7	10 MIN. EACH HALF + 5 MIN.	INTERVAL	(FINAL 15+5+15)
UNDER 9	15 MIN. EACH HALF + 5 MIN.	INTERVAL	(FINAL 15+5+15)
UNDER 11	15 MIN. EACH HALF + 5 MIN.	INTERVAL	(FINAL 20+5+20)
UNDER 13	20 MIN. EACH HALF + 5 MIN.	INTERVAL	(FINAL 25+5+25)
UNDER 15	25 MIN. EACH HALF + 5 MIN.	INTERVAL	(FINAL 30+5+30)

- 1) NO EXTRA TIME WILL BE PLAYED IN ANY PRELIMINARY GAMES.
- 2) IN THE PRELIMINARY GAMES, IF POINTS OBTAINED ARE TIED, GOAL DIFFERENCE WILL BE CONSIDERED. IF STILL TIED, THE TEAM SCORING MORE GOALS WILL BE THE WINNER. IF A TIE STILL PERSISTS, THEN PENALTY SHOOT-OUT WILL DECIDE THE WINNER. 5 PENALTIES, THERE AFTER SUDDEN DEATH TO DETERMINE THE WINNER.
- 3) UNDER 7 + UNDER 9-IF IN THESE AGE GROUP IN THE FINAL GAME ENDS IN A TIE, THEN 5 MINUTES EXTRA TIME WILL BE PLAYED EACH WAY. IF STILL A TIE PERSISTS THEN THE RESULT WILL BE DETERMINED BY A PENALTY SHOOT-OUT. (INITIALLY 5 PENALTIES EACH WAY TAKEN BY DIFFERENT PLAYERS)IF STILL A TIE THEN SUDDEN DEATH PENALTY SHOOT-OUT.
 UNDER 11 -13+ 15 - AS ABOVE EXCEPT THE EXTRA TIME WILL BE 10 MINUTES EACH WAY.
- 4) TEAM MUST BE IN POSSESSION OF THEIR LEAGUE REGISTRATION CARDS. TEAMS FIELDING UNREGISTERED PLAYERS WILL BE SUSPENDED FROM THE TOURNAMENT AND FORFEIT ANY FEES PAID.
- 5) ANY PLAYER ISSUED WITH A RED CARD WILL BE SUSPENDED FROM TAKING FURTHER PART IN THE TOURNAMENT. THIS ALSO APPLIES TO A PLAYER ISSUED WITH 2 YELLOW CARDS. THE LEAGUE WILL ALSO BE NOTIFIED OF HIS SUSPENSION.
- 6) TEAM MANAGERS MUST REPORT TO THE ADMINISTRATION STAND AT LEAST 20 MINUTES BEFORE THE START OF A GAME. NO GRACE TIME WILL BE ALLOWED FOR ANY GAME.
- 7) A MAXIMUM OF THREE SUBSTITUTIONS PER GAME WILL BE ALLOWED.
- 8) UNDER 7 TO UNDER 13 WILL PLAY WITH A SIZE 4 BALL. U-15 SIZE 5 BALLS
- 9) UNDER 7 AND UNDER 9 THE FOUR STEP RULE/ BACK PASS WILL NOT APPLY. CORNERS AND SPOT KICKS WILL BE TAKEN FROM THE 18 BOX.
- 10) NORMAL RULES APPLY FOR THE UNDER 11 + 13 EXCEPT CORNER KICKS WILL BE TAKEN FROM THE 3/4 MARK.
- 11) UNDER 15 NORMAL RULES.

- 12) REFEREES WILL BE APPOINTED BY THE TOURNAMENT COMMITTEE. THE REFEREES DECISION WILL BE FINAL AS FAR AS ACTUAL PLAY IS CONCERNED
- 13) THE ORGANISERS WILL NOT BE RESPONSIBLE FOR ANY LOSS OR DAMAGE OR INJURY , TO ANY PROPERTY , OR PERSON DURING THE TOURNAMENT .
- 14) ALL FLOATING TROPHIES REMAIN THE PROPERTY OF THE SWARAJ SPORTING FOOTBALL CLUB. RECEIPIENTS OF TROPHIES WILL BE REQUIRED TO COMPLETE INDEMNITY FORMS , PLEDGING TO RETURN AND OR PAY FOR DAMAGE OR LOSS OF TROPHIES.
- 15) ANY MATTER NOT INCLUDED IN THESE RULES WILL BE DECIDED UPON BY THE SWARAJ SPORTING TOURNAMENT COMMITTEE . THIS WILL ALSO APPLY TO ANY INTERPRETION OF THESE RULES .
- 16) PAYMENTS OF THE TOURNAMENT FEES INDICATE YOUR ACCEPTANCE OF THE RULES AND CONDITIONS OF THIS TOURNAMENT.
- 17) ALL TEAMS MUST SUBMIT A MEMBERSHIP ROLL (TEAM LIST) OF 20 PLAYERS (MAXIMUM) AND A MANAGER .SEPARATE MATCH CARDS MUST BE COMPLETED AND SUBMITTED TO THE REFEREE BEFORE EACH GAME. TEAM LIST WILL BE CHECKED WITH LEAGUE LIST.
- 18) CLUBS ARE URGED TO BRING + DISPLAY BANNERS.
