Your Worship,

On behalf of many women of all race in Johannesburg, the Federation of South African Women and the African National Congress Womens' League request that you will receive our delegates at 12 noon on Thursday, November 27th, 1958 when many women will come personally to the City Hall to present to you, the Mayor of this city, their protest against the issuing of reference books to African women in Johannesburg.

All citizens of this land are aware of the deep resentment against the pass system which has, for many years affected so harshly and so tragically not only African men, but their wives and families. African women dread the extension of passes to themselves and have, during the past three years, protested in thousands to Native Commissioners, to the Minister of Native Affairs and to the late Prime Minister.

During the past month reference books have been issued for the first time in Johannesburg. You are aware of the spontaneous protests of some two thousand women, which led to the infringement of bye-laws and of the punitive measures taken against these women. But these reprisals have not in any way decreased the objection of African women to passes; nor is the objection limited to African women, for many women of other races wish to identify themselves with this protest against passes and against the co-operation of the City Council, as reflected by the policy and practice of the Non European Affairs Department, in a measure so hateful to so many of the people of Johannesburg, both voters and voteless

You will recall the historic protest of twenty thousand women of all races to the late Prime Minister at the Union Buildings in Pretoria on the 9th August 1956 - a protest acclaimed throughout South Africa for its dignity and discipline, and its legality. On that occasion the representatives of the women were denied an interview. On November 27th 1958, women of Johannesburg will come to you, the Mayor of Johannesburg, confident that you will not refuse to meet the representatives of the women of your city. We shall come as women and mothers in dignity and discipline; in racial harmony. It is not our intention to infringe the city's bye-laws: we come to exercise our right of peaceful protest and our right to present that protest to you, who represent the City of Johannesburg.

Mesdames,

The Mayor (Clr. I. Maltz) has asked me to acknowledge receipt of your letter of 16th instant in which you request him to receive a deputation at 12 noon on Thursday, 27th November, 1958.

The Mayor is not able to see your deputation on the 27th instant but is prepared to give consideration to receiving it on another mutually convenient date and time. It must be pointed out, however, that the subject matter of your deputation does not fall under the jurisdiction of the Mayor or of this Council.

It occasioned the Mayor a good deal of surprise when before he had agreed to receive the deputation a department of the Council showed him a pamphlet which had been issued by your Federation and the African National Congress Women's League and which seems to convey that the Mayor had already agreed to receive the deputation on Thursday the 27th. It appears to the Mayor that your Federation wishes to use the occasion for the purpose of staging a mass demonstration on the steps of the City Hall and he wishes me to make it clear that he is not prepared to allow your Federation to use him as an instrument for any such purpose. He would normally have been glad to meet a deputation of your Federation and to hear any representations it wishes to make to him on matters affecting the city and its people but he cannot receive any such deputation if it will be accompanied by any sort of demonstration. The issue of the pamphlet is most unfortunate and you should take immediate steps to have it withdrawn and explain that no mass protest can be received by the Mayor.

The Mayor wishes to know whether your Federation still desires to send a small deputation to meet him at a mutually convenient time and date to be arranged between us. On receipt of your reply giving full details of those persons who will form your deputation and an undertaking that any deputation received by him will not be accompanied by any form of mass protest or any other form of demonstration he will give your application further attention.

Dear Sir,

The Pederation of South African Women has received your letter of November 21st. We find it a matter for deep regret that you should refuse to receive the representative of the women on Thursday, 27th November

The issuing of passes to African women is a matter of vital concert to women and we cannot accept your statement that this matter falls outside the jurisdiction of yournelf and the City Council, for officials of your Department of Non-Barogoan Affairs have opanly and officially co-operated by making permits and houses conditional upon the production of reference books. Moreover your Location Superintendents have associated themselves with the issue in an unmistakeable manner. Der has the City Council uttered any protest wantsoever against the subjection of the European residents to the deliberate intimidation of the letters signed by the Native Commissioner requesting that domestic agreement be sent on a particular date for reference books.

The women will submit written protests to you, which they will deliver personally to the City Hall on Thursday, 27. At no time have women been asked to form processions and we repeat that it is not our intention to violate any Municipal regulations or any laws. The right to protest is a fundamental democratic right, a right of supreme value to non-Europeans who are denied the vote. The manen will exercise this right when they bring their protests to the doors of the City Hall, the doors which you have closed on that day to their representatives.

The Federation of South African Women welcomes any opportunity of meeting the Mayor of Johannesburg to discuss the issue of passes, but we as their representatives cannot disassociate curselves from the women who will hand in their rotests on Thursday, and we urge you to reconsider your refusal to receive the representatives on Thursday. We ask you to realise how this refusal must embitter and despen the present tension and

despair of these women who struggle desperately against the pass system, which has so harshly affected the lives of their menfolk and now threatens their own existence.
