SOUTHERN RHODESIA GOVERNMENT.

Conditions governing the award of bursaries for Native Students attending Educational Institutions in the Union of South Africa.

1. Purpose of Bursaries.

The Government of Southern Rhodesia has inaugurated a bursary system to assist deserving and promising Native Students in taking courses of instruction not available to them within the Colony. Bursars must be prepared, upon completion of the course, to take up approved employment within the Colony of Southern Rhodesia. In the award of bursaries preference will be given to applicants for such training courses as :-

- (a) Native Frimary Higher Teacher's Course.
- (b) Post-Matriculation T 3 Course.
- (c) Post Graduate Teacher's Course.
- (d) Hofmeyr School of Social Work.
- (e) Agricultural Diplome Course at the South African Native College, Fort Hare.
- (f) Any other course approved by the Bursary Advisory Committee of Award.
- 2. Amount and Tenure of Eursaries.

The amount and number of bursaries awarded in any year will be in the discretion of the Minister of Native Affairs.

Bursaries will be tenable for one year at any recognised educational institution in the Union of South Africa. Bursaries may be renewed for one year at a time at the discretion of the Minister to students who have good school or college records. It is to be noted that no new bursar will be awarded a bursary for more than four years, provided that if the bursar takes up approved employment in Southern Rhodesia for one year for each year he has held a bursary he may become eligible for another bursary for an approved course of training.

Bursaries will be paid direct to the Principal of the School or College attended by the Bursar and will generally be of an amount which will cover the inclusive fees charged for the course taken by the Bursar, provided that no bursary will exceed £50. 10. 0. a year. \checkmark

The Minister may withdraw the bursary from any Bursar who fails to pass any of the required examinations or whose conduct and general progress is considered to be unsatisfactory.

- 3. Eligibility of Candidates for Bursaries.
- (i) Candidates must be the children of parents resident in Southern Rhodesia.
- (ii) Candidates should be between the ages of 16 and 25 when applications for bursaries are made. In exceptional cases consideration will be given to applicants outside this age range.
- (iii) Candidates must normally possess a school certificate not lower than the Junior Certificate or its equivalent.

- (iv) Generally preference will be given to applicants whose financial circumstances warrant assistance, to enable them to complete an approved course upon which they have already started.
- (v) The award of bursaries to candidates for a degree course will be confirmed only after the subjects to be included in the degree have been approved by the Director of Native Education. Normally in the case of students taking an Arts Degree approval will be given only if the proposed course includes at least three subjects taught in schools of which at least one subject must be a major subject.
- (vi) Selected candidates will be required to produce a satisfactory medical certificate.

4. Applications for Eursaries.

Applications for Bursaries must be made on the prescribed form which may be had from the Director of Native Education, P.O. Box 686, Salisbury.

Applications for bursaries must be received by the Director of Native Education not later than the 31st August in the year prior to that in which the applicant proposes to commence the course.

Bursaries are tenable for one year only and if a bursar wishes to have a bursary renewed for a second or subsequent year he must submit a fresh application each year.
