APPOINTMENT OF A TRAVELLING ORGANISER

Some time ago His Excellency, Chief Scout, South Africa, spoke to me in regard to the development of Scouting in country areas and in those Divisions unable to employ whole-time men. His Excellency asked me whether I had in mind any scheme that would mean personal contact with isolated Groups, particularly in country districts.

I explained to His Excellency that I thought a solution to the problem would be the appointment of a "Travelling Organiser" whose services would first be offered to those Divisions who had not a whole-time Staff. His duties would be to organise where necessary, interest prominent people in the Movement, be generally helpful, give advice etc., visit country areas and inspire Groups who had not had recent visits or encouragement through lack of facilities, talk to gatherings of Scouters, Local Associations, parents, etc. - and in short to press the claims of Scouting. Even those Divisions with established Headquarters and a fulltime staff could, if they desired, make use of the "Travelling Organiser" in their country areas, especially in places where it is thought that a stay longer than a few days would be necessary.

His Excellency asked whether I thought the appointment should be a permanent one, and I said I thought so because continuity was essential. His Excellency very graciously proceeded to try and raise a fund for this purpose as he considered that it was a step in the right direction. The position to-day is that while the fund raised is not sufficiently large to bring in a permanent income which would enable the Council to employ a "Travelling Organiser" for an indefinite period, His Excellency has been able to raise a sum of £900 per annum, guaranteed for three years. In consultation with His Excellency's Secretary the following is the

Guaranteed Income per annum for 3 years -- £900.

Designation of "Travelling Organiser" to be "Assistant Secretary to the South Africa Scout Council"

It will be seen that the excess of Income over Expenditure amounts to £358. 10. 0. per annum which in three years would mean /

a total excess of £1075. 10. 0. It would thus be possible to employ an Assistant Secretary for the purpose stated for a period of five years. In other words £900 per annum for three years means a total gross income of £2700, and expended at the rate of £541. 10. 0. per annum, will mean that the gross income will only be expended at the end of the fifth year.

Before the scheme recommended can be finally adopted it will, of course, be necessary to submit it to His Excellency the Chief Scout, South Africa, for his final approval; and when His Excellency's consent has been obtained it is proposed:-

- That the South Africa Scout Council issue circulars to Divisions for distribution among their Scouters inviting applications, and stating-
 - (a) that there is a vacancy for a whole-time Assistant Secretary to the South Africa Scout Council, whose main duty will be to travel and organise the Movement in those Divisional Areas where the Assistant Secretary's help and assistance is asked for.
 - and (b) that it is made quite clear that the appointment cannot be longer than for a period of five years.
- (2) That the basis of contract be one month's notice on either side, and the salary £300 per annum, plus travelling expenses at the rate of 10/- per day when the Assistant Secretary is actually away from Headquarters, plus the cost of the Railway ticket to the centresto be visited.
