### ANNUAL REPORT - 1975

At 31st December, 1971, the Bantu Men's Social Centre Premises in Eloff Street, Johannesburg, were closed in accordance with the Group Areas Act. During the year 1975, therefore, no activities took place.

The Executive Committee of the Centre submitted an appeal through the Johannesburg City Council to the Minister of Bantu Administration and Development for assistance in the establishment of a new Bantu Men's Social Centre in Soweto, but there has been no outcome of the appeal.

The premises in Eloff Street were renovated by the City Council and are let to the West Rand Areas Bantu Administration Board.
