Dear Bishop Napier

The ECC over the past year has witnessed tremendous growth, even though we have had to operate under extremely difficult circumstances. Many of our members have been detained, our meetings banned and the Emergency Regulations continue to place heavy restrictions on our work.

However, one of the major restraints to organisation has been a severe shortage of funds for the campaign expenses. In our budget for 1987 drawn up this time last year, I was fairly conservative in judging our expected expenditure. This was because their was so much unclarity about our future. By June this year it was clear we had grossly underestimated our expenditure. We therefore sent you a copy of an interim application for the final six months of this year. I hope you have been able to respond to that.

With this letter I have also sent you a budget for our work for 1988. As you can see our expected expenditure is far higher than last year, but this is because of our shortcomings in compiling the 1987 application. I have included the following in this application:

- 3. Financial Statements from our Auditor for 1986
- 4. Financial Statement for January to June 1987.

The South African Council of Churches has on many occasions rejected the South African political system which entrenches the control of the country, its resources and its economy and of political decision making by a white minority, as a fundamentally unjust system. It has openly expressed its view that this system cannot be reformed, but that it has to be demolished.

Against this background the SACC has continuously raised the question whether Christians by virtue of their conscience are not bound to reject and resist military conscription and military service in South Africa, as it is used to defend and uphold a fundamentally unjust system and to repress all resistance against it.

Against this background the SACC feels bound to endorse the objectives of the End Conscription Campaign. We have tried to strengthen and support the people involved in this campaign morally and otherwise. On our part we have also been strengthened in our efforts to resist evil in our society and country and to contribute towards a new South Africa, by the great courage and devotion of the people involved in the End Conscription Campaign.
