

Native students are admitted to all courses barring medicine. This exception is based on the regulations governing access to hospitals in which medical students are trained.

(d) University of Natal.

An integral part of this university is that relating to the Non-European Section: courses leading to degrees in the following faculties are provided here: Arts, Commerce, and the Social Sciences; the syllabuses, examinations and staff are the same for Europeans.

Within the next year a Medical School for Natives will be opened under this University. At the moment native students receive this training at the university of the Witwatersrand.

(e) University of S.A. (External Studies).

The number of Bantu students registered is 444. (1950). Although the emphasis is on correspondence courses, these students are nevertheless annually given an opportunity to gather in Pretoria for a month, to attend lectures covering the respective fields and for tutorials. This applies to European and Non-European alike.
