NATIONAL VOLUNTEER CORPS

GENERAL RULES OF DISCIPLINE

OBJECT

The inculcation of a sense of responsibility and discipline in the minds of the individual volunteers.

METHOD AND OBLIGATIONS

To achieve its purpose, it should place on the shoulder of the individuals the responsibility for carrying out certain general obligations. Volunteers are required to obey orders without question, no matter how trivial the order may seem or how much the volunteer may disagree with it. Accept reprimand without any animosity. Always behave in a manner likely to bring credit to his unit or the Corps. In case of conflict of orders the orders of superior authority are to be obeyed. In the absence of an officer, the responsibility shall revolve on the immediate assistant, this responsibility shall reach in turn to the last man. If volunteer fails to carry out the order he will be required to give explanation to an appropriate officer.

Volunteers are required to maintain a high standard of cleanliness both in person and apparel. Volunteers must hold themselves erect and appear alert. The appearance, bearing and conduct of volunteers is important both to the morale and prestige of the corps.

Drunkenness, rowdism and hooliganism are highly prejudicial to the unity, the corps and the cause, therefore the volunteers are required to avoid any semblance of it. Provocation no matter how severe must not be considered justified.

Volunteers when they meet or approach their officers or Congress officials are required to salute in an appropriate manner as a mark of love, respect and discipline.

Volunteers on duty are required to be available at all times during the period of duty.

A volunteer who is believed to have committed a breach of discipline will be dealt with by an appropriate officer.

PENALTIES

Penalties for minor offences will be extra duty. Penalties for major offences will be suspension or expulsion.
