Mr. Owen will tell you (or told you already) that I am trying to gat a "Komasegupober" That means to say that instead of me going for a month on my own cost which will leave me pennyless & will give you nothing I am trying to be sent on important work for a month and will get all my expenses paid. Now you understand that I can not write & tell you this ... can I? The money I will get will come handy to you & me as I am getting on to the last bits of clothes I had. I don't know perhaps I am not doing right. Only I think I am. Mr Owen will have to let me know as soon as permission has been received for me to come.
