Robert Hangalico Cobularo, former leader of the banned Pan-Africanist Congress who is now South Africa's only pricemer without a contence, is applying to the Government for an emit permit to leave the country. He has told his wife to instruct Johannesburg attorneys to make a formal application for a permit.

I learned this during an interview with Hr. Sobulawe on Hobbon island the maximum security prices seven miles from Cape Town which has been his home for the past mino months.

Hr. Robular completed a three year sontence for incitement, arising out of the 1960 PAC anti-pace compaign, in May last year. Since then he has been hept in prison without any further trial in terms of a special provision of the General Law Accordant Act.

He is the only person jailed in this way.

PAG loadors oversees have continually alleged in public statements that Wr. Sobulars is being starved and bequai. I found this to be completely untrue and it was also repulsated by Wr. Sobulars himself.

He has regained much of the weight which he lost during his three year jail sentence. Apart from rhoundtie-type pains, which he attributes to his lengthy opell in jail, his health his good.

During the hours we spent together, without any prison warders being precent, he was rolaxed and spoke freely and easily.

In granting permission for Nr. Nobulate's interview, the Minister of Justice, Nr. Verster, impose only one restriction: that Nr. Sobulate's views on the law under which he is jailed not be sought.

During our interview, Mr. Sobulate:

- Sophatically denied that he was anti-shite.

- Gaid he had not been involved in last year's Poge terrorist movement.

- Prodicted that changes were imminent in South Africa which would enable Whitegand non-Whites to achieve "broader Agroement".

By order of the Minister of Justice, Mr. Sobulate enjoys privileges which make him the country's No. 1 prisoner. Although I was not allowed to visit his quarters, and interviewed him in the visitor's room, this is the description of Mr. Sobulate's conditions which he gave me mo:

He occupies a neathy-furnished two-roomed bungalow - formerly part of a Coloured school - oot inside an onelesure Statio ft by 170 ft. which is surrounded by a barbod-wire fonce.

There is het and cold running water and a shower in a separate ablution block.

He can receive and write two letters a weak and is even able to sent telegreme. A wide range and number of books, magazines and newspapers is allowed.

His time is entirely his can. He can get up and go to bed when he pleases and can keep on the lights as late as he wishes.

His moals are of a botter quality then normally supplied to African prisoners. Scentimes, his meals are supplied from the white warders' moss. Howcan spend up to BiO a month buying entra food and other goods.

He wears his own clothing.

He has a radio - a modium - wave min sot, as he is only allowed to listen to the S.A.S.C.

He spends most of the time reading and studying for the Bachelor of Economics degree which he is doing through the University of London.

"All the prices official chew me every consideration," Wr. Sobulate told me. "They go out of their way to make my stay here as bearable as possible.

"But the fact remains that this is a prison.

The I see no prospect for my release, I have told my wife to instruct attorneys to apply for an axit permit for myself and my family.

"I am doing this for the sale of my wife and our four childron. I want to give them the chance of living a full family life.

"Also, I cannot protend that I reliah the idea of being fessilised on Bobbon Teland. I want to use thatever talent I have usefully and creatively for the benefit and advancement of manking?.

He added: "I finished three years in jail for whatever I had done. I served my contence. Straight from there I was moved to prison procincts and made subject to prison regulations with the exceptions which the Minister of Justice has allowed.

"The consideration which the prison officials are showing no is not anything I can claim as of right. Guards are on duty where I live 24 hours a day. And I an affected by being in the presence of other prisoners, oven though I only see them from a distance. I cannot but compare my situation with theirs.

"I am allowed newspapers and a certain mumber of lotters. But as a result, I am in contact with the world while at the same time I am detached from it. This leaves no uncettled and frustrated.

"I an virtually in colitary confinement, as the only people I see, apart from a very for visitors, are the warders."

I acked Nr. Cobulato about reports Linking his name with last year's Poge Kovement.

He said: "I was behind bars in Protoria jail when it happened, and when I was allowed contact with the world again the immediate causes of it were over. So I do not know what gave wise to it.

"I was not involved in the Pogo neverant in any way at all."

On his attitude towards whites, he said: "I know I have been accused of being anti-white, not only by the Boverment but also by others. But there is not one the can quiete any statement of mine which bears this out.

"Then I say Africa for the Africans' I have always made clear that by "African' I mean these, of any colour, the accept Africa as their home. Colour does not mean anything to me."

and on the South Africa situation he said that he thought there were prospects for change in the near future.

"The fact that these who are opposed to apartheid are taking up an uncompromising attitude means that the issues will be highlighted. Boths the economic development in the country and the intellectual stirrings, particularly among Afrikaners, will bring about an initial medification of attitudes. Once that is achieved it will be easier to reach a breader agreement.

"I think the Covernment is quite aware of this and that is thy it is trying to prevent not only contact across the colour line but also the free circulation of ideas."
