It is clear that the National Party will propose legislation in this current parliamentary session to deal with the criticisms that ourselves and other organisations have made against the system of conscription. Dear Karl,

A copy of your letter to Paula at Lawyers for Human Rights has been sent to us, with a request that ECC give you an update on the present situation with regard to conscription. Paula assures me that the technicalities of applying for indemnity will be dealt with by the UN and that she will see that they get the necessary information.

With regard to your return, you will still be liable for callup under the Defence Act, which has not changed much since you left (except for the 1983 Amendment which made provision for some sort of civilian service for Religious Pacifists and increased the penalties for all other COs).

But the 64-million dollar question now is: is the call-up of white males still legal in the light of the repeal of the Population Registration Act in June last year? ECC says no, and has legal opinion to support this view, but the call-up continues, and the ideal thing would be a test case in court. The state appears to have been sidestepping the issue by not prosecuting objectors. The last people to have been charged were Alan Storey (refused national service in January 1991) and Wally Rontsch (refused a Dad's Army camp), but they never stood trial as the Attorney General withdrew the charges.

At least two of the group of COSAWR exiles who returned to this country in December 1990 have since received call-up papers, and both refused to serve, quite publicly - Francois Krige in January 91 and Fritz Joubert in July 91. Neither has been charged, and both are feeling thoroughly frustrated by the lack of reaction.

Ever since July, both ECC and the Conscription Advice Services have had to deal with a lot of queries from confused conscripts, both National service conscripts and campers. The message of the possible illegality of the call-up has got through, and many people are choosing to "vote with their feet" by simply failing to report. The situation became even more confused last month, when just after the new National service intake the Deputy Minister of Defence, Wynand Breytenbach blandly admitted that people who had not reported would not be prosecuted since there was the possibility of some change of legislation in the pipeline. This led to a lot of media publicity in which the Minister and his Deputy appeared to be contradicting each other, and generally increasing the confusion over the issue. In practice it seems that while a few people are being charged with "Failure to Report", there is still no follow-up on those who refuse to serve.

I enclose a few recent press-clips and ECC's latest pamphlet which has been widely distributed. Good luck and keep in touch. Man free Nan Cross. National worker.


