- 2) Contest all call-ups at all levels through the courts. Despite the verdict in the Pretoria court in support of rascist conscription, we do not know that all judges would uphold this ruling. Those that do rule in favour of a whites only call-up can then be added to a list of people who need to be prosecuted for enforcing apartheid (see below). In every case, call specialist evidence alleging SADF crimes, brutality, racism etc. This will be extremely embarrassing for the SADF. Recent exposure of SADF covert operations greatly strengthen our stand in this regard.

- 4) Compile a list of individuals implementing whites only conscription (e.g. Minister of Defence, Chief of SADF, individual officers signing call-ups etc.). We should then demand that these individuals be held accountable for continuing with apartheid (a UN defined crime against humanity) after its official scrapping in SA (scrapping of Population Registration taken as official scrapping in SA).

If I am going to be involved in such an undertaking then I believe that I should be in South Africa where my presence can demonstrate my readiness to deal with the consequences.

I feel strongly that prosecutions under the call-up laws must be suspended.



I will be watching carefully to see if John Downie or John Kelly are indeed prosecuted in this matter.

I have three sons all of whom were happy to do their duty to the country they are living in. None of them were born here. The situation being what it is - enough is enough! I have been dealing with sons going to camps for 15 years. I consider the situation ludicrous!
