ADDITIONAL STATEMENT

BY: COUNCILLOR A.W.G.CHAMPION.

- 1. In my capacity as Member of the Native Representative Council I received a circular letter from the Chief Native Commissioner drawing my attention to No.2 of the terms of reference.
- 2. I want to raise the point of legal representation by Natives both as bus owners or as passengers who suffer a great deal because bus transportation is not sufficient for Natives.
- 3. The Department for Native Affairs who represent us should have provided us with legal representation. If not able, the Department should have advised us to do so on our own.
- 4. As it is now, the Native case will be poorly placed before the Commission by people who have never had the opportunity to meet.
- 5. In applying for a Certificate of transport, a Native must prove that he resides in the Area. He must have the support of the Native Commissioner.
- 6. Generally, Natives who have money are not welcome by the Native Commissioners in Natal. It is, therefore, difficult for them to carry with them the support they require.
- 7. I want to state that if Segregation is to be supported by the Natives of this land, it must not be one-sided.

 Trading in Native Areas must be reserved for the Natives, and in Non-Native Areas for Non-Natives.
- 8. The Urban (Natives) Areas Act with Native Law Amendment Act of 1937, provides for that against the Natives, but not against other than Natives.
- 9. The dice is loaded against the Natives. I quote the ownership of Beer Halls and the right to trade in the Urban Areas by Natives.
- 10. In order that the Natives should get satisfaction with the policy of our Union Government in trade, they must own business rights exclusively: In commerce and transportation:
