According to our records 28 ECC activists have been detained of whom 15 are still being held.

We also know of over 30 members of our member organisations (eg Jodac, Nusas, black Sash, PFP Youth, WP Council of Churches) who have been detaned. Some have been released and some are still being held. Several of those released were questioned about ECC - some of them having been involved with ECC in the past.

All of the ECC activists who have been released were interrogated about ECC. At least two of the ECC members detained (Jaqui Boulle and Michael Evans) have been interrogated by Military Intelligence as well as by the security police. Another Durban ECC activist, Rowena Allison-Brunehead, was questioned by Military intelligence and asked to make a statement, but not detained. Several of those detaiend were asked to make statements in the course of their interrogation.

Of those detained some have been held in solitary confinement while others have been allowed access to their fellow detainees.

The houses and offices of at least 50 of our members have been raided by the security police, riot police, and SADF. In at least two cases teargas was thrown into the flats of our members. Our offices in Johannesburg and Cape Town have been raided and documents have been confiscated. At least 20 ECC members (other than those detained) have been questioned by the security police. About 30 ECC activists are in "hiding" to avoid being detained. One of our newer members, Steven Boyd, 19, a member of the Johannesburg ECC Education group, was twice questioned by the security police. On one occassion, in the ECC office, he was assaulted by one of the security policemen. He was pushed around and butted in the face while being questioned.

The office of our Port elizabeth Chairperson, Janet Cherry, has been raided on three occasions. After the last raid everything in the office other than the furniture disappeared.

Neighbours of at least two of the Johannesburg ECC members have been approached by the security police to assist in spying on them.

In most of the regions our members have reported a spate of tyre slashings and other acts of vandalism over the last month.
