Dear Howard

I enclose a cheque for 24 pounds for 3 subscriptions to WRI news. Your invoice no. is 4289.

I also enclose a voucher from my plane ticket in case you need this as substantiation for the amount spent. The amount was R4140.

I do hope that you are well. I received a letter from Ali yesterday and he said that you had gone off to Israel over Christmas, which must have been very exciting.

All is well this end. I will be writing a fuller update shortly but at the moment things are in such flux that an update would soon become outdated. COSG is considering merging with the grouping around the 771 and there has been lots of discussion about a new anti-conscription movement. Now however with the reduction in service liability, a new conscription group does not seem that appropriate and what is really needed is a strong campaign for the release of jailed objectors. The recent reductions have not been made applicable to jailed CO's - either those already inside or those still awaiting trial. Doug Torr has heard he is being charged so he still faces 6 years, as does Brendan Moran who will be refusing in February. Mike Graf has refused a camp and is being charged as are two other campers. Ivan and David's appeal is being heard on the 27 February and Ivan is still considering a hunger fast if he is sent back to jail and is not given political prisoner status. He received a death threat yesterday which he has reported to the police. He was particularly concerned about it because they phoned him at home and he has an unlisted number.

Please give my love to Chris and Veronica. I hope you all had a good Christmas and New Year. I will keep in touch.

Dear Heidi,

Many thanks for your letter enquiring about COSG. I enclose our most recent edition of Objector, as well as a fact sheet on the Johannesburg branch of COSG. I also enclose a card sent out by ourselves in December, calling for Charles' release. The card was sent to MP's and other influential people.

In addition to the three objectors currently in jail, there are 5 men who will probably be charged for failure to serve, in the next two months. One of them Doug Torr is an Anglican priest, and he faces a possible 6 year sentence. In addition, Ivan Toms' appeal is being heard at the end of February so he faces the prospect of having to return to jail.

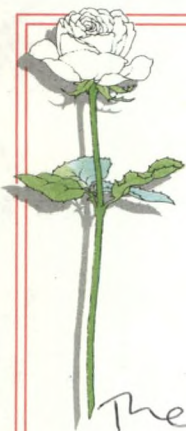
So as you can gather there is going to be an enormous amount of support work to do over the next few months. COSG will be campaigning for the release of objectors and at the very least will be demanding that the reductions made to national service should also be made applicable to jailed objectors.

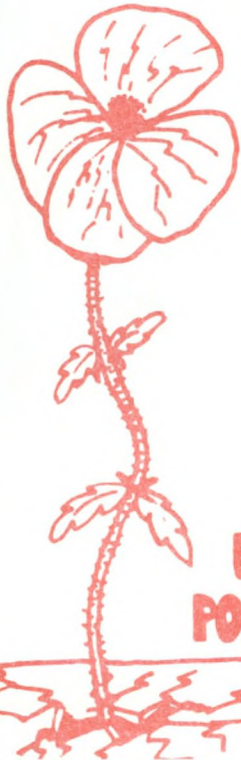
