RESOLUTIONS TAKEN BY THE NATIONAL EXECUTIVE COMMITTEE OF THE UNITED DEMOCRATIC FRONT ON SUNDAY THE 1ST OF JULY 1984.

1. That the UDF bring an urgent application to the Supreme Court of South Africa for the following relief:-
 - (a) that the South African Police as represented by the Minister of Law and Order and/or the Commissioner of Police be interdicted and restrained from unlawfully harassing and interfering with the UDF and its agents, employees, officers and any other persons assisting the UDF in the execution of its Million Signature Campaign.
 - (b) that the South African Police be interdicted and restrained from invading the privacy of the UDF and the persons identified in (a) above in their execution of the campaign afore-said.
 - (c) that the South African Police be ordered forthwith to restore to the possession of the UDF all documents and petitions belonging to the UDF, concerning the campaign aforesaid, and which have been unlawfully seized, and which are presently in the custody of the South African Police.
 - (d) that the respondents be ordered to pay the costs of this application on an attorney and client scale.
2. That Mr Popo Molefe is authorised to sign all necessary documents to enable the application to be brought, and is furthermore authorised to permit any individual to be joint with the UDF as co-applicant/s.


