My dear Mr. Boss.

I received your letter of some days ago; but have not been able to reply to it until now.

I have, however, already taken certain action concerning it. and sounded certain opinions about it, with a view of find out from certain guarters what candidates are likely to be on the field for the seat.

I would also have been much clearer in the attitude to take, if I had known, even confidentially, the people who had approached you; because the Transkein seat, as the method of election is constituted under the Act, depends greatly upon members of the Bhunga and many of them under the influence of certain magisizates.

Besides, I have heard it rumoured that Dr. A. Kerr, Principal of Fort Hare, was maneuvering for the position for one of the seats and he would be a difficult candidate to come up against, as he would have the full support of all the magistrates, and, perhaps, of many of the Bhunga members.

I am hoping to see Mr. Qamata at Cape Nown within ten days and am also communicating with the Editor of the "Thetunywa" published at Umtata, and I may also communicate with Mr. Tennyson Makiwana who does a great deal of lowring at the Bhunga.

I am inclined to support you for the seat, and, I believe I could do a whole lot, if I could have had personal contact with many of the Councillors, and still have influence in the area as a some of the soil; but there is the question of expense and leaving my practice and the inconvenience of travelling under petrol rations. ## re: PIMVILLE COLLISION

I attended the enquiry this morning and found that same had been adjourned until the 2nd March. There was no reason given for the adjournment, but we understand that certain of the railway men refused to give evidence until after the criminal case against the guard and the driver had been completed and also because the members of the enquiry felt that their terms of reference were not broad enough to include an investigation of the general relationship between the natives who used the train and the railway employees.

I personally feel that not much good can be done by pursuing the question of the enquiry any further as in the criminal proceedings (preparatory examination) against the driver and the guard it was clearly established that there had been negligence on the part of the railway servants. This means therefore, that the railway administration is responsible for all damages suffered by the families of the deceased and by those injured, and that this damage must be on a common law basis and not on the basis of the Workmens Compensation Act, which as you know lays down a tariff for death and incapacity, which is a blot, among the many other blots, on our statute books.

I understand that Mr. Brink, the Native Commissioner, has been asked by the Native Affairs Department to draw up a scale of compensation and that he has drawn up such a scale. I do not know the details of this scale, but I have spoken to Miss Heymann, who assures me that the Legal Aid Bureau will press for adequate Dr. A. B. Xuma, JOHANNESBURG.

compensation on a common daw basis.

I think that the most that the Congress can do at the present stage is to issue a public warning to the relatives and to those injured in this collision to the effect that they are not to accept any compensation and that they are not to sign any documents until the Legal Aid Bureau or their own lawyer has approved of the amount of compensation.

There seems to me nothing more to be done at the present moment although I do think that this disaster presents the Congress with an opportunity to press for a proper enquiry regarding the treatment of natives on trains, trams and buses and it also presents the Congress with an opportunity to press the government and the bigger municipalities to employ natives as at least conductors and ticket examiners on those services patronised wholly by natives.
