#### THE UNION FESTIVAL

The Peri-Urban Areas Health Board's decision, mentioned in the February issue of the Bulletin, to arrange a programme for Alexandra residents in connection with the Union Festival, has turned out to be opportune.

Starting with the schools, in collaboration with the Alexandra Board of Bantu School Principals and the District Inspectorate, the Board donated £93 worth of equipment for the Schools Sports Competitions, the finals of which were held at the Sports Stadium, No. 2 Square, Alexandra, on Wednesday, 16th March, 1960. All fourteen Bantu Community Schools took part in the 35 events for 104 prizes, consisting of silver-plated trophies all engraved "Uniefees, Alexandra 1960".

The number of competitors totalled 420.

Besides the 165 teachers and 15 officials in attendance, the competitions were witnessed by over 8,000 spectators.

The finals of the Music competitions took place at the Holy Cross School, Alexandra on Tuesday, 22nd March, 1960. Here again the local community schools all took part, as well as the Holy Cross Higher and Lower Primary Schools and the Witkoppen Farm School for the 16 trophies donated by the Board.

At a grand function held at the Sports Stadium on Wednesday, 23rd March, 1960, prizes were presented by the Chairman of the Board, Mr. P. A. Stoffberg, M.P.C. and by Mr. Oelschig on behalf of the Chief Bantu Affairs Commissioner, Mr. Smuts.

# Floating Trophies, Shields:

Sports trophies were presented by Mr. A. S. Bosman, Inspector of Bantu Education, Johannesburg East and Music trophies and Bronze diplomas by Mr. K. B. Hartshorne, Inspector of Bantu Education, Rand Central Circuit. Also on the plat-form were the District Commandant, S.A. Police, Bramley, the Bantu Affairs Commissioner, Alexandra, Mr. A. H. J. Els, who in the course of his opening remarks mentioned that sweets and cold drinks would be handed out at all local schools on Thurs-day, 7th April, 1960. Altogether 30,000 children would be provided for, so as to include those not yet of school-going age and those at creches and kindergartens. age and those at creches and kindergartens.

Also present were Mr. C. H. Kotze, Manager of the Board's Bantu Administration Department, Mr. J. H. Swart, Administrative Assistant for Alexandra, Mr. P. J. Badenhorst of P.U.T.C.O., the Chief Inspector, Mr. du Toit, members of the Board's Bantu Administration Inspectorate, members of the S.A. Police, Wynberg and Mna. M. Katane, who moved a vote of thanks to the Board, P.U.T.C.O., teachers, children and residents on behalf of the Chairman, Alexandra School Board. Many residents, including elergymen, were among the big audience. The opening prayer was delivered by Rev. Tekane of the A.M.E. Church.

In his address the Chairman of the Board, Mr. Stoffberg, mentioned the improvements effected in Alexandra since the Board took over, and indicated that more improvements were still to come. He expressed disappointment however, in regard to the unsightly appearance of the streets which were littered with refuse. To combat this undesirable and unhealthy state of affairs, he would approach his Board to offer prizes in the form of oxen to be slaughtered for the residents whose street or avenue wis, in the opinion of Mr. Kotze, the Board's Welfare Officer, the cleanest in the Township. For the best kept avenue, the prize would be one ox and for the best kept street, two oxen The period of time during which observations would be made by Mr. Kotze would depend on the circumstances.

The presentation of trophies function was the highlight of a busy and interesting month of hard work by the Alexandra Union Festival Committee, officials, teachers and children and the Bulletin congratulates all concerned.

# BANTU ADULT PARTICIPATION

Copies of the relevant entry form are obtainable at all. Alexandra Bantu and private schools and at Entokozweni, No. 3 Square, Alexandra.

The culmination of the Bantu Adult programme will be marked by a public function at the Stadium, No. 2 Square, Alexandra, when five oxen will be slaughtered, for a "vleisbraai" in accordance with customary Bantu ceremony.

The Festival Committee has decided to sell the five ox skins and to allocate the proceeds to such schools as may be decided upon for schoolfunds.

Altogether, the Board is spending about £2,000 (two thousand pounds) for the festival celebrations to provide equipment, trophies, refreshments, meat, sweets and transport for school children to the various district competitions in Johannesburg and Orlando.

A programme has also been drawn up for the local Coloured community.

# DIE UNIEFEES.

Die Raad se besluit soos gemeld in die Februarie uitgawe van die Bulletin, naamlik om 'n Uniefeesprogram te reël vir die inwoners van Alexandra, het uiters tydig geblyk te wees.

Om met die skole te begin, het die Alexandrase Raad van Bantoeskool Prinsipale in samewerking met die Distriksinspektoraat 'n skoolsport gereël, terwyl die Raad £93 se waarde aan 104 pryse vir die doel geskenk het. Die pryse het bestaan uit trofees en ander geskenke. Die trofees was voorsien van silwerbeslag met die woorde "Uniefees Alexandra 1960" daarop uitgegraveer.

Die finale byeenkoms was gereël vir 16 Maart 1960 en die 14 Bantoegemeenskapskole het almal aan die verskillende kompetisies deelgeneem. Vierhonderd-en-twintig mededingers het aan die byeenkoms deelgeneem. Behalwe die 165 onderwysers en 15 baanbeamptes het 8,000 toeskouers die verrigtinge bygewoon.

In die finale musiekkompetisies wat op Dinsdag, 22 Maart 1960 plaasgevind het, het al die Gemeenskapskole, die Hoër en Laer Holy Cross Skool sowel as die Witkoppen Plaasskool, deelgeneem. Die verrigtinge het op die terrein van die Holy Cross Skool plaasgevind, en vir hierdie afdeling het die Raad 16 trofees as pryse beskikbaar gestel.

Pryse is deur die Voorsitter van die Raad, mnr. P. A. Stoffberg, L.P.R. en mnr. Oelschig wat die Hoofbantoesakekommissaris, mnr. Smuts, verteenwoordig het, by die Sport Stadion te Alexandra op 23 Maart oorhandig. Mnr. A. S. Bosman, Inspekteur van Bantoe-Onderwys van Johannesburg-Oos, het die sport trofees oorhandig, terwyl mnr. K. B. Hartshorne, Inspekteur van Bantoe-Onderwys van Sentraal-Rand, die musiektrofees oorhandig het. Op die verhoog was ook teenwoordig die Offisier in Bevel S.A. Polisie, Bramley-distrik, die Bantoesakekommissaris van Alexandra, mnr. A. H. J. Els, mnr. C. H. Kotze, Bestuurder van die Afdeling Bantoe-administrasie van die Raad, mnr. J. H. Swart, Administratiewe Assistent, Alexandra, mnr. P. J. Badenhorst van P.U.T.C.O. en Inspekteur P. J. du Toit van die Veiligheidsafdeling te Alexandra.

Eerwaarde Tekane van die A.M.E. Kerk het die verrigtinge met 'n gebed geopen, terwyl geestelike leiers van alle kerke in die gehoor teenwoordig was.

Mnr. Els het gedurende sy openingstoespraak melding gemaak dat daar op 7 April, lekkers en koeldranke aan 30,000 kinders van alle ouderdomme uitgedeel sal word.

Mnr. Stoffberg, L.P.R. het in sy toespraak onder andere die verbeteringe genoem wat die Raad reeds aangebring het sedert die oorname van Alexandra, en het verder dit in die vooruitsig gestel dat nog meer verbeteringe en geriewe beoog word. Mnr. Stoffberg het ook sy spyt uitgespreek oor die swak toestande van die strate - vuillis lê ooral versprei en dit is op sigself 'n groot gevaar vir die gesondheid van almal Om hierdie euwel op te los het spreker belowe om by die Raad aan te beveel dat pryse aangebied word vir die skoonste laan en straat; die pryse sal wees, twee slagosse vir die skoonste straat en een slagos vir die skoonste laan. Mnr. G. D. Kotze Welsynsbeampte, sou in hierdie geval die beoordelaar wees. Die oorhandiging van die trofees was die hoogtepunt van die dag en ook die afsluiting van 'n besige en interessante maand vir die Alexandra Uniefeeskomitee. Die Bulletin wil hiermee almal wat in alles gedeel het bedank en gelukwens.

# NATIVE LABOUR REGULATIONS

(Government Notice No. 63 dated 9th January, 1959)

Published in terms of Section twenty-three, sub-section 1 of Act No. 15 of 1911 as amended.

Of the ten chapters of the Native Labour Regulations mentioned above, Chapter V, <u>Establishment of Labour Bureaux</u>, is reproduced for the information of Alexandra residents and employers of labour, viz:-

- 1. (1) A district labour bureau is hereby established
  - (a) in the office of every Native Commissioner;
  - (b) in the office of every Magistrate, detached Additional or 'Assistant Magistrate, and Special Justice of the Peace, provided there is no office of a Native Commissioner at the same centre.

(The District Labour Bureau for Alexandra is at the office of the Bantu Affairs Commissioner, Wynberg.)

- (2) Every district labour bureau is established in respect of the area of jurisdiction of the Native Commissioner, Magistrate, detached Additional or Assistant Magistrate or Special Justice of the Peace in whose office such labour bureau is established, but excluding -
  - (a) any area falling under the jurisdiction of a local labour bureau conducted by a local authority; and
  - (b) (i) in respect of a district labour bureau at a Native Commissioner's office, any area falling within the area of jurisdiction of any other district labour bureau, and
    - (ii) in respect of a district labour bureau at a Magistrate's office any area falling within the area of jurisdiction of a detached additional or Assistant Magistrate or Special Justice of the Peace.

2/ ....

(3) A local labour bureau is hereby established in respect of every prescribed area. The Minister may by notice in the Gazette, after consultation with a local authority, assign the powers and duties connected with the conduct and control of a local labour bureau to such local authority; provided that where a prescribed area means an area proclaimed under section twenty-three of the Natives (Urban Areas) Consolidation Act, 1945 (Act No. 25 of 1945) the local authority shall exercise jurisdiction only in respect of the area in which the local authority exercises any of the powers referred to in sub-section (1) of the said section twenty-three.

(Alexandra is a prescribed area in terms of section twentythree of the Natives (Urban Areas) Consolidation Act, 1945 and the Minister (of Bantu Administration and Development) has by Government Notice No. 324 dated 28th February, 1958 assigned the powers and duties connected with the conduct and control of a local labour bureau to the Peri-Urban Areas Health Board which is the local authority for Alexandra as well as the adjoining area of North Johannesburg.)

(4) A regional labour bureau is hereby established in the office of each Chief Native Commissioner for his area of jurisdiction.

(The Regional Labour Bureau for this area is in Johannesburg.)

- (5) A Central Labour Bureau is hereby established in the office of the Director (of Native Labour).
- 2. (1) Every district or local employment officer shall -
  - (a) control and conduct his labour bureau in terms of these regulations and any instructions received from time to time from the Central or Regional Labour Bureau;
  - (b) maintain such records and registers and furnish such returns and information as might be required from time to time by the Director;
  - (c) cc-operate with other employment officers, employers and recognised bodies to ensure the efficient functioning of the labour bureau.
  - (2) Any officer duly authorised by the Director may inspect any labour bureau or depot.

# PRESCRIBED AREAS.

(Regulations 3 to 5 "NON-PRESCRIBED AREAS" omitted.)

6. (1) No person shall engage a Native for employment in a prescribed area, who is not registered with the local employment officer of the area in terms of regulation 9 of this Chapter.

- (2) Every person who takes into his service a Native for empleyment in a prescribed area shall -
  - (a) endorse his full names and address, and the date of engagement in such Native's reference bock; and
  - (b) complete a notification substantially in the form (prescribed) and coliver or post it within three days to the local employment officer of the area in which the Native is employed together with the prescribed fee.
- (3) In the event of the death, discharge, desertion cr other cessation of the employment of a Native the employer shall -
  - (a) on the production to him of the reference book issued to such Native record such termination and the date thereof in such reference book; and
  - (b) notify the local employment officer within three days after such death, discharge, desertion or cessation of employment on a notification substantially in the form (prescribed).

7. Every person who employes Native labour in a prescribed area shall report to the local employment officer within three days on a document substantially in the form (prescribed) any vacancies which exist in his service.

8. A local authority may charge a fee of two shillings and sixpence in respect of every Native engaged for employment in a prescribed area. Such fee shall be payable by the person who engages such Native.

- 9. (1) Every male Native who is unemployed or not lawfully employed, who is over the age of 15 years and who is not a full-time pupil or student at an educational institution shall within three days after becoming unemployed or 15 years of age or within fourteen days after ceasing to be a pupil or student, report to the local employment officer and shall satisfy such officer as to his identity, that he is unemployed and as to the types of employment for which he is suitable or eligible, and furnish such further information as may be required.
  - (2) The local employment officer shall register a Native who qualifies for registration in the prescribed area in terms of regulation 10(1) of this Chapter or a Native whose application to be so registered is approved in terms of regulation 10(2) of this Chapter, and shall in respect of every Native so registered -
    - (a) complete a document substantially in the form (prescribed);
    - (b) communicate to the Native vacancies of a type

for which he is suitable or eligible and which are recorded with him in terms of regulation 7 of this Chapter; and

(c) place the Native in employment; or

(d) direct such Native to a depot; or

- (e) if the Native fails or refuses to accept employment in any of the vacancies offered and qualifies to remain in the prescribed area in terms of caragraph (a), (b) or (c) of sub-section (1) of section ten of the Natives (Urban Areas) Consolidation Act, 1945, (No. 25 of 1945) issue to such Native a card substantially in the form (prescribed) or if such Native is in possession of a reference book make a suitable endorsement in such reference book and instruct him to report again on the date to be endorsed on such card or in such reference book being not more than fourteen days from the date of issue or endorsement, if he has failed to find employment; or
- (f) if the Native fails or refuses to accept employment in any of the vacancies offered and does not qualify to remain in the prescribed area in terms of paragraph (a),
  (b) or (c) of sub-section (1) of section ten of the Natives (Urban Areas) Consolidation Act 1945 (Act No. 25 of 1945) cancel his registration and refer him to his district employment officer for registration in the non-prescribed area.
- (3) Should a Native to whom a card has been issued, or whose reference book has been endorsed in terms of paragraph (e) of sub-regulation (2) fail or refuse to enter into employment during the period of validity of the said card or endorsement the local employment officer shall -
  - (a) communicate to the Native vacancies of a type for which he is suitable or eligible; and
    - (b) place the Native in employment; or
  - (c) direct such Native to a depot; or
  - (d) extend the validity of the card or cf the endorsement in the reference book for a period which shall not be more than fourteen days from the date of registration.
- (4) If a Native mentioned in sub-regulation (3) has not accepted employment at the expiration of the period of validity of the card or the endorsement in the reference book and any extension granted in terms of sub-regulation (3)(d), the local employment officer shall enquire into the reasons for his failing or refusing to accept employment, and shall -

- (a) if suitable work is available in the prescribed area, and if the Native refuses without reasonable cause to accept such work, causo such Native to be dealt with in terms of section twenty-nine of the Natives (Urban Areas) Consolidation Act, 1945, (No. 25 of 1945);
- (b) if suitable work is not available in the prescribed area communicate to the Native Vacancies in any other area which have been reported to such lical employment officer. If the Native refuses to accept such work, the validity of his card or of the endorsement in his reference book shall be extended for a further period not exceeding fourteen days. Should the Native at the expiration of such further period be still unemployed and still refuses to accept employment in any other area, he shall be dealt with in terms of paragraph (a) of this sub-regulation; or
- (c) if the Native is unable to find or accept employment for some reasonable cause, deal with him in terms of instructions from the regional labour bureau.
- 10. (1) The local employment officer shall register a Native who -
  - (a) is entitled in terms of paragraph (a), (b) or (c) of sub-section (l) of section 10 of the Native (Urban Areas) Consolidation Act 1945 (No. 25 of 1945) to remain in the prescribed area;
  - (b) is authorised by the regional labour bureau in terms of these regulations to proceed to employment in the prescribed area; or
  - (c) makes application in terms of and in accordance with the provisions of regulation 12 of this Chapter to re-enter the prescribed area after an absence therefrom of not more than twelve months for the purpose of taking up employment with the employer by whom and the class of work in which such Native was last employed before leaving such area, unless such Native was originally permitted to be in such area for a specific period.
  - (2) The local employment officer may register a Native who is not mentioned in sub-regulation (1) of this regulation, if the Native was legally employed in the presoribed area up to the time he became unemployed, and complied with the provisions of regulation 9 of this Chapter, and if there is registered with the local employment officer vacancies in the class of work for which the Native qualifies, provided that the registration shall be conditional upon the Native accepting employment in the class of work in which he was employed with the permission of the local employment officer given in terms of these regulations at the time he became unemployed or in some other

class of work approved by the regional labour bureau. Should there be no vacancy for which such a Native qualifies or which is acceptable to him he may be registered for a period not exceeding seven days subject to him residing in a depot or, if no depot is provided or if there is no accommodation in the depot, and provided alternative approved accommodation is available, to his reporting to the local employment officer every working day until he is placed in employment or his registration in the prescribed area is withdrawn.

11. The local employment officer may place with the district employment officer a requisition to fill any vacancy and the district employment officer shall dispose of such requisition in accordance with instructions received from the central or regional labour bureau.

- 12. (1) A Native male who desires to enter or re-enter a prescribed area with the intention to take up employment therein should apply for permission to the labour bureau where he is registered or ought to be registered in terms of regulation 5 or 9 of this Chapter.
  - (2) A Native female who desires to enter a prescribed area or to remain therein with the intention to take up employment there, should apply for permission to the employment officer of the area where she normally resides.
- 13. A Native -
  - (a) who has failed to comply with the provisions of regulation 9 of this Chapter;
  - (b) whose application for registration in terms of the said regulation 9 is refused or whose registration has lapsed without him having been placed in employment by the local labour bureau; or
  - (c) who has not obtained permission in terms of regulation 12 of this Chapter to enter the prescribed area or to remain therein

may not take up or seek employment in a prescribed area. If such a Native is a workseeker and has no right to remain in the area in terms of paragraph (a), (b) or (c) of sub-section (1) of section ten of the Natives (Urban Areas) Consolidation Act, 1945 (No. 25 of 1945) he may not enter the area with the intention to take up or seek employment therein."

The Chapter quoted above should be studied in conjunction with the sections of the Natives (Urban Areas) Consolidation Act 1945 (No. 25 of 1945) as amended, published in the May and June issues of the Bulletin.

The texts and extracts of the Acts and regulations hitherto reproduced in the Bulletin will, it is hoped, help residents, workseekers, employers of labour and others to understand what the law requires of them and to act accordingly.

# BURSARIES FOR STUDENTS AND SCHOLARS.

The Board has approved the grant of the following three bursaries for Alexandra Bantu students and scholars tenable for three years at approved institutions:

Standards 6 to 8 one bursary of £40 per annum. Standards 9 to 10 one bursary of £60 per annum. Degree one bursary of £120 per annum.

The Principal of the Alexandra Secondary School has received the sum of £45 (forty five pounds) from Mr. T. H. It is understood that depending on the results achieved by the students concerned, the grants may be renewed in future. Although Alexandra is mainly populated by Bantu, it has since its proclamation as a non-white residential area 48 years ago, always had a substantial group of progressive Coloureds who have shared in its development and growth, a factor which has contributed materially to the healthy relations existing between members of this community and the Bantu section of the population.

NEL. LIBRAR

Of the Coloured residents of Alexandra few, if any, can equal the sterling services rendered by the late Mr. Douglas Thomas Richard Nel, during the thirty five years which ended with his tragic death in July 1958, to the people of the Township.

Following on his appointment as a teacher at the Alexandra Government Coloured School in 1923, Mr. Nel took a keen interest in the public affairs of the community as a result of which he was elected representative of the Coloured ratepayers on the Alexandra Health Committee in 1936, a position he held with distinction until that body was disestablished in 1958.

An unassuming personality of cheerful disposition, Mr. Nel enjoyed the respect and confidence of all sections of the community he served so selflessly and with singular devotion, for a generation and more, in various spheres.

During his lengthy term of office as a member of the Health Committee Mr. Nel served, inter alia, on the Board of the Alexandra Health Centre and University Clinic, was responsible in great measure for that indispensable amenity, the Wilk Depot, which he officially opened on the 10th December, 1949, and took a leading part in the preliminary and final stages of the negotiations which led to the Bantu Welfare Trust donating the handsome Sports Stadium at No. 2 Square. He led and served on many deputations and bodies entrusted with weighty matters of public welfare and development and, with Mr. Dan. W. B. Gumede, was die first non-white to be appointed a Commissioner of Oaths for Alexandra.

Characteristic of his versatile endowments was the distinction he achieved in representing Transvaal, Rhodesia and the Eastern Province in Coloured Provincial Rugby in his younger days.

The Bulletin wishes to add its humble contribution to the many tributes paid to this outstanding member of our community who without fear or favour, unswerving loyalty and singleness of purpose did so much for his fellows for the greater part of his life.

A tombstone erected to his memory by members of his family was unveiled at the Newclare Cemetery on Sunday, 4th September, 1960.

# ADDITIONAL GENERAL TAX.

In terms of Government Notice No. 1863 dated 13th November, 1959, all Bantu men and women earning more than £180 per year (that is, more than £15 a month) from whatever sources, i.e. employment, business, trade, occupation, rents, pensions, dividents etc. are required to render returns of such income on prescribed forms obtainable from the office of your nearest Bantu Affairs Commissioner for determination of taxable income.

Additional General Tax is payable as from the end of the financial year 30th June, 1959 and if you have not already submitted your return for that year (as well as for the year ending 30th June, 1960) you should do so without further delay in order to avoid prosecution.

The tax is additional to the £1.15s.0d. General Tax payable annually by every Bantu man over the age of 18 years who is not exempted therefrom.

# CHRISTMAS GREETINGS RECEIVED FROM THE CHAIRMAN OF THE BOARD

As the new Chairman of the Peri-Urban Areas Health Board, the honour has also devolved upon me of becoming the Chairman of the Alexandra Local Area Committee. I regard this position as very important because it enables me to play my part in the furtherance of good relations between Europeans and non-Europeans on the local government plane. I therefore welcome this opportunity of delivering my Christmas greetings and New Year's message to the residents of Alexandra.

At Christmastime our thoughts turn to charity and the good deeds that we may and can do for others especially for the less privileged groups in our respective communities. As far as Alexandra is concerned, the Board has embarked upon a feeding scheme for tuberculotics which carries a yearly expenditure of £16,000 whilst the milk distribution scheme is subsidised in the amount of £1,250 annually. The dental clinic is also being subsidised and bursaries and other aid are made available for the education of the youth. It is not only the intention of the Board to continue with this good work during the coming year, but to extend the provision of social services amongst other things providing ablution facilities costing £10,000 and a community centre also costing £10,000. As before, the Board has this year again organized a Christmas function for the needy old aged and the Board is looking forward to the day when it will also be able to treat the children of Alexandra to a Christmas party.

CHRISTMAS GRELTING ; FROM THE MANAGER, BATU ADMINISTRATION.

I again gladly avail myself of the opportunity presented by the "Bulletin" of felivering by Christmas creetings and New Year's wishes to the public of Alexandra.

A year of turmoil has passed - a year in which especially the Bantu in some other areas resorted to violence because of the existence of alleged grievances which were exploited by troublemakers. Some families are probably now in need because theirbreadwinners lost their lives in this tense period. Thank God, Alexandra remained calm during the emergency and the selfreproach of others that this bloodshed could havebeen avoided, should therefore not be present in Alexandra. Congratulations to the public of Alexandra with this feet:

My Christmas message to you is one of hope. Where peace provails and mutual understanding exists, problems are not inscluble. The persons whils to hate and suspicion between the racial groups cannot solve our problems because hate and suspition lead to destruction. We as different population groups - white, coloured, Bantu and Asiatic - have been brought together with a purpose to work out our common salvation in this southern corner of Africa and this cannot be done by agitators. If grievances exist with one of

the population groups, then the correct course is to seek a solution through the recognized channels. Let us trust and try to understand each other and to accept the Europeans' goodwill toward the coloured groups.

When one thinks back on the past year, then one is grateful that one was in a position to be able to do something for the coloured groups and I value the friendship and good spirit that went out from the public of Alexandra.

Where the Bantu Liaison Committee was dissolved as a result of a misunderatdning on the part of the residents, I trust that the undignified and perverse attitude which caused these good men to resign has now come to be realised by the Alexandra public and that the public will now again approach the Board with a request that the Liaison Committee be re-appointed.

I would like to address a word of thanks to the Board's European and Bantu officials who, through their reasonable and considerate actions, contributed to the mutual good relations between the Alexandra public and the Peri-Urban Areas Health Board. I also want to wish them through this medium a very happy Christmas and a prosperous New Year.

Where Christmas will presently be celebrated by the community and the New Year is not far removed, it is my wish that the public of Alexandra will enjoy a specially blessed and happy Christmas and that the New Year shall contain great prosperity and happiness for the public of Alexandra.

EMPLOYMENT OF BANTU YOUTHS - NORTH JOHANNESBURG

The Board's Welfare Department in collaboration with the Local Labour Bureau, has formulated a scheme whereby unemployed Alexandra youths will be organised into teams to undertake domestic (house/garden) work in the Northern-Johannesburg area.

This scheme /

This scheme was born out of the need of employers in the Northern Johannesburg area and the fact, since established by intensive investigations conducted by the Welfare Department that there is a large number of Bantu teenagers who are not engaged in any form of occupation in Alexandra.

An appeal is accordingly directed to employers, parents, teachers and other agencies to co-operate with the Department to make the scheme a success.

The programme of this scheme has been drawn up as follows:

- A youth labour team will consist of as many members as are necessary to meet the requirements of employers provided such teams consist of not less than two members;
- (2) The minimum daily rate of pay will be 2/- (twenty cents) per member. Working hours will be from 9 a.m. to 1 p.m. over a five-day week and lunch will be provided for each member;
- (3) In order to ensure good order and attention to duties prescribed by the employer, each team will be visited once a day by an official of the Department;
- (4) Employers will have the opportunity, if they so desire, to take over one or more members of a team into permanent service;
- (5) Transport will be provided by the Department for the teams to and from work where employers are unable to do so;

This scheme, it is emphasised, is not one of administrative policy or regulation but is intended primarily to ameliorate an undesirable state of affairs. It is essentially a social welfare measure designed to break down misguided antagonism to urbanised Bantu youth on the part of employers and to find an outlet for the surplus energies of otherwise promising boys who would and often do in their frustration, gravitate towards organised crime.
