"We are not prepared to stand back but to fight for freedom without bloodshed in our land..."
Three organisations stand for peace and tranquility in S.A...." We believe we can all stay here in harmony". Ex. G. 314. p.1.

NGURUNYEKA (87).

"A.N.C. people call for co-operation.....If they look back at the C.O.F. Govt. should know that the races are co-operating". Ex.G. 314, p.1.
