Dear Bishop Tobias,

The Future of South West Africa.

I hope you duly received a copy of my pamphlet on South West Africa. Owing to the delay caused by our efforts to persuade General Smuts to let the Institute send a delegation to South West Africa I only had about ten days in which to write the pamphlet, as I had to leave for Central Africa - and even this short period was broken into by other work. It was quite out of the question to include in it any first hand account of actual conditions in South West Africa. As my Council had not expressed itself on the annexation issue, I had to leave that open. UNO. sent for copies and copies were also sent to other bodies in Britain and the United States of America.

It is clear that we in the Union must take a much more active interest in South West Africa, and I hope someone from the Institute will be deputed to visit the territory this year. I shall be grateful for any suggestions you may make as to any action by the Institute.

I don't know what is in General Smut's mind. I believe he is a very angry man, although he has managed to keep signs of it out of his public pronouncements.

My Executive and Council meet in Cape Town in January 22 - 25. If by chance you are in Cape Town then it would be a great help to consult you. My address will be C/o. City Club, Queen Victoria Street.
