DEPRESSION SIGNS/com.

- France is on the verge of bankruptcy. Only West Germany is exuberantly productive. She is the largest creditor and Britain the largest debtor in the European Payments Union. With the shrunken world market, West Germany's phenomenal productivity can only aggravate matters, firstly for her capitalist contemporaries and finally for herself.
- One would have imagined that South Africa would have attempted to insulate herself against the effects of a world depression. But the Government's fiscal policy instead of raising higher tariff barriers and increasing import control to prevent dumping of foreign goods on the South African market, in fact makes provision for the relaxation of import control. This must aggravate the difficulties of South African industry which cannot as yet compete with overseas production, and result in increasing unemployment. While this is in the interests of gold mining magnates, who thrive during depressions owing to increased investment in gold, it must lead to a depression in the living standards of the people.
- What South Africa needs is the removal of all restrictions on the movement of labour, so that it may integrate itself completely in the more productive 'secondary' industries. Also effective protection against foreign competition as a means of promoting expansion and development. There is also a need for a powerful labour movement in the country to ensure a corresponding increase in the wage standards of the workers and thereby ensuring also the progressive modernisation of South Africa's productive machine. Such measures would not only insulate South Africa from the effects of world depression, but allow her to thrive under it.

ACCORDING TO THE JULY 'HANUFACTUPER', 14 WORKERS IN AMERICA NOW PRO-DUCE 90% OF ALL GLASS LIGHT BULBS USED IN THE UNITED STATES OF AMERICA. NOT ONLY THIS, THEY PRODUCE ALSO ALL THE GLASS TUBES IN TELEVISION (EXCEPT PICTURE TUBES) AND RADIO. THE 14 MEN OPERATE AUTOMATIC GLASS BLOWING MACHINES.

LESS AND LESS PRODUCE MORE AND MORE

In the United States Ford Cleveland plant one man now runs a transfer machine which performs more than 500 machine operations.

"Conventional methods required 35 to 75 men." Whereas 400 workers before took 40 minutes to turn out an engine block, 48 now take less than 20 minutes.

The U.S.S.R. has automatic machinery which produces aluminium pistons for heavy truck engines. "No human hand intervenes throughout the process and even waste metal is removed from machines automatically." These are only some of the wonders that automat-

ically controlled automatic machines can perform.

POVERTY OF WEALTH

Apparently the rapid change from conventional means of production to automation is feared by workers in "Western" countries. They are quite sure that the immediate and widespread application of automation will for some time at least create conditions of the most terrible unemployment. According to current opinion the U.S.S.R., whose industries are nationalised and state controlled, does not face the same problem. Production there is not for profit. A "reserve army of unemployed" is therefore, not required to keep down labour costs.

PUBLIC OWNERSHIP

While itsis generally recognised that automation will revolutionise society and create undreamt of wealth, labour leaders in both America and England, aware that automation can immediately be used against the workers, have demanded that they be given a share in the fruits of automation through shorter working hours and higher wages. Walter Reuther in America and other trade unionists in England have also demanded that those industries in which the application of automation will cause unemployment must change from private to public ownership. It is felt too that Industry should bear a large part of the cost of re-training workers to enable them to cope with the new automatic techniques.

S. A. AND AUTOMATION

Because South Africa is less developed industrially than other "Western countries" the workers by and large will not resist the application of automation. It is felt, therefore, that if the Colour Bar were removed so as to enable Industry to develop as rapidly as possible the workers could be trained almost overnight to handle the new automatic equipment. With adequate facilities for the training of the necessary electricians, technicians and scientists South Africa could be transformed into a great modern industrial nation within a few years. That the Colour Bar is not removed to enable such a development is explained in terms of the Gold Mines! need for cheap pauperised labour which apartheid provides.

I It was pointed out that Baartman was a victim of ruling class racialism.

PROSECUTE RACIALISTS

An executive member of the Heatherley Civic Association, Lansdowne, said "It is high time that the members of the Nationalist Cabinet and others who advocate racialism were also prosecuted."

APARTHEID CAUSES 'TRIBAL' FIGHTS

"ONLY COMPLETE DEMOCRACY CAN SAVE SOUTH AFRICA FROM RACIAL WAR. THE POLICY OF APARTHEID WHICH DIVIDES THE NATION INTO 'AFRICAN', 'WHITE', 'COLOURED' AND 'INDIAN' MUST INEVITABLY LEAD NOT ONLY TO STRIFE AMONG THE PEOPLE IN THE VARIOUS 'RACIAL' DIVISIONS THEMSELVES, BUT TO BITTER STRUGGLES BETWEEN ONE SO-CALLED RACIAL GROUP AND ANOTHER," SAID MR. RULERS CREATE DIVISION

He said that if the people do not struggle against Apartheid they will turn in upon themselves.

> "The ruling class knows this, therefore, to maintain itself it constantly recreates divisions amongst the people."

Even the daily press, which belonged to the Chamber of Mines in whose interests Apartheid was created, had to admit that the faction fights were a reflection of a "malignant illness in the body politic", that is, Apartheid.

"The CAPE TIMES editorial of September 20th blames the Nationalist Government for the riots. They admit that they are a "reaction to the frustration' caused by 'our economic and political system'. They go further and say:

> 'Has the migrant labour system with its dislocation of family life, its imposition of an unnatural separation of the sexes, and its by-product of juvenile delinquincy, not helped to create a situation in which violence is always imminent?'

"However, what this paper fails to mention is that this policy serves the Chamber of Mines who dominates this country and whose needs result in such a state of affairs."

ETHNIC GROUPING

Mr. Mogali held that the riots had nothing to do with "intertribal" warfare.

> "That period of South African history is gone forever. More than a hundred years of capitalism has completely destroyed tribalism. The faction fights are directly the result of Apartheid."

To satisfy the need of the mines for cheap labour workers were rounded up by the Chamber of Mines recruiting agencies, brought to the Native Labour Association and then arbitrarily and forcibly divided into so-called "ethnic groups".

"They are then sent to the various mines and farms where they are rigidly separated as Zulus, Shangaans, Sothos and so forth.

SOCIAL FRUSTRATION

"Not only is a 'tribal' psychology constantly recreated by these divisions in the compounds and more recently in the schools and locations — Daveytown location in Benoni for example — but there are also wide social differences among the pecple, between those in the reserves and those who have grown up in the towns.

> "These differences are maintained by the different labour needs of Secondary Industry and Mining. Sncbbery is also rife."

He felt that it was surprising that with the frustration which location and migrant labour life gave rise to, all the abuses and daily indignities heaped upon the heads of the people by Apartheid, that there were not more and more widespread riots.

"Such an environment gives rise to large numbers of delinquents and criminals. Having no police protection the people take the law into their own hands which often leads to rioting."

"There is only one alternative to democracy in South Africa, and that is a protracted, blocdy and wasteful racial war involving the whole South African nation," he said.

FIGHTING THE LOCATION SYSTEM

In spite of all the brave words our whole nation stands helpless before the abominations and iniquities of the pernicious location system. This devillish device brought forth from the dens of brazen political criminality seeks to perpetuate the world of paupers and pariahs created by the Gold Mining Industry and its political hirelings for the enrichment of foreign capitalist exploiters. It began its vile career with various "Native" Land Acts, and went over into several "Asiatic" Land Tenure Laws. Now we have before us this most perfect of the series of monstrous pieces of legislative iniquity, the Group Areas Act.

At this stage in the historical development of South Africa when the objective evolution of capitalism imperiously demands a merciless scrapping of all the old racialist junk to ensure its own progress, all the progressive forces should now have been lining up to put an end to all the old locations, not standing helpless before the nightmarish efforts of lawgiver Dönges. Under the circumstances one wonders how even a racialist madman could have conceived such a fantastic piece of legal iniquity.

And the first condition for this is the complete rejection of all "racial" thinking or thinking with one's blood, and an ideological war against the voluntary acceptance of apartheid.

Only on such a basis will we be able to put an end not only to the diabolical devices of the nightmarish Dönges but also those of his more hypocritical but no less cynical predecessors who prate of voluntary apartheid but conceived the Native Land Acts and the Asiatic Land Tenure Acts.

"Those who are earning three to four pounds a week are being told to leave the better built houses in schemes nearer Town and are being pushed into houses far from their places of work.

As there were insufficient houses for those who were being shifted further out, occupants of houses in such areas were being evicted on the slightest pretext to make way for newcomers.

PEOPLE DEGRADED

"Detailed records are kept of residents' personal lives and people are encouraged to report one another's misdeeds to housing managers. *--*

COUNCIL HOUSING

"In this way evictions are justified on information collected," she said.

Fear of losing their homes caused many to indulge in that degrading practice so as to be on good terms with their housing managers.

CIVIC BODY AND TRADERS REJECT ATHLONE GROUP AREA MISGIVINGS OVER RUMOURS TO CASH IN

AT A MEETING CALLED BY THE HEATHERLEY CIVIC ASSOCIATION EDECUTIVE, A RESO-LUTION WAS PASSED REJECTING THE LATEST PROCLAMATION OF GROUP AREAS IN THE CAPE PENINSULA. THE RESOLUTION, WHICH WAS SUPPORTED BY THE ATHLONE, CRAW-FORD AND DISTRICT TRADERS' ASSOCIATION, TOTALLY REJECTED "APARTHEID IN ANY FORM".

"AS SOUTH AFRICANS"

"The only way to fight this Act is to regard ourselves as South Africans who have the right to live anywhere in the land of our birth. We cannot fight against Group Areas as 'Coloureds' or 'non-Europeans'," said an executive member.

Two young delegates of the Traders' Association expressed full agreement with this point of view: "The old way of approaching these problems must go; we can never hope to win if we approach this struggle as Indians."

The Traders' secretary added that it was equally dangerous to approach the struggle purely as traders.

"CASHING IN"

The Chairman of the Traders' Association expressed grave misgivings over rumours circulating in Athlone that "Coloured businessmen" in the area were preparing to stab in the back those whom the Group Areas Board intended moving to the 'Indian Area' in Rylands Estate, by cashing in' on their misery.

He said that it was runcured that Companies to start 'Coloureds Only' bus services and to take over the businesses of disqualified businessmen in the area were now being floated.

"The traders hate the laws that degrade the oppressed people and fully identify themselves with their struggle," he said.

"NON-EUROPEAN" UNITY

A suggestion by a visitor that, "perhaps it would not be such a bad thing after all to group all non-Europeans in one area in the best interests of non-European unity", was sharply attacked by the secretary of the Civic and others from the floor. It was pointed out that this was, in fact, accepting Apartheid and begging for its application. And that only "European" and "non-European" racialists would see nothing wrong in such an idea.

"We cannot fight this Act by accepting non-Europeanism," added a Civic executive member.

THE RESOLUTION

The resolution passed at the meeting points out that the purpose of the Group Areas Act is "to divide and separate the South African Nation and so cause racial strife and hostility and retard all progress and development."

The resolution commits the organisation to "encourage the formation of residents' organisations" to take up the struggle against Group Areas" and also that as the Aot cannot be put into effect without the consent of the people — "we will not consent nor degrade ourselves by applying for any Group Area whatsoever."

The right to enter Varsity we demand as citizens who pay for these institutions. We can abandon this right only by bowing down before usurpers and robbers. We who are building the new South Africa abandon neither and will fight to the end against those who have robbed the people of these rights.

DR. R.E. VAN DER ROSS does not share this view. He is prepared to trade our common humanity for the titles, degrees and diplomas of academic baboonery. He placates the racialists who brought about the vile Mixed Marriages Act and Immorality Act with a promise that racial co-pathetic self-disdain! What pitiful selfdebasement! Who but a racialist or a pander to racialists could conceive of this most natural and reasonable process as a crime? And that from a man who is himself the offspring of our three hundred years of natural assimilation.

THE MULTI RHOAL CONFERENCE AT BLOEMFONTEIN

IT SEEMS CLEAR THAT 'THE CITIZEN' STANDS ALONE IN ITS TOTAL OPPOSITION TO THE MULTI-RACIAL CONFERENCE AT BLOEMFONTEIN. THE 'NEW AGE' AND ITS SATELLITES ARE TRYING TO OUTSHOUT THE POWERFUL CHAMBER OF MINES PRESS IN THEIR SUPPORT OF THE CON-FERENCE

The Liberals, we are sure, are the leading spirits in the enterprise. THE TORCH and its entourage do not really know where they are. Apart from trying to salvage their old friend, the Rev. Mahabane, who has left the old pastures of Non-Europeanism for the new fields of Multi-racialism, they have been silent — and silence is consent.

What are the political considerations determining support or boycott or neutrality in the mat-ter of this conference? We do not propose here to deal with the CAPE TIMES or the Liberals or other spokesmen of the exploiting and oppressing classes and inter-They have their good reaests. sons for supporting this conferen-ce. They are sure that the thing will be of immeasurable benefit to themselves now and in the future. And they are not miscalculating. These people have a vast and varied experience in the deceit and domination of other people and classes. The supporters of the NEW AGE should contemplate this point very, very carefully.

The NEW AGE supports the conference. They support it not out of devilment or because they have been bought nor yet because they can find no better use for their time. Not at all: They support the conference because they believe it in their bones that in this way they will be able to pack the mightiest punch against the present Nationalist regime. They are certain, and they are not wrong in this, that the political defeat of the Nationalists is an inevitable step in the unfolding of the new democratic South Africa. They may also be convinced that once allies from hostile social classes have served their turn they can be easily jettisoned and the ship of democracy will sail safely into harbour.

A MISCALCULATION

We are sure that the NEW AGE is seriously miscalculating and that their miscalculation is not accidental. They have long since forgotten the elementary rule; he who would be free must himself strike the blow. And in this case those who wish to be free aseaa whole nation of oppressed and exploited people. But the NEW AGE groups have long since lost all confidence in the masses, they have forgotten that no great historical turn, such as that before us now, has ever occurred without the direct intervention of the ba-sic layers of the people. They have faith only in the manoeuvres and manipulations of powers, authorities, institutions and dignitaries. Their participation in this conference is an act of political desperation which may have the most disastrous consequences.

Certain it is that Finance Capital hopes to get out of these manoeuvres nothing more or less than enough pressure to force on the Nationalists a Nationalist -United Farty Coalition Government which will the better serve their interests, Certain it is that by this move the Congressites will be hopelessly compromised and will not be able to extricate themselves without the most shattering internal convulsions. In any event they are guilty of handing over as host-ages to the real rulers of our country the strongest and best organised political tendency among the oppress-ed. They are committing the impermissable error of mixing banners. And no temporary advantage will compensate for this grievous loss.

As for THE TORCH and its followers they are torn by such bitter internecine strife, their political bankruptcy has been so fully exposed, they are so tired and demoralised that they are only capable of silence and neutrality. All the brave wordspinners have turned out to be and Non-Europeanism but a cheap edi-V6L.2-NO.10 21.10.1957 On March the 19th an article "NATIVE" OR AFRICAN appeared in THE TORCH newspaper which made it clear that this paper was not impressed by the Government of Southern Rhoddsia substituting the word 'African' for 'Native' in its laws. THE TORCH correctly asks: "But is the mere substitution of one word for another of real importance?"

The article goes on to say, "It is one thing for a change of name to take place, but it is quite another for the whole political, economic and social conditions to change and give real meaning to the word; or further and more correctly, to dispense with the word altogether, and to replace it with the word and idea and reality of citizen". (my emphasis).

I am in full agreement with these sentiments. But the contradiction which puzzles me is why, despite these correct ideas, THE TORCH persists in classifying itself as a "Non-European" paper. Worse! It persists also in classifying South Africans, both individually and collectively, as "White", "Non-White", "African", "Coloured" and "Indian" etc. Surely this is no way to <u>set about</u> realising "the word and idea and reality of citizen" in the minds of its readers.

RACIAL SPLIT IN ANTI-CAD ? ILITICAL COLLAPSE OF NON-EUROPEANISM

OVER THE LAST TWO YEARS THERE HAS BEEN A SERIOUS AND MOUNTING CRISIS IN ANTI-CAD CIRCLES. IT IS CONSIDERED THAT THE INTERNAL FIGHTS AMONG THE LEADERSHIP REFLECTS IDEOLOGICAL AND POLITICAL COLLAPSE. THIS HAS AP-PARENTLY ENABLED A STRONG RACIALIST ELEMENT TO MOVE TO THE FORE. AND IT HAS ALSO FREED THE MORE "PETIT-BOURGEOIS" TYPES TO MOVE TOWARDS "LIBERALISM".

BITTERNESS AND HOSTILITY

Reports indicate that the battle between the Kies and Tabata factions in the Anti-Cad is increasing in bitterness and hostility. Mr. Benjamin Kies is attacked for being "Flattered by the attention of Liberal elements" and Mr. I.B. Tabata for overlooking a tendency towards "African" nationalism. Personal boycotting is rife.

A more recent split is that between Mr. Kies' "Fellowships" and the newly formed "Cape Peninsula Students Union" under Mr. Allie Fataar. It is said that the CPSU has organised a boycott of THE TORCH. No holds are barred: the members of the "Fellowship" organisations (NEF, CFEF, CLEF) are called "Effies" by the "Students' Union". These in turn have mockingly named the CPSU the "Communist Party of the Soviet Union".

At the recent conference of the "Coloured" Teachers' League of South Africa the quarrel between Mr. Kies and Mr. Fataar would, it is reported, have split this organisation had it not been for the efforts of the President, Mr. W. van Sohoor.

DEGRADED POLITICAL METHODS

The departure of Dr. G.H. Gool, early last year, was a serious blow to the Anti-Cad. It cost them their "militant and mass front". According to some Dr. Gool left because he refused to be associated with the TARC funds "affair" and with the attempts to wreck the people's Anti-Group Areas struggle in 1955. Others feel that these are only isolated factors and that Dr. Gool left because of the Anti-Cad's ever increasing use of "the most degraded political methods" (eg. smearing consistent democrats as C.I.D. agents), the refusal of the leadership to correct ideological failures and the fact that they were becoming politically indistinguishable from the "multi-racialists" and Liberals.

"RACIAL" DIVERGENCE

Deep disappointment is felt by those Anti-Cad leaders who thought the federated "racial" three pillars would *--*

eventually converge. But despite all their attempts to prevent it the three "pillars" have become divergent and are at best "developing along parallel lines".

One example of the growing "racial divergence" is a recent statement by an Anti-Cad leader that the presence of "Coloured" students in a certain discussion organisation would "upset the mental balance" of the "more backward Africans" present there: There is also considerable "Anti-Moslem" prejudice. "African Nationalism" is also being resorted to as a result of conservative "Cape Coloured" patronage.

It is not doubted that it is the withering and devastating attacks of consistent democracy on "non-Europeanism" — characterised as the "left cover" of "Cape Colcaed" nationalism — which caused the ideological collapse of its antiracial protagonists in the Anti-Cad. Also their defence of the Russian bureaucracy's "murderous and bloody intervention" in the Hungarian revolution opened them up to further severe attack.

Efforts were made, especially by Mr. Hosea Jaffe, to adopt the new South African approach to put an end to the incessant attacks of the consistent democrats. THE TORCH, also took down its banner — "The Only Independent Non-European News-

paper — and a campaign for "De-Colouredisation" was set in motion. But the representatives of "Cape Colouredism" were not prepared to accept the political implication of "South Africanism" and these efforts had to be abandoned.

However, while THE TORCH raised its "non-European" banner once again, it continued to print "Coloured" in inverted commas. More recently, Anti-Cads sometimes refer to themselves as "non-Citizens" instead of "non-Europeans".

LIBERAL ATTRACTION

Liberal capitalism with the ideological collapse of the Anti-Cad has exercised increasingly strong influen-ce in these circles. The Anti-Cad's "NEUM" President attended the Bloemfontein 'African' Ministers' Conference and its Vice-President associated himself with the "academic non-segregationists" and the United Party "Black Sash". Many are surprised that Mr. A. C. Jordan and Mr. Sihlali should have contributed articles on "African" literature and "Bantu" education to Mr. Ronald Segal's "liberalist" publication "Africa South". Surprise has also been expressed at Mr. Kies having written a "law book" on the Cape Educational laws which has been described as " a guide book to the apartheid educational laws".

ESSENCE OF T.L.S.A. DISPUTE

By a Political Correspondent

While ardent attempts have been made to suppress the bitter internal conflicts within the TLSA and to blanket the noise from the ears of the public it has been of no avail: the dispute has reached too great an intensity and vigour. What has sounded through to the public appears to permit description of the affair as petty, personal and at best, of a secondary and tertiary political nature. But this is perhaps too superficial.

TWO GROUPINGS

Accepting that the dispute rages within the camp and on the "non-European" political premises of a privileged caste, investigation reveals — to those not distracted by the "sound and fury" — that there are two groupings: one moving further towards "Cape Coloured" conservatism, retaining merely a democratic facade, the other towards the establishment of independent, non-racial, non-sectarian students' organisations and demanding a fuller support of the Cape African Teachers' Association's defence fund for the defence of victimised teachers.

POSITIONS NOT CLEAR

These two groupings within the TLSA (which is to all intents and purposes the 'Non-European Liberatory Movement') have not yet begun to think out, or define clearly their positions. It is inevitable, therefore, that their attacks on one another will be couched in the language of the personal and will take place on the plane of the secondary and tertiary. However it is inevitable, also, that if the conflict is not resolved, that justification for the differences will have to be sought in the realm of ideas. If this occurs the essential nature of the dispute will be clearly revealed.

FREEDOM ELSEWHEH

HOME TO ENGLAND AND FREEDOM! This was at one time a popular catchphrase among those "Coloured people" whom the apartheid shoe was beginning to pinch. That period is now passing. Ghana is becoming the new promised land for those trying to evade the obligation of fighting for their own freedom. A stream of professional people are making their way to Ghana --- "for there at least you find freedom!" With such a mentality one cannot stand on one's feet like a man. And only men can fight for freedom. The others will run to enjoy freedom fought for by other men.

COONS AND ZOMBLES

THE SOUTH AFRICAN INTELLIGENTSIA

ERSPECTIVES

Unless Baasskap and Apartheid are magic wands with which Strijdom and Co. have succeeded in arresting the historical progress of capitalism, there is, of course, not the remotest possibility that South Africa, this South Africa of Rhodes and Milner, will survive the present generation. Manufacturing Industry which grew up around the old Gold Mining economy is already threatening the very foundation of that economy and the political and social arrangements in which it flourished. Industrial capitalism now requires, irrespective of the consciousness of men, a transformation of all the old arrangements.

Naturally, since histroy is made by men, such a transformation is inconceivable without a prior transformation of conscious-The business of progressness. ive politics is, precisely to achieve that transformation of consciousness, to bring the ideas of men into line with the objective tasks before them. But we will fail to understand our tasks if we delude ourselves that the level of consciousness of the people has already reached a stage where it militates against the

status quo. On the contrary, the widespread acceptance of the ideas of racial separation is shocking in its apparently unbroken monotony. Even people who call themselves intellectuals in public, and who, in the secrecy of their own bedrooms pretend to be great revolutionaries, are unable to overcome the thought blocks of sectionalism and remain prisoners of the ideologies of racialism so skilfully erected by the Rhodes-Milner regime.

There is already lining up in South Africa two vast opposites of power; on the one hand, a great class of industrial proletarians and, on the other, the forces of a modern capitalist class. And neither can continue very much longer in the old way. The social struggle, largely unconscious as it may still be, has begun. South Africa is now entering upon a great revolutionary period.

But it is entering upon this period without prolonged intellectual and political preparation. Social development already demands a revolutionary transformation but the political and intellectual prerequisites for the control and guidance of that rebirth have not yet been developed. For South Africa has been cursed with an educated class which has an apparently congenital incapacity for original thought and *--* POLITICAL PERSPECTIVES____/CONT

inclined to behave more like the posterior end of society than its head.

While it is true that the development of the means of production is, in the last analysis, the decisive factor in the evolution of society, the character of the transformation and the nature of the new society depends entirely on the consciousness of those who guide the nation in its rebirth. It follows that the task of transforming the present semi-conscious cowardly, unambitious, unscientific and toothless gentry, who like to think of themselves as intellectuals, into a real modern intelligentsia is one of overwhelming importance.

Let it not be imagined that the mere juxtaposition of hostile historical forces automatically leads to a resolution of the social conflict in a progressive direction. Progressive social forces, before now, have been led into an historical cul-de-sac.

The potentialities today exist in South Africa for the creation of a modern democratic republic. But the creation of such a republic can by no manner of means be an automatic process and the failure of duty by the progressive intelligentsia may have tragic consequences in three possible dead ends of which we must be aware.

Firstly, there is the great danger that the people in their


struggle, in the absence of a modern political leadership, may take a nonpolitical road and exhaust themselves in a struggle of racial attrition along the lines of the Kenya revolt. This cannot realise the new potentialities of the nation. Secondly, there is the danger that in their struggle against oppression and exploitation the masses of our nation may be cheated of the fruits of their victory by coming, through opportunistic leaders, under the sway of hostile and alien forces. Thirdly, in the absence of a modern social democratic leadership, free from racialist mumbo-jumbo, the terrific forces fighting against exploitation and oppression may be led along tragic lines of race struggle as happened in Algeria.

Having due regard to these dangers the rising intelligentsia must work out its political perspectives for South Africa before it can embark on its historic task — the creation of a modern democratic South African republic.
