For the purposes of the provisions of the Government Service Pension Act, 1936, relating to the Union Widows' Pension Fund, the payment made to Treasury under subsection (2) of section six sexies by any person who, if that section had not been passed, would have been required to contribute to the Union Public Service Pension Fund, shall be deemed to be contributions to the last mentioned fund.

6 octies (1). The Council shall, as soon as practicable after the fixed date, pay to the Minister of Finance from the Council Pension Fund a sum representing the aggregate of the amounts (including the Council's contributions) standing at the fixed date to the credit of the persons referred to in section six ter in such fund.

(2) The Minister of Finance shall pay to the Consolidated Revenue Fund all moneys received by him in terms of subsection (1) and all moneys paid to the Treasury in terms of section six sexies.

(3) All payments of pensions or other benefits (other than pensions or other benefits which under the Government Service Pension Act, 1936, are payable from the Union Widows' Pension Fund), to which any person who has become an employee of the Government of the Union in terms of section six ter is entitled on his retirement or to which his representatives or dependents are entitled on his death in respect of service under the Council or in the Government of the Union shall be made from the Consolidated Revenue Fund.

(4) The provisions of subsection (4) of section six bis shall, mutatis mutandis, apply in respect of such financial adjustments between the Trust and the Government of the Union as may be necessary regarding the salaries, wages and allowances

of the persons who have become employees of the Government of the Union in terms of section six ter and whose services are in terms thereof utilised upon duties connected with the administration of the Trust.

Future amendment of Fourth Schedule to Act No. 18 of 1936.

6 nonies (1) The Governor-General may, by Proclamation in the Gazette, amend the Fourth Schedule to this Act by adding thereto the names of any or all of the European members of the administrative and clerical staffs employed by the Council and, as from a date to be specified in such Proclamation (which for the purposes of this section shall be deemed to be the fixed date as defined in section forty-nine), the persons whose names have been so added shall become employees of the Government of the Union and their services shall thereafter be utilised upon duties connected with the administration of the Trust.

(2) The provisions of sections six ter, six quater, six quinquies, six septies and six octies shall mutatis mutandis apply in respect of the persons who in terms of subsection (1) have become employees of the Government of the Union.

Amendment of of section 49 of Act No. 18 of 1936.

24. Section forty-nine of the Native Trust and Land Act, No. 18 of 1936 is hereby amended:

(1) by the insertion between the definitions of "acquisition" and "dependant" of the following new definitions:

"Council" means the United Transkeian Territories General Council constituted by Proclamation No.279 of 1930, read with Proclamation No. 191 of 1932, as amended from time to time.

"Council Pension Fund" means the United Transkeian Territories General Council Employees' Pension and Gratuity Fund established under Proclamation No.143 of 1921, as amended from time to time.

- "fixed date" means a date to be fixed by the Governor-General by proclamation in the Gazette.
- (3) by the insertion after the definition of "squatter" of the following new definition :
- "Treasury" means the Minister of Finance or any officer in the Department of Finance authorised by him to perform the functions assigned to the Treasury in this Act.
