NATIVE TRADE UNION.

According to the local Press "The Industrial and Commercial Workers' Union of South Africa held their fifth annual conference in the African Wesleyan Institute, Eloff Street Extension, from April 13th to 17th. Delegates attended from all centres of the Union, and delegates were also present from Basutoland and the South-West Protectorate. The first day of the conference was taken up mainly with administration. Among the subjects discussed on the third day was that of sending an official oversea to study the world labour movement. Other topics for consideration included a minimum wage for unskilled labour, the civilised labour policy of the Government, the pass laws and the Colour Bar Bill."

This enlightening paragraph conclusively shows that the natives in South Africa have not been slow in imitating the European workers in regard to the organisation of labour.
