Many thanks for sending me the cutting entitled 'Your Guess'. I can understand very well how you feel and you certainly made the right points. It is now seven weeks since D & A was banned and since the Minister alleged that it had given money to the Communists and the banned A.N.C. Yet we find not one vestige of proof has been produced. I think it quite outrageous that a Minister should make a statement like this which undoubtedly defames anyone who has been outspoken in defence of D & A., and that nothing can be done about it. I was wrongly reported by the SUNDAY TRIBUNE that I would take steps against the Minister. His reply to this was that he would love me to do so. The truth is that I would not dare to risk ten thousand rand as things are at present.

Perhaps you know that Delius is thinking of suing DAGBREEK because under a headline - 'Breytenbach onder die Kommuniste' are published the photographs of Eddie Roux, myself, Breytenbach, and Delius. But the CAPE TIMES is reluctant to support him, because it reckons that DANAMSEK WILL SPEND any amount of money on the case, and if Delius should lose the coats will be fantastic. It seems to me relatively easy today to defame people like myself, for example. I think one could say almost anything about Petrus Byleveld, and get away with it. On the contrary, people like myself must be extremely what they say about Nationalists, who in any defamation case would have odds of 6 to 4 on, or even better.
