CH/IRMAN'S OPENING REMARKS. The Chairman prefaced the business of the meeting by reporting that the Scouters' Conference at 3, Polly Street, Johannesburg, on Saturday, 11th. August, 1951 was well attended and successful in its deliberations which included the visit early in 1952 of the Camp Chief, Mr. John Thurman of Gilwell, England to South Africa and the Bob-a-Job Week Campaign in the Transvaal during April next year. He asked the Council for representations he should make to the meeting of Transvaal Divisional Commissioners where the programme of the Camp Chief's visit would be discussed, and he hoped Mr. Rathebe would also be present. Finally, the Chairman welcomed back Mr. S.H. Mbambo, an old Council member who had been away on long study leave.

In response to the Chairman's appeal, Mr. Marivate on behalf of the Training Course Committee, suggested that the Camp Chief's programme should include a whole day Scouters' Conference, say, on 8th. March, 1952 and also separate Wood Badge Courses for Pack and Troop Scouters in the Northern and Southern Transvaal.

MINUTES of the previous meeting held on 12th. June. 1951 having been circulated were taken as read and confirmed after noting the correct spelling of Revd. Veysie's name.

MATTERS ARISING FROM THE MINUTES.

Photo: Mr. Rathebe reported that the Deputy Cnief Scout's
African Scout Commissioner, the Venerable Archdeacon
S.P. Woodfield, had agreed to send the requested photo of
himself as soon as possible.

Animal Welfare: Mr. Rathebe reported that the article on this topic would appear in the next issue of the Transvael African Scout Gazette.

S/M St. Thomas: This was deferred pending receipt of Revd. Fr. Clarke's report.

D/C Orlando: Mr. Rathebe reported that he had not yet met Mr. Lot N. Sikwane on this appointment, as the latter had only recently been discharged from the Baragwanath Hospital.

"AFRICAN DRUM. Mr. Rathebe reported that arrangements for the sale of the magazine "African Drum" by Transval African Scouts on a commission basis of ld. to troops and ad. to Divisional Headquarters on each copy sold, had now been satisfactorily concluded. The response by troops to the scheme was encouraging and it was agreed to fix a quota of 3,000 copies per month for distribution by the Transvall Division of the African Boy Scouts Association. It was noted that the Bechuanaland and Cape Border Divisions of the Association had also commented favourably on the scheme.

Christianity and Scouting: This was deferred till Revd.

Buchler could submit for approval
the draft of the proposed circular.

TRAINER'S REPORT. Mr. Marivate reported on the Preliminary
Training Course for Troop Scouters held at
Serenity Farm, Forfar, from 2nd. to 7th. July, 1951. He
also gave an interesting account of his visit with the 2nd.
Johannesburg (Albert Street Methodist School) troop to
Lourenco Marques on 6th. July, 1951. He commended S/M Roy
Motaung on the excellent discipline of the boys and requested the Council to send letters of thanks on behalf of
the troop to Capitae Hermens de Oliveira, Capitae Alberto
Purtado Montanha and Enoque Libombo who, in several ways
contributed considerably towards the success of this tour.

The Secretary was asked to find out from the General Secretary at South African Headquarters at Cape Town whether it could be arranged for troops from the Northern Transveal to travel to the Central African Jamboree at Nkana through Messina instead of coming to the assembly point at Mafeking.
- CORRESPONDENCE. It was unanimously agreed that Mr. C.N. Wallace should be the Association's representative on the Board of Trustees of the Donaldson Orlando Community Centre to fill the vacancy created by the resignation of Div. Com. Archdeacon Woodfield.
