We would seek to draw a variety of important interest groups to the conference, in particular parliamentary groups, business representatives, IDASA, church bodies, community and welfare organisations. The possibility of IDASA hosting the conference was raised. A prolonged period of lobbying prior to the conference would be necessary. We would seek to win the support of these groups for the ECC's call for alternative national service, generate an interest in the conference, and encourage them to contribute to the campaign in whatever manner they could.

A number of well-researched 'inputs' to the conference would be necessary. These could include 1) the survey of community and welfare organisations re alternative service; 2) a specifically commissioned study of whites' attitudes to conscription and the need for alternative service; 3) the economic impact of conscription for professionals; 5) social and psychological effects of conscription.

The objectives of the conference itself would be to draw up a comprehensive, realistic and practical outline of a system of alternative national service. This would be presented as a drafted bill that could be laid before parliament, and it would be adopted as a resolution of the conference.
