In reply to your letter of the 16th instant, we are in the happy position to advise that we have the matter of provision of bus shelters in hand at last and only await approval from the City Council for the programme to start.

We feel that it is a sad state of affairs that the Corporation should have to ultimately shoulder this addition to its cost structure which has absorbed all increased prices such as fuel, tyres, spares, cost of living allowances, housing and transport levies, etc., and still charges the passengers pre-war fares - there have been no increases in fares for the past fifteen years.

It has always been our opinion that provision of bus shelters was purely the responsibility of the City Council but they have consistently refused to assist. It is still a debatable point as to whether they will give approval for the erection of these shelters in the built up areas even at our expense.

Our experience (as borne out in your letter under reply) is that the only time the African expresses himself on the subject of his bus service is to voice his dissatisfaction. This in spite of the fact that the Corporation has a large amount of capital invested in its Pretoria services and £300,000 (Three hundred thousand pounds) has been spent on the purchase of new buses for use in Pretoria during the past four years. The Corporation has made substantial contributions to the Non-European social life in Pretoria, treats its Staff far more satisfactorily than most other large employers in this Country, and is operating a very efficient service at pre-war fares.
