The meeting will elect a charperson. Members of KRO and possibly a representative of Greyhound will address the meeting; public discussion will also be invited.

### 3. Ad par 4

Save to state that the boycott has been in force since \$/1/86 we do not consider the reasons therefore to be relevant in considering the permission sought.

#### 4. Ad par 5

The KRO is the only organised representative body in Kagiso and Munsieville which strives to co-ordinate and articulate public feeling in these areas.

#### 5. Ad par 6

The KRO does not presume that it is capable of ending the boycott; in a spirit of reconciliation and in the interests of the people of the community and the bus line it merely wishes to create the opportunity for the parties to communicate with each communicate and to reconsider their positions.






