LADS' HOSTELS COMMITTEE.

REPORT FOR THE YEAR ENDED 30th JUNE, 1938.

To be submitted at the Annual General Meeting to be held at 5, Duff Road, Houghton, on Thursday, 18th August, 1938, at 8.15 p.m.

The General Committee has pleasure in submitting its Annual Report, together with the Balance Sheet and Accounts for the year ended 30th June, 1938.

STAFF.

The permanent European staff at each Hostel has consisted of Principal and Matron.

Mr. and Mrs. D. McDonald resigned the Principal- and Matronship of Spackman House on 31st January, 1938, and the Committee would like to place on record its appreciation of the work they did during the five years they were at the Hostel.

Mr. and Mrs. R. J. Jones were appointed to the posts of Principal and Matron in February, 1938.

Honorary—

The Committee wishes to place on record its thanks to Dr. F. Aitken, Drs. F. Young and F. Retief, and Dr. L. Adler for their continued services as Hon. Medical Officers at Norman House, Howard Pim Hostel and Spackman House respectively; to Dr. P. J. Hugo, as Hon. Dentist to Spackman House; to Dr. Morris Cohen, as Hon. Psychiatrist, and to Drs. Wium and Immelman for professional services rendered to the lads of Norman House and Howard Pim Hostel.

Thanks are also due to Miss J. Adams who has continued to assist in the office throughout the year.

COMMITTEE.

During the year each Hostel sub-committee and the General Committee met once a month.

The following members resigned from the Committee during the year:—

Mrs. Burt Andrews, Capt. L. P. Smart, Dr. C. J. Goedvolk, Messrs. W. S. Anderson, D. E. Coles, R. S. Fair and R. E. Lighton.

Of these, the five last-named resigned upon transfer.

It was with extreme reluctance that the Committee accepted Mrs. Burt Andrew's resignation, and much regrets the circumstances which made her resignation necessary.

Mrs. Burt Andrews had been associated with the Committee since 1923, and, as a member of the Norwood Sub-Committee, took a keen interest in the lads, and played a most active and untiring part in the work of the Hostel, and the Committee would like to place on record its grateful appreciation of her work. Although Mrs. Andrews has ceased to take an active part in the work, the Committee feels assured of her continued interest in the movement.

The following members joined the Committee during the year:—

Cottesloe Sub-Committee—

Messrs, H. C. Mullins and J. H. Griffin.

Mr. and Mrs. A. P. Richter, who resigned their membership in 1937 on going overseas, re-joined in June, 1938.

Norwood Sub-Committee—

Mr. C. K. Harris, who resigned from the Committee upon being transferred to Durban some time ago, has been re-transferred to Johannesburg, and has recently re-joined the Committee. While in Durban, Mr. Harris maintained his interest in the Hostel movement and served on the Durban Hostels Committee.

Krugersdorp Sub-Committee—

Messrs. R. I. Beddy, R. Powell and H. Voss.

Mr. H. P. Dent, who resigned in July, 1937, found that he was able to continue the work, and re-joined the Committee in February, 1938.

Obituary—

Capt. H. L. Seligson—We record, with profound regret, the death in March, 1938, of Capt. H. L. Seligson, who had been a member of the Committee since March, 1931.

In Capt. Seligson the Committee had an active and untiring colleague, and we should like to record our sincere appreciation of the work he did for the movement as a whole, and at Norman House in particular.

As a result of Capt. Seligson's wish that any expressions of remembrance should take the form of donations to Norman House in lieu of wreaths, an amount of £162 16s. 6d. has been received. The Committee intends that this fund should be utilised in some practical and useful way to commemorate Capt. Seligson's memory, but has not yet reached a definite decision in this respect. Pending a decision being arrived at, the money has been put into a trust account.

Mr. C. H. Olivier—It is with deep regret that we have to record the death of Mr. C. H. Olivier, who died suddenly in June, 1938, while in Capetown.

Mr. Olivier was one of the mainstays of the Hostel movement in the early days, and after running the Ferreira Hostel single handed for some months, acted as Principal at both Cottesloe (now Howard Pim) and Norwood (now Norman House) Hostels in the early days. This early interest in our work continued throughout his life, and present members of the Committee have a lively picture of his sympathetic co-operation as Senior Probation Officer, while there is no doubt that a host of young people who had suffered misfortunes of various sorts regarded him as a very real friend, and many of them enjoyed hospitality at his farm in Linden. His life should prove an inspiration to many, and in his passing the Committee have suffered a very severe loss. We extend our sympathy to his widow.

The number of lads who have passed through Howard Pim Hostel and Spackman House show a fair decrease on last year's figures, although the number at the former Hostel is still high.

The number of admissions on transfer from Tokai Reformatory is four this year as against five last year. The practice of accepting lads on transfer from a Reformatory was embarked upon as an experiment during the year 1936. At first the transfers gave every promise of proving successful, but latterly considerable difficulty has been encountered with the lads transferred, with the result that the Committee has under consideration at present the question of the advisability of discontinuing the practice.

The number of absconders during the year has been relatively high particularly at Howard Pim Hostel, and the Committee has been investigating possible causes. Considerable concern is felt at the apparent laxity in apprehending absconders, and at the fact that, in most cases, it is only when an absconder commits an offence that he is apprehended, a state of affairs which, it is felt, is serious not only because it is detrimental to the discipline of the Hostel, but because these are the boys who are likely to become the criminals of the future. A deputation from the Committee interviewed the Secretary for Social Welfare on 21st March, 1938, and discussed the question fully. We have now been promised the wholehearted co-operation of the Police Authorities in this connection, and, with this and the continued assistance of the Probation Office, it is hoped that the position will gradually improve.

BUILDINGS.

Howard Pim Hostel:

For some time past the question of the inadequacy of the Principal's and Matron's accommodation has been under consideration, and towards the end of last year our landlords, the Witwatersrand Lads' Club, agreed to erect a new building if the existing building could be disposed of. Negotiations for the disposal of the property were opened, but, as the difficulty of obtaining a site for the proposed new building proved insurmountable, it was decided that, instead of building a new Hostel, the existing building be adapted. Accordingly, fairly extensive structural alterations were embarked upon, and have just been completed. It is felt that these alterations have been well worth while, and the accommodation now provided for the Principal and Matron is adequate and comfortable.

We should like to record our appreciation of the Witwatersrand Lads' Club's generosity in effecting these improvements.

Norman House:

Various improvements have been carried out at Norman House, and the efforts of the unemployed lads at the Hostel have been directed towards the lay-out of the grounds which reflect much credit on the Principal.

EMPLOYMENT.

The year under review has been a satisfactory one from the employment point of view, and the increased industrial activity in the earlier part of the year resulted in the Principals being able to place, with comparatively little difficulty, the lads ready for employment. Not only was it easier to place boys, but the type of work which was obtained was of a higher standard. Latterly, unfortunately, the Principals have experienced more difficulty in placing lads, a result of the general slackening off in most spheres of industry.

As in the past, efforts have been made to avoid "blind-alley" jobs, and to apprentice lads in trades where possible, and during the year lads have been apprenticed in the painting, metal-working, tiling and boiler-making trades.

There are, as is to be expected, a number of lads who have not the necessary educational qualifications for an apprenticeship, but the special tuition provided at Norman House and dealt with in detail below, is helping to solve this problem.

The lads' contributions are dealt with in the financial section of the report.

EDUCATION.

Evening Classes :

(a) Norman House :

The extension classes have been continued throughout the year under the able instruction of Mr. H. W. Viccars. This year the experiment of coaching the lads for the ordinary Standard VI Commercial Examination was tried, and seven boys were entered for this examination. The final portion of the examination has just been held, and the results are not yet known.

The value of this tuition, in offering the boys an opportunity of qualifying for apprenticeship, cannot be over-emphasised, and the Committee is grateful to Mr. Viccars for his assistance and co-operation.

(b) The apprenticed lads have all attended evening classes at the Trades School, while two lads have attended the Witwatersrand Technical College for the purpose of improving their educational qualifications.

One boy, at Howard Pim Hostel, who showed marked ability in drawing, has been enrolled at the Art School and appears to be doing well.

Schooling of Spackman House Lads :

The position as regards the schooling of lads at the junior Hostel is still unsatisfactory, and the delay which occurs in most cases before a child is admitted to school is still held to be a matter for concern by the Committee. In order to combat the ill-effects of this enforced absence from school, the Committee has continued the arrangements for the provision of special tuition at the Hostel when necessary, and the Matron, who is a qualified teacher, also coaches the lads during this period.

A special sub-committee has been appointed to go more fully into the question with the Witwatersrand West School Board, and it is hoped that this will result in more satisfactory arrangements being made.

General Instruction :

(a) First-aid Classes at Norman House :

A series of lectures in First-aid, sponsored by Mr. L. G. Butt, and arranged by the Red Cross Society, were held at Norman House during the year, and as a result twelve lads were successful in obtaining the S.A. Red Cross Society's General Certificate. The Committee would like to record its thanks to Dr. Carpel as lecturer, and to Messrs. P. J. Kock and J. Rice as demonstrators.

(b) Boxing and Physical Culture Classes at Howard Pim Hostel :

These classes have been held at Howard Pim Hostel by Mr. E. Eustice and Mr. Armstrong regularly once a week throughout the year, and we should like to record our appreciation of their services in this direction.

CAMP.

During the winter vacation the lads of Spackman House camped at St. Michaels-on-sea, South Coast, Natal, in charge of Mr. H. W. Viccars. This is the second sea-side camp which Mr. Viccars has organised for the lads, and it is hoped that it will be possible to continue to arrange these annual camps. The Committee would like to place on record its appreciation of Mr. Viccars' assistance in this connection.

THE GOOD COMPANIONS ROVER CREW—HOWARD PIM HOSTEL.

(Reported by R. G. Silson, Assistant Rover Leader.)

At the beginning of September last our leader, Mr. A. Nimmo, was granted leave of absence from the Crew to enable him to organise and conduct a training course for Scoutmasters and Rover Leaders. After the conclusion of the course, Mr. Nimmo, or "Skip," as he is better known to us, left in April for overseas on long leave. We have greatly missed him from the Crew, and look forward to his return early in October.

It is, perhaps, inevitable that the life of the Crew should be one of ups and downs, but, generally speaking, our activities in the past year have been interesting and useful.

Camping and hiking, the most important branch of Rovering, have been very popular with the Crew. We have a liking for King's Kloof, where three camps were held. Boskop and Witkoppen, too, were visited.

We have enjoyed meeting other Crews at cricket, football and dances. We exchanged correspondence with scouts in the Seychelles Islands, whom our assistant leader had visited on his holiday, and we sent them some of our Rover literature. Rosebank Crew entertained some of us to a shoot at Craighall, and they kindly refrained from saying what they must have thought of our marksmanship.

Mr. Ernie Eustice, for a period of some months, held a boxing class once a week, which was open to all the Hostel without charge. The class is in recess for the present.

Mr. Harold Edkins, a mechanical and electrical engineer, gave a series of informal lectures, and the Crew were very interested, particularly in the practical side, such as the mending of bells and electric light switches and the like.

Mr. Kenneth Fleischer, from Scout Headquarters, spoke to us on the Rover Movement, the Rev. R. L. Pearson gave an informative talk on his visit to Russia, and Mr. Royce Reed one evening brought some of his pet snakes along and discoursed on their habits. Visits were paid at different times to the Jupiter Rope Works, the "Rand Daily Mail" works, the Central Fire Station, and the Delta Sewage Disposal works. The Crew's interest in hobbies was stimulated by instructive talks, one by Geoffrey Hardwick, who has a flair for modelling sailing ships, and another by Michael Price, who builds model aeroplanes. The latter has accepted an invitation to instruct the Crew in aeroplane modelling early in August.

We are grateful to Mr. and Mrs. Matthews for their friendly interest and assistance in many directions. Miss N. Adams is a great help in the solution of our book-keeping problems, and to Mr. Sheffield our thanks are due for all his untiring work. We thank Mrs. Best for a gift of books (per Mrs. H. A. Tothill), and those anonymous donors who have kindly assisted us.

OLD BOYS' REUNION.

The annual Reunion of old boys was held at Howard Pim Hostel on Sunday, 28th May, 1938. Unfortunately, owing to the fact that the playing field was in the course of being re-surfaced it was impossible to hold the usual football match, but a varied programme of games and entertainments was substituted.

Supper was followed by a concert arranged by Mr. C. H. Olivier and Mr. H. Matthews, and we should like to record our thanks to the artists who entertained the lads on this occasion.

SUNDAY RELIEF AT THE HOSTELS.

It has always been a strict principle of the Committee that Principals and Matrons should be relieved by a member one evening

a week. Recently it was felt that it would be desirable to arrange for similar relief on one Sunday per month, and, with the helpful co-operation of the members, this extra relief has now been instituted.

It is felt that the importance of this relief work by members cannot be over-emphasised, not only because it provides the Principal and Matron with some much-needed relaxation from the Hostel, but also because it gives members a valuable opportunity of getting to know the boys.

DETENTION HOUSE AT AUCKLAND PARK JUVENILE COURT.

For some time past the unsatisfactory nature of the Detention House at the Juvenile Court has been held to be a matter for concern, and arrangements are at present being made for members of the Committee to discuss the question with Dr. van Schalkwyk, with a view to establishing an adequate place of detention and safety.

Quite recently the Department of Social Welfare, in a circular letter, intimated that Hostels could be used as places of safety, and that the Department would pay maintenance in such cases on the usual per caput basis. The Committee is of the opinion that such a policy would have a disturbing influence on the Hostels, and feels that the Government should establish special accommodation and not use the existing institutions for this purpose. It is felt, that, while it would be desirable that the place of safety be managed by a private Committee, the Government would have to take full financial responsibility.

It is hoped that the meeting with Dr. van Schalkwyk will result in the necessary accommodation being established.

AFTER-CARE.

An interesting and important development which has recently taken place is the appointment of an After-Care Officer. Although considerable importance has always been attached to this aspect of the work, and the Committee has always felt that the lack of definite provision for after-care attention has constituted a weakness in its work, it has not hitherto been in a position to undertake the work in any systematic way.

During the year the question of evolving an effective system of after-care work has received much consideration, and this has resulted in the appointment of Mr. P. N. F. Roode as after-care officer. Mr. Roode assumed duties on 23rd May, 1938.

Provision for foster home placements is very necessary in any after-care scheme, and the Committee has been at some pains to discover private families who would take in one or two lads as boarders on payment, and exercise a beneficial influence on them. With the much appreciated assistance of the Armsorg Committee, we have now six such families whose co-operation we have been able to invoke in several cases.

An aspect of the work which has been given special attention recently is the assistance of old boys who have got into further trouble and been sentenced to a term of imprisonment. Several such lads have been assisted by providing board and lodging, clothing, pocket money, and most important of all, by helping with the difficult task of finding employment.

A special after-care sub-Committee has been appointed under the able Chairmanship of Mr. J. C. Merkin who studied this question very fully during a recent visit overseas, and each member of this Committee is pledged personally to assist the after-care Officer with special cases.

The Committee has estimated the cost of after-care work at between £700 and £1,000 per annum. On the suggestion of the Secretary for Social Welfare, we applied for the grant of a Government subsidy towards the salary of the after-care officer, and this application has been granted.

The appointment of an after-care officer is in the nature of an experiment, and as the scheme has been in operation for such a comparatively short time, it is impossible at this stage to judge of the degree of success attained. It is felt that after a year's working it will be possible to judge of the effectiveness of the scheme, the success of which would complete and round off the work of the Hostels.

NATIONAL COUNCIL OF CERTIFIED HOSTELS.

Recently the question of establishing a National Council of Certified Hostels was raised. Mr. Hardy discussed the matter with representatives of the Capetown and Durban Hostels at a meeting held in Durban in May, 1938, when a resolution in favour of the formation of a temporary Committee to inquire into all factors affecting the proposed establishment of a National Body was passed. A constitution has now been drafted and will be submitted to a meeting of representatives to be held in Durban in July, 1938.

The objects of such a Council would be generally to promote co-operation amongst persons interested in Certified Hostels and to collect, study and circulate information concerning such Hostels; to accept and manage funds for assisting existing Hostels and founding new Hostels; and to do all things considered necessary for the furtherance of the Hostel movement.

It is felt that such a co-ordinating body would be of considerable value, providing it received the support and wholehearted co-operation of the various Hostel Committees, each of which would retain complete local autonomy and would continue to control its property and manage its own affairs as hitherto.

FINANCIAL REPORT.

The Revenue and Expenditure Account shows a surplus of £67 10s. 2d. for the year, which has enabled us to reduce the loss incurred in operating expenses in former years to £1,092 10s. 0d.

Before taking into account the donations for the year, the working revenue shows a shortfall of £565 10s. 9d. at Howard Pim Hostel; £146 16s. 1d. at Norman House; and £238 5s. 5d. at Spackman House—a total of £950 12s. 3d.

The total cost per boy per day, including rent and administration, was 6s. 8d. at Howard Pim Hostel, 5s. 8d. at Norman House, and 5s. 6d. at Spackman House; and the cost of food was 1s. 5d., 1s. 3d. and 1s. 2d. at each of these respectively. The total boy units at Howard Pim Hostel were 6,229, at Norman House 6,812 and at Spackman House 6,125, the capacity at each Hostel being 7,300 units.

Expenditure:

The accounts on this side do not vary appreciably from last year, and call for little comment.

The expenditure at each Hostel shows a slight increase, especially at Howard Pim Hostel, at which the largest increase is in the clothing account which is £160 11s. 8d. as against £113 9s. 7d. last year.

The borehole at Spackman House continued to function satisfactorily throughout the year, and consequently no Municipal water has been used. The figure £15 16s. 1d. represents light only.

The Sundries Account at Spackman House is considerably higher than at the other Hostels, but this includes school fees and extras which do not occur at the other Hostels. Also there are no refunds of any transport expenses, as the lads are not working lads.

An additional item under expenditure this year is After-care, an amount of £132 8s. 4d. having been spent on this work since last May. It is estimated that approximately £1,000 will be required during the coming year. The Government subsidy which has been promised towards the salary of the After-care Officer will help towards meeting this expense, and the Witwatersrand Lads' Club has promised a grant-in-aid. If this work is to succeed, further income must be obtained.

Revenue:

On this side, too, the figures have not varied much. Including donations, the total working income for the year was £6,494 18s. 5d. of which the Government Grant forms approximately 56 per cent., and Lads' Contributions 14 per cent., and the Parents' Contributions 2 per cent.

The Government Grant shows slight increases at Howard Pim Hostel and Norman House, but a small decrease at Spackman House where the average number accommodated during the year has been lower than last year. The average amount of the Government Grant per boy per day was as follows: Howard Pim Hostel, 3s. 5d.; Norman House, 3s. 7d.; Spackman House, 4s. 6d. The basis of the grant has remained the same throughout the year, viz. 3s. 4d. per boy per day for Juvenile-adults and 4s. per boy per day for Juveniles at both Howard Pim Hostel and Norman House; and 4s. 6d. per boy per day at Spackman House.

The Lads' Contributions show a fairly substantial increase at Howard Pim Hostel, but a slight decrease at Norman House. These tend to fluctuate in accordance with the age and competence of the boys, and the state of the labour market.

The Parents' Contributions at Spackman House have decreased very considerably. These contributions fluctuate from year to year according to the parents' ability to contribute towards the maintenance of their sons.

The cash donations show a slight increase on last year, and we should like to place on record our sincere appreciation of the continued support of our subscribers, without whose help this work could not be continued.

The Municipal Grant-in-aid for the year amounted to £200, and we should like to record our thanks to the City Council of Johannesburg for its continued assistance.

The street collection held in Krugersdorp in November, realised £25 3s. 8d., an amount which exceeds the sums obtained at either of the two previous collections, and the Committee wishes to express its thanks to Mrs. P. Silbert, who organised the collection, and to those who helped her.

We desire to express our thanks to Mr. L. G. Butt for his services in auditing the books, and our sincere appreciation of his helpful advice throughout the year.
