TO TEAM MEMBERS AND FRIENDS

Many of us in church and community organisations are still feeling the effects of the State of Emergency. This circular letter is being sent out to remind TEAM members and friends of the detention of Rev Marawu, a TEAM executive member and organiser for Transport and General Workers' Union (TGWU). We recently spoke to Mrs Marawu and perhaps there is no better way to convey to you the kind of person Rev is, and how much he is missed, personally and by TEAM, than to share some of that discussion with you:

"I felt very unhappy when Rev was detained. Rev is an old man who doesn't deserve to be sitting in jail at the age of 64 and being a very sick person. Rev loves his work. He started working for the trade union in 1978. He even gave up his church circuit work (did not resign) so that he can be fully involved with community work. This shows what kind and charming person he is — willing to help others.

In the evening, in fact every hour of the day I think about him and pray because I know he did not commit any crime by attending and conducting funerals. Even his church work is suffering - he is a member of African Reformed Church in South Africa. I am here at home alone not working. I stopped working in 1985.

I am feeling very depressed and suffering from tension because of this situation. I really don't know what to do. If the organisations could help by demanding his release at least I would feel that one day he will come home. When he comes home I feel that we must take a holiday."

At the moment in TEAM we are trying in conjuction with TGWU to work out legal action. As you can see from the enclosed poster, we are also trying to keep Rev constantly in our thoughts and prayers. We ask you to think especially about Mrs Marawu and the rest of her family. We will keep you informed if anything new develops concerning Rev.
