- 5. The LESSEE shall during his tenancy keep in good order and condition and cultivate in a proper husband-like manner all fruit and other trees on the said farm.
- 6. The LESSEE shall have the right to kaep, run or graze on the said farm and on the adjoining Native Reserve all cattle, horses, mules, asses, sheep, goats and pigs that he may require for his own use.
- 7. The LESSEE shall during his tenancy abide by and keep the Barolong Customs in respect of his occupation of the said farm and in respect of the running of cattle, horses, etc, etc on the adjoining Native Reserve.
- 8. Lastly the Lessee generally shall manage and cultivate the said farm and lands in a husbandlike manner and the LESSEE so long as he shall keep the conditions herein contained shall have

free and undisturbed occupation of the said property during the said tenancy.
