Report of the Continuation Conference held at Communal Hall, Orlando on 6/11/55.

As the members will remember 10 people were elected as delegates at a meeting convened by the Provincial committee on 11/11/55, Messrs J. Mavuso, A. Nzo, X. Makwane, K. Piloo, J. B. Molewa, W. Mandita, J. Kadebe, Miss V. ^{W. Pilling} Mungoma and Mrs M. Jodinda. Before the conference was opened the provincial secretary together with other members of the province requested our delegation to stand down particularly during the discussion on the financial report. The reason forwarded was mainly to avoid some interference particularly from the reactionary Madzymba group who might contest that they are the ^{official} ~~delegated~~ delegation from ^{Alexandra} ~~conference~~ which might result in a lot of time wasted at conference. This request was accepted by our delegation as a gesture of co-operation with the Provincial authorities.

After a discussion on the financial report our delegation was allowed to take part in the subsequent business of conference which consisted mainly in the Resolutions, which were as follow: -
(1) Resolution condemning the passes

for women. After discussion conference agreed on an addendum moved by one delegates to the effect that the forthcoming national conference should consider the intensification of the pass resistance which would consist in the boycott of the passes by african males.

II Organizational: In the main conference resolved that political training should be given as follows:

(a) 3 months training for all branch members.

(b) 2 months training for other branch officials.

(c) 1 months training for other congress volunteers.

III Congress of the People: - conference resolved to intensify the million signature campaign of the Freedom Charter.

IV Bantu Education: - Conference resolved to intensify the struggle against Bantu Education which consists in the boycott of Bantu Education schools. Conference resolved also resolved to popularise the establishment of Cultural Clubs for african children.

V Trade Unions: - conference resolved to popularise the trade union movement through organising of the workers into the movement.

VI Political Education: - Conference resolved to encourage all members to read

progressive literature and newspapers. An addendum condemning the "Bantu World" was approved which consisted also in instructing all congresses particularly the leaders not to send any statements to the "Bantu World" or to have any interviews with the "Bantu World" people.

VII Western Areas Removal: Conference resolved to intensify the anti-removal campaign of the Western Areas. The Provincial Executives was further instructed to draw up some plans relative to the Anti-Removal Campaign.

VIII Ethnic Grouping: Conference passed a resolution condemning ethnic grouping.

IX Draft Constitution: Conference resolved to recommend to the forthcoming National Conference that all branches in all provinces should first of all study the draft conference to be adopted at as special Conference to be conference during the coming year.

X Defiance Campaign: This was referred to the forthcoming National Conference for consideration.

III (a) Evaton Bus Boycott: The provincial secretary gave a brief report of the boycott up-to-date and he further urged all branches to give whatever assistance possible to the boycott. Some casualties during the boycott were also reported.

(b) C.P. Signature Campaign: The
