1. Motivation for Proposal

The End Conscription Campaign (ECC) was restricted in August 1988. Since then the different elements of work which had been covered by ECC, have been taken up by a number of diverse organisations. This strategey has enabled antimilitarisation work to continue in spite of the restriction of ECC, but has had the negative effect of greatly diminishing our overall public impact.

Now, a year after the restriction of ECC, there is a general consensus amongst the organisations involved in anti-militarisation work, that there is an urgent need for a consultative conference. Such a conference would provide an overview of the area, and would facilitate a possible restructuring of our work in order to become more effective.

The primary purpose of such a conference would therefore be:
i. to conceptualise this area of work, particularly assessing changes that have occured during the last year, eg. troops returning to SA from Namibia and Angola; increased use of black troops and vigilante forces in township areas.

ii. to set up better co-ordinating structures between those organisations involved in this area and/or to develop new initiatives to more effectively take forward anti-militarisation work.

2. Consultation

The project has been preceded by a thorough process of consultation between the different organisations involved in this area of work, and between the different regions. On the basis of these consultations, a paper was drawn up for discussion by regional workshops. The paper sought to present the different options being considered by different organisations and regions. (See Annexure A)

Representatives from a broad range of organisations attended the regional workshops which were held in Johannesburg, Pretoria, Durban, Pietermaritzburg, East London, Grahamstown, Port Elizabeth, Stellenbosch and Cape Town. Each workshop will be sending representatives to the national workshop.

In order to facilitate communication between regions and organisations, the COSG national worker was mandated to travel to all the regions. She helped

motivate the national consultative conference and helped run the regional workshops. (This trip has been included in the budget).
