

#### CONSCIENTIOUS OBJECTOR SUPPORT GROUP

PRESS STATEMENT

WITHDRAWAL OF CHARGES AGAINST CONSCIENTIOUS OBJECTORS.

The withdrawal of charges of charges against two Conscientious Objectors in the Johannesburg Magistrates Court today highlights the State's inability to deal with the situation of Conscientious Objectors in the present state of political uncertainty.

The Reverend Alan Storey, probationer Methodist minister, refused on Christian pacifist grounds to obey his military call-up ion january this year. Mr Wally Rontsch (40) objected for moral reasons to his call-up into "Dad's Army", the Citizen Reserve Force which is being used to patrol the white suburbs to "protect hearth and home".

President F.W. de Klerk has promised to repeal all racist legislation before the end of this current Parliamentary session next week. But the conscription of only white males continues, even though this implies the use of the Population Registration Act, one of the Apartheid laws which is being repealed. In July the usual twice-yearly intake of new white conscripts will be taking place all around the country.

The Conscientious Objector Support Group is also concerned about those C.O's who were classified as Religious Objectors by the Board for Religious Objection and are currently performing up to three years so-called community service, mainly fairly unskilled jobs in government offices, at Army pay rates. Alan Storey, as a religious universal pacifist, could have himself applied for Religious Objector status, but refused to do so because he saw the Board as a discriminatory system: "I do not believe that religious persons have a monopoly on integrity and conscience... therefore I cannot accept the privilege given only to religious pacifists by the Board for Religious Objectors". It is therefore ironic that he is now apparently in a better position than the Religious Objectors.

Both Alan and Wally can of course be called-up again, and would have to go through the long legal process of Refusal to serve again. But it seems unlikely that the SADF will want to repeat the process.

While conscription remains, COSG would like to see a system of true alternative service being made available to all those who in all conscience cannot serve in the South African Defence Force.

CONSCIENTIOUS OBJECTION

- 1. Thank you for your letter of 29th May 1991 sent on to me by the South African Council of Churches. I am now working under the auspices of the Mestern Province Council of Churches, P O Box 441, Salt River 7925. My responsibilities include keeping a watching brief on issues of Conscientions Objection for the SA Council of Churches.
- 2. My original submission to the Geldenhuys Committee was made on 13th August 1985 on behalf of six churches related to the SACC. There is no time to consult these churches on what I say in this letter, but I am sending a copy of it to each of them so that they may repudiate anything which they are not able to support. I am asking them to do so direct to you, if they wish to comment.
- 3. I wish to draw attention to some sections of my original submission and to comment on them in the light of what we have learned since 1985. There is one new proposal I wish to put forward.
- 4. Paragraph 1 (c) noted that "the abolition or phasing out of conscription...
  is preferable to any other suggested amendments in this memorandum". I hope
  that a recommendation on this subject is within the terms of reference of
  your Committee. Conscientious objection exists only where there is
  conscription.
- 5. With regard to Sections 2 and 3 of my submission, I think we are long past the time for making amendments to the Defence Act to include moral and selective objection. That should have been done by the Naude Committee and, failing them, by the Geldenhuys Committee. We aught to be ashamed of the way we have treated these objectors in the meantime, and thankful that a few young men of great quality have had the courage to expose our shortsightedness by the suffering they accepted. Pending an end to conscription all conscripts should have a free option of community service outside the SADF or non-combatancy within it without having to prove anything before a Board. This is advocated in Section 1 of my original submission.
- 6. In respect of the length of community service and where it can be rendered a farcical situation has arisen. Due to Supreme and Appeal Court decisions and the amendment of the Triminal Procedure Act a refusal to render the full period of military service has received in effect a sentence of 800 hours of community service. The current effect of being classified by the Board for Religious Objection into Category 3 is roughly three years of community service. Admittedly the former sentence is unpaid, without monetary allowances and it carries the supposed stigma of a criminal offence, but it represents 100 days work which may be done without interfering with one's career compared with more than 1000 days required of the "religious objector" which cannot be done concurrently with his career. Section 4 of the submission relates to this matter.

- 7. Furthermore, the type of community service required of the Rev Douglas Torr and Mr Michael Graaf indicates the validity of our contentions in Section 5 paragraphs (b) and (c) that such service is possible beyond Government structures and also that it does not have to be done in one continuous period.
- 8. I am now out of touch with the Board for Religious Objection and have no comment to make on Section 6.
- 9. It will be next year before Parliament can amend the Defence Act, and by then a new Constitution may be in sight carrying with it an end to the residual effect of race classification that makes only white males subject to conscription. In the interim an administrative decision, such as that which recently halved the period of national service, needs to be taken by the Minister of Defence in terms of Section 72E (2) & (3) of the Defence Act to further shorten the period of community service making it equal (and not one and a half times) the length of military obligation. I think that representations made to the Department of Manpower by community servers have shown that the hardships and disadvantages of community service are comparable, though not similar, to those of military service. And this community service, if objectors are allowed into areas where their skills are used, is of at least as great value to the country as is defence.
- 10. Some objectors, in their trials or when appearing before the Board for Religious Objection, have referred to the option of civilian (or socially-based) defence when ask how a country could be defended if everyone took their attitude to military service. I hope that it is within the terms of reference of your Committee to recommend that the SADF should take up an examination of this concept. It is particularly relevant as a restructuring of the Defence Force approaches subsequent to the adoption of a new Constitution. I and others can supply information on the subject.

Visit to the UK and Europe, July 1991

#### 1. Arrivals and Departures.

I shall arrive in London on Saturday morning July 13th and will stay with a friend Doreen Tucker in Cricklewood. Her phone number is 81 450-5306. When do you want me to "report for duty?"

My airticket will be Johannesburg-Amsterdam-London-Amsterdam-Johannesburg. The travel agent says she needs to book the London-Amsterdam leg before issuing the ticket. If you wish me to use this for the start of my European travels can you give me a date for her? I was planning not to return to London after the WRI triennial in Belgium, but if you want a report-back I can come back to you either before or after the Triennial, and then use up this bit of the ticket on my final journey home. (Sorry if this sounds a bit confused)

- 2. Some of the questions I had for Maggie have been answered by Jacqui and by the records at the SACBC which I have been going through. However what I still need to know are the names, addresses and contact persons of the agencies I shall be visiting. We are trying to put together a funding pack to send them before I arrive. It would also be helpful to know when they were last seen by someone from here (I forgot to ask Jacqui this)
- 3. A word about myself. I heard a gasp from Marie on the phone when she asked my age, and I suppose I have the doubtful distinction of being the oldest person still active in the Anti-Militarisation movement. (Date of birth 3 January 1928, if that helps with getting any pensioner rebates). I joined COSG in about 1980, and was one of the founder members of Johannesburg ECC in 1983, retaining my COSG membership as well. Most of my work in ECC was done in the Churches group: I am a Baptist and my early interest in COs was the Baptist Objectors, Peter Moll, Richard Steele and Mike Vivieros.

I retired from my full-time job with the Jo'burg City Council in February 1990, and worked part-time for about a year for Five Freedoms Forum (with Alastair, which was a big bonus). I took over the ECC job on a part-time basis when Roddy left earlier this year, and in practice am doing a combined ECC-COSG-CAS job from the ECC office. Jo'burg COSG has been supporting CO's either on trial or awaiting trial non-stop since the David Bruce campaign of 1988. For the first time now, with the commutation of Doug Torr's jail sentence into part-time community service, and the withdrawal of charges against Alan Storey, we seem to have a bit of a breathing space. But with the call-up looming again in July, CAS is getting lots of anguished calls for help from unwilling conscripts, and ECC is planning actions against
